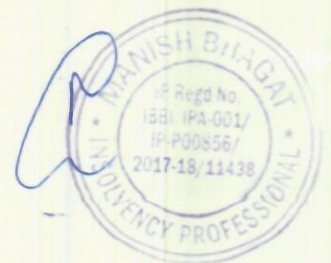

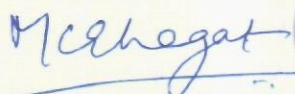

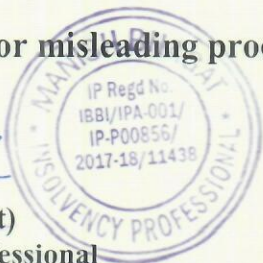
Submission of false or misleading proofs of claim shall attract penalties.
