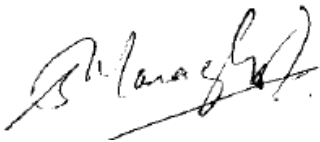
Notice is hereby given that Devilbiss Healthcare Private Limited has commenced voluntary liquidation on 21 February 2025.
