Notice is hereby given that the Hon'ble National Company Law Tribunal, Hyderabad Bench-II, has by its Order dated 21.08.2026 passed in IA (IBC) (Liq.) No. 08 of 2025 in CP (IB) No. 666/7/HDB/2018, a certified copy whereof was received by the Liquidator on 24.08.2026, ordered the commencement of liquidation of M/s. Splendid Metal Products Limited (now known as M/s. Thalaivar Steels Limited) under Section 33 of the Insolvency and Bankruptcy Code, 2016, and has appointed CS Dr. Ahalada Rao Vummenthala as the Liquidator of the Corporate Debtor. The liquidation commencement date is 21.08.2026.

The stakeholders of M/s. Splendid Metal Products Limited (now known as M/s. Thalaivar Steels Limited) are hereby called upon to submit their claims on or before 07.09.2026, being fourteen days from the date of Liquidation commencement (receipt of the copy of the Order).

The financial creditors shall submit their claims with proof by electronic means only. All other creditors may submit their claims with proof in person, by post or by electronic means.

A secured creditor is required to inform the Liquidator of its decision to relinquish its security interest to the liquidation estate, or to realise its security interest, on or before 07.09.2026, in such format as notified by the Board. Where a secured creditor does not intimate its decision within the said period, the assets covered under the security interest shall be deemed to be relinquished to the liquidation estate.

Submission of false or misleading proof of claims shall attract penalties.
