Guwahati, March 26 (IANS): In yet another attack on Rahul Gandhi, Assam Chief Minister Himanta Biswa Sarma said that the future of the Congress leader and his party is bleak.

He told the Press here on Tuesday, "People of this country who want India to be the world leader will definitely vote for Narendra Modi. The Prime Minister is working to make our nation a powerful country on the global stage."

According to Sarma, Rahul Gandhi lacks vision, will-force, and his prospects after the Lok Sabha polls are dark.

"Voting for Congress means supporting Rahul Gandhi who does not have a future whereas supporting BJP equates support to PM Modi," he said.

The Chief Minister also mentioned that the Con-



gress party is on the verge of collapse in the entire country.

He said, "In Assam, Congress leaders are like fixed deposits for us. Whenever it is required for Modiji, we will bring them into the BJP."

CM Sarma earlier also asserted that barring one or

two -- the rest of the party leaders from Congress would eventually join the BJP.

He said, "All will come in the BJP and that is why we have never closed our doors. Even Congress President in Assam, Bhupen Borah will also switch sides."

NPP to support NDPP LS candidate in Nagaland, NPF nominee in Manipur

Kohima, March 26 (IANS): The National People's Party (NPP), led by Meghalaya Chief Minister Conrad K. Sangma, on Monday, announced it would support the Lok Sabha candidate of the Nationalist Democratic Progressive Party (NDPP) in Nagaland and the Naga People's Front (NPF) nominee in Manipur.

NPP nation President Sangma, after meeting Nagaland Chief Minister and senior NDPP leader Neiphiu Rio, said that his party would support NDPP candidate Chumben Murry for the lone Nagaland seat.

Murry is the consensus candidate of the ruling People's Democratic Alliance (PDA), which leads

Nagaland's multi-party coalition government.

The NPP would also support NPF candidate Kachui Timothy Zimik in the Outer Manipur seat, Sangma told the media adding that his party would support the BJP nominees in two Lok Sabha seats in Arunachal Pradesh - Union Minister Kiren Rijiju (Arunachal West) and Tapir Gao (Arunachal East).

The NPF fielded Zimik, replacing its sitting MP Lorho S. Pfoze.

The NPP, NPF, and NDPP are the allies of the BJP-led National Democratic Alliance (NDA).

Sangma said that the NDA partners are supporting each other's candidates in different northeastern states.

The BJP earlier announced support to the candidates of the NPP in the two parliamentary seats in Meghalaya, the NPF nominee in the Outer Manipur Lok Sabha seat, and the NDPP contender in Nagaland's lone Lok Sabha seat. It is however yet to declare its candidate for the Inner Manipur seat.

The NPP, which dominates the Meghalaya Democratic Alliance government led by Sangma, has fielded state minister Ampareen Lyngdoh from the Shillong Lok Sabha constituency, besides renominating Agatha K. Sangma from Tura. Agatha, the sister of Conrad Sangma, was the youngest Union Minister during the second UPA government.

Ask Ardent on why he helped form RDA: Pangniang

Staff Reporter Shilllong, March 26: Hill State People's Democratic Party (HSPDP) president KP Pangniang today said that the Regional Democratic Alliance (RDA) was formed under the leadership of former UDP president (L) Dr Donkupar Roy and former HSPDP president, Ardent M Basaiawmoit, who is now leading the newly floated VPP in the state.

"You should ask Ardent on the objective of forming the RDA in 2017," Pangniang told reporters.

He said the RDA wanted to ensure unity among the regional parties and to get the support of the people of the state. "With that in mind, we have decided to further strengthen the RDA," he added.

Stating that the people of the state have also put their trust in the two regional parties, Pangniang said, "Both the parties have a vote share of over 3.35 lakh and we believe that this is an indica-

tion that people want us to work together."

"We also hope that the people will continue to support the RDA (in the LS polls) like it did in 2023," he added.

Earlier, UDP chief Metbah Lyngdoh said that the UDP and HSPDP under the RDA are confident to win from Shillong constituency.

"We will work very hard in the next couple of weeks for the polling day. We are together with the HSPDP and we are on the same platform where we are working for the interest of the people and we are also for the jaidbyrniew," he said.

He said that the two parties are sharing their responsibilities in campaigning for the RDA candidate.

Lyngdoh said nobody can dictate the RDA to stop contesting the MP election.

"Nobody can ask us to pull out. It is our decision. Whatever decision we take, it is for the interest of everybody," he said.

Rijiju, Tuki file nomination papers in Arunachal

Itanagar, March 26 (IANS): Union Minister and BJP nominee Kiren Rijiju on Tuesday filed his nomination for the Arunachal West parliamentary constituency, where elections would be held in the first phase of polling on April 19.

Accompanied by Chief Minister Pema Khandu and MLAs Kento Jini and Nyamar Karbak, Rijiju filed his papers at Aalo, the headquarters of West Siang district.

After submitting his candidatures, Rijiju said on the X: "I extend my heartfelt gratitude to Hon'ble CM Shri Pema Khandu ji for his presence and support during the filing of my nomination papers. With BJP under the strong leadership of Hon'ble

PM Shri Narendra Modi ji, Arunachal Pradesh is on the path to progress and success."

Meanwhile, former Arunachal Pradesh Chief Minister and Congress' state unit President, Nabam Tuki, also filed his nomination from the same Arunachal West seat.

Six-time MLA, 60-year-old Congress leader Tuki has been the sitting MLA from the Sagalee constituency in the Papumpare district since 1991.

Rijiju, BJP's one of the prominent leaders in the northeastern region, won the seat for the third time in the 2019 elections, including second consecutive time and secured 204,553 votes.
