

UP nabs MCA grad for toll plaza scam across 14 states over 2 years

Lucknow: UP STF arrested a 35-year-old MCA graduate in Varanasi on Wednesday for masterminding a country-wide toll tax fraud network spanning over 14 states in 18 months and siphoning off collections for over two years.

While police are trying to figure out the magnitude of the fraud, its extent can be gauged from the fact that at Mirzapur's Atraha toll plaza alone, the scam resulted in losses of Rs 45,000 to NHAI.

Alok Kumar Singh, an expert programmer and a former toll plaza employee, created an illegal software system that diverted toll collections to private bank accounts maintained by the scam members.

The software targeted vehicles without FASTag or with insufficient FASTag balance, which are typically charged double the toll.

It developed an unauthorised program that operated alongside the NHAI official software. The fake receipts mimicked NHAI receipts, making the scam difficult to detect.

STF has also arrested MCA graduate and toll plaza manager Misha for their alleged involvement in the fraud.

Singh confessed to loaning the earnings through his bank accounts and digital wallets. To mislead STF, he ensured that only tolls from non-FASTag vehicles were recorded in NHAI's official software. The rest was marked as exempt or unregistered.
