Notice is hereby given that Broadsoft Technologies Private Limited has commenced voluntary liquidation on 09th December, 2022.

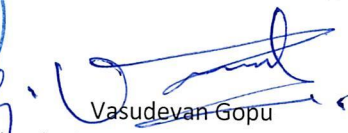
