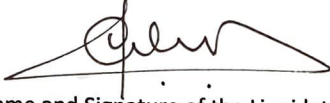
Notice is hereby given that the Asia Pacific Breweries (India) Private Limited has commenced voluntary liquidation on July 27, 2020
