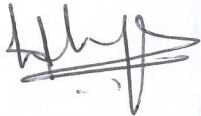

इंडिगोच्या इगोने प्रवासी वेढीला

भारताचा आर्थिक विकास वेगाने होतो आहे. तिसरी आर्थिक महासत्ता होण्याची घाई सरकारला झालेली आहे. हे सर्व उद्दिष्ट गाठण्याकरता सर्व स्तरावर विकासाच्या वेगवेगळ्या योजना राबवल्या जातात. आपण जगाच्या बरोबर राहिले पाहिजे आणि जागतिक स्तरावर आपली तितकीच दखल घेतली गेली पाहिजे अशा उद्देशाने सरकार वेगवेगळ्या स्तरावर प्रगतीचे टप्पे गाठतो आहे. म्हणूनच गेल्या काही वर्षात देशभरात अगदी हवाई वाहतूक क्षेत्रामध्ये मोठे परिवर्तन घडवून आणले जाते आहे. आज संपूर्ण देशामध्ये जवळपास छोटी-मोठी २०० विमानतळ बांधली जात आहेत. म्हणजे देशांतर्गत विमान वाहतुकीला मोठी चालना मिळेल आणि एकेकाळी श्रीमंतांचीच मत्सेदारी असलेला हवाई प्रवास सर्व स्तरातील सामान्य माणसाला सुद्धा तितकाच सहजतेने आणि स्वतःमध्ये उपलब्ध होईल अशा प्रकारच्या योजनाही आखल्या जात आहेत. एकीकडे हे प्रयत्न चालू असतानाच नवी मुंबईतले अगदी जागतिक दर्जाचे आंतराष्ट्रीय विमानतळ बांधले गेले त्याच्या पाठोपाठ आता वाढवणालाही त्यापेक्षाही अधिक आधुनिक विमानतळ तयार होईल. देशाच्या अन्य शहरांमध्ये अगदी दिल्ली, बंगलोर, अहमदाबाद, लखनऊ या ठिकाणची विमानतळही अत्याधुनिक स्वरूपाची केली जात आहेत. गेल्या काही वर्षांमध्ये भारतातील हवाई वाहतूक जवळपास १०० पटीने वाढलेली आहे. म्हणजे विमानाने प्रवास करणाऱ्यांच्या प्रवासी संख्येमध्ये चक्र १०० पट वाढ झाल्याचे पाहायला मिळते आहे. वेगवेगळ्या कारणांमुळे ही वाढ नोंदली गेली ज्यामध्ये हवाई प्रवास काही प्रमाणात सुसह्य झाला. शिवाय वेळ वाचवण्यासाठी आणि उद्योग व्यवसायांचा विस्तार झाल्याने लोकांचा हवाई प्रवास वाढलेला आहे. कॉर्पोरेट क्षेत्रामध्ये हवाई प्रवासाला पर्याय राहत नाही. तिथे काम करणाऱ्या अधिकाऱ्यांना, कर्मचाऱ्यांना त्यांच्या हवाई प्रवासाच्या सर्व सोयी उपलब्ध करून दिल्या जातात. अशा वेगवेगळ्या कारणांमुळे हवाई प्रवास करणाऱ्यांची संख्या मोठ्या प्रमाणात वाढली आहे. ज्या प्रमाणात ही प्रभावी संख्या वाढली त्या प्रमाणामध्ये भारतातील हवाई उद्योगासाठी किंवा हवाई प्रवासासाठी आवश्यक असलेल्या पायाभूत सुविधा भक्कम झालेल्या नाहीत हे अलीकडच्या काही ताज्या घटनांवरून स्पष्ट होते. गेल्या दोन-तीन दिवसांपासून भारतातल्या इंडिगो विमान कंपनीने प्रवाशांचे जे काही हाल केले आहेत त्यावरून हे स्पष्ट होते की, भारताच्या हवाई उद्योगावर सरकारचे अपेक्षेप्रमाणे नियंत्रण नाही.

हवाई क्षेत्रातील बेशिस्त

हजारो प्रवाशांना वेढीला धरण्याचा प्रकार गेल्या काही दिवसात घडला आणि अनेकांचे आर्थिक नुकसान होण्यापासून, आरोग्याच्या बाबतीतही बराच मोठा त्रास अनेक प्रवाशांना सोसावा लागलेला आहे. इंडिगोने जवळपास आपली १००० ते १५०० उड्डाणे दोन दिवसांमध्ये रद्द केली. ज्यांना व्यवसाय उद्योग आणि अन्य कारणांसाठी प्रवास करायचा असतो ते किमान महिनाभर किंवा पंधरा दिवस अथवा एक आठवडा आधीच विमानांचे अॅडव्हान्स बुकिंग करून ठेवतात. जेणेकरून त्यांचा प्रवास अधिक सुसह्य आणि वेळापत्रकाप्रमाणे व्हावा हा उद्देश असतो. परंतु इंडिगो कंपनीने केलेला

हलगर्जीपणा आणि एकूणच उड्डाण रद्द करण्याचा केलेला तमाशा हा लोकांसाठी अत्यंत जीवधेणा स्वरूपाचा ठरला. याचे कारण सांगताना त्यांच्याकडे कर्मचाऱ्यांची कमतरता असल्याने ही परिस्थिती उद्भवली. परंतु सरकारने १ नोव्हेंबरपासून विमान चालकांसाठी एक नवीन नियमावली तयार केली होती. ज्यामध्ये त्यांच्या कामाच्या वेळा मर्यादित करून त्यांना पुरेशी विश्रांती देणे आणि ज्याला नाईट लॅंडिंग म्हणतात त्याच्या संदर्भातही काही निकष आखून दिले होते हे निकष आखून दिल्याने कर्मचाऱ्यांची किंवा विमान चालकांची संख्या वाढवणे सुद्धा तितकेच गरजेचे होते. या संदर्भातील सगळी कल्पना सगळ्या विमान कंपन्यांना दिली गेली होती आणि त्यानुसार त्यांनी आपल्या कर्मचाऱ्यांच्या संख्येत वाढ करावी, असे सुद्धा सांगितले गेले होते. परंतु महिनाभराचा अवधी देऊनही इंडिगो विमान कंपनीने याबाबतीत फारसा उत्साह दाखवला नाही. परिणामी अचानकपणे जेव्हा कर्मचाऱ्यांची कमतरता भासू लागली त्यावेळेला धडाधड विमान रद्द करण्याचा सपाटा लावला. ज्यातून लोकांचे आर्थिक नुकसान झाले. ऐनवेळेला विमान उपलब्ध होत नसल्याने भाडे वाढत गेले. कारण विमान कंपन्यांना तशी मुभा दिली गेलेली आहे की, ज्या वेळेला प्रवाशांची मागणी जास्त असेल त्यावेळेला ते आपल्या पद्धतीने भाडे वाढवू शकतात आणि या सगळ्या परिस्थितीचा प्रचंड गैरफायदा इतर विमान कंपन्यांनी घेतला आणि अगदी मुंबई-दिल्ली विमान भाडे दहा ते पंधरा हजार असते ते तब्बल ३५-४० हजारांपर्यंत जाऊन धडकले. इंडिगो विमान कंपनीच्या या अत्यंत बेफिकीर प्रकाराने विमान उद्योगावरच एक मोठा परिणाम झालेला दिसून येतो. हवाई प्रवाशांना वेढाला धरण्याचा प्रकार त्यातून उघड झालेला आहे. इंडिगोने आपला हा इगो जपल्यानेच ही परिस्थिती उद्भवली आणि त्यातून प्रवाशांना आर्थिक आणि मानसिक त्रासही खूप सहन करावा लागला आहे.

उत्तम दर्जाच्या सुविधा नाहीत

एकीकडे भारताला जागतिक स्तरावर स्वतः ला विकसित म्हणून मिरवून घ्यायचे आहे, पण त्या तुलनेमध्ये जागतिक स्तरावर ज्या उत्तम दर्जाच्या हवाई किंवा विमान प्रवासाची आवश्यकता असते तो दर्जा अजून भारताने गाठलेला दिसत नाही. हा गोंधळ एकूणच भारताच्या हवाई उद्योगावर परिणाम करणारा ठरतो. लोकांमध्ये इंडिगो कंपनीविषयी असलेली लोकप्रियता आता संपुष्टात आल्यात जमा आहे. देशातील जवळपास ६० टक्के विमान ही इंडिगोची असतात आणि त्याला लोकांनी प्रतिसाद दिलेला होता. परंतु आता ज्या पद्धतीने प्रवाशांना गृहीत धरले गेले त्यावरून आता या कंपनीची विश्वासार्हता संपुष्टात आलेली आहे. मात्र देशभरातल्या या अभूतपूर्व गोंधळाने देशाच्या हवाई क्षेत्राला खूप मोठी शिस्त आणण्याची आवश्यकता आहे. सरकारने आता महिनाभरासाठी काही नियमात बदल केले ते तात्पुरत्या स्वरूपाचे जरी असले तरी एखाद्या कंपनीने घातलेल्या गोंधळापुढे सरकारला शरणागती पत्करावी लागलेली दिसते. या पद्धतीने हवाई क्षेत्र कंपन्यांच्या हवाली करून आणि प्रवाशांना भेटीला धरून चालवता येणार नाही हे या नव्या प्रकारातून स्पष्ट होते.

अमेरिका, कॅनडा आणि मेक्सिकोमध्ये पुढील वर्षी ११ जून ते १९ जुलैदरम्यान होणाऱ्या फिफा विश्वचषकाची गटवारी घोषणा वॉशिंग्टनमध्ये करण्यात आली. ४८ संघांना १२गटांमध्ये (ए ते एल) विभागण्यात आले असून प्रत्येक गटात चार संघ आहेत. यावेळी विश्वचषकाचा उद्घाटनाचा सामना ११ जून २०२६ रोजी मेक्सिको सिटीमध्ये खेळवला जाईल. यात यजमान देश मेक्सिको आणि दक्षिण आफ्रिका आमनेसामने असतील. अमेरिका, मेक्सिको आणि कॅनडा हे तीन देश विश्वचषकाचे यजमानपद भूषवत असल्याची ही पहिलीच वेळ असेल. या सोहळ्यात अमेरिकेचे राष्ट्राध्यक्ष डोनाल्ड ट्रम्प यांना ‘फिफा प्रीस प्राइज’देण्यात आले. फिफाने नोव्हेंबरमध्ये हा नवीन वार्षिक पुरस्कार घोषित केला होता.

न्यूझीलंडविरुद्ध वेस्ट इंडिजला कसोटी अनिर्णित राखण्यात यश
