

CORRIGENDUM TO FORM G ISSUED ON 25th JANUARY 2026
INVITATION FOR EXPRESSION OF INTEREST FOR
KARANJA TERMINAL & LOGISTICS PRIVATE LIMITED
OPERATING IN PORT AND LOGISTICS SERVICES AT KARANJA PORT,
URAN (PORT FACILITY) AND AT BELAPUR CBD
(REGISTERED OFFICE)

This corrigendum is issued to the Form "G" issued and published on 25th January 2026 in respect of KARANJA TERMINAL & LOGISTICS PRIVATE LIMITED (the **"Corporate Debtor"**).

The aforesaid Form "G" under Point No. 17 mentions 'Corporate Debtor is not an MSME'. However, subsequent to the publication of the Form G, one of the (suspended) directors of the Corporate Debtor has informed the Interim Resolution Professional that the Corporate Debtor has infact registered itself as an MSME. This information was not notified to the Interim Resolution Professional prior to January 31, 2026, by the directors or any other person and the Form G was based on information then available of the Corporate Debtor with the Interim Resolution Professional. The Interim Resolution Professional continues to act in good faith in the CIRP of the Corporate Debtor and shall review the MSME registration of the Corporate Debtor in detail, at this moment, the Committee of Creditors of the Corporate Debtor has determined that based on the currently available registration as a MSME, at this moment a corrigendum to the previously issued Form G should be issued. Accordingly, against Point No 17 of the Form G, the words should be as follows:

'The Corporate Debtor, as on date, has a Udyam Registration Number - UDYAM-MH-18-0435867'.

The Committee of Creditors has also determined that on account of the aforesaid change in Form G, in accordance with Regulation 36A of the Insolvency and Bankruptcy Board of India (Insolvency Process for Corporate Persons) Regulations, 2016, the various dates appearing in Form G in Points 10 - 15 thereof shall stand replaced as follows:
