

In Charkhi Dadri, fancy vehicle number goes for record ₹1.17 cr

Haryana's Badhra subdivision in Charkhi Dadri district fetched the highest bid of Rs 1.17 crore in the country for the fancy vehicle registration number of HR88B8888 today.

According to sources, Sudhir Kumar, son of Om Prakash and a resident of His-

ar, won the bid. The bid stood at Rs 1.03 crore at 4.20 pm. Afterwards, the bid rose and ended at Rs 1.17 crore.

The online bid which had 45 participants was finalised at 5 pm today. The auction is done by the Ministry of Road Transport and Highways on its web portal fancy.parivahan.gov.in.

The base price for the bid

was fixed at Rs 50,000, Rs 10,000 is the security money and Rs 1,000 is the registration fee for the numbers. VIP or fancy numbers are auctioned every week and each bid is closed on Wednesday at 5 pm.

HR stands for Haryana while 88 is the Regional Transport Office (RTO) number representing Badhra subdivision.

In two separate incidents, two minor boys died after basketball poles reportedly collapsed on them in Lakkan Majra village (Rohtak) and Bahadurgarh town (Jhajjar).

The deceased, identified as Hardik (16) of Lakkan Majra, Rohtak, and Aman (15) of Bahadurgarh, were Class X students. Hardik, a national-level player, participated in several sub-junior and junior national championships.

The first incident occurred on Sunday in Bahadurgarh when Aman was practising at Brigadier Hoshier Singh Stadium. A basketball pole suddenly fell on him. He was rushed to the civil hospital and later referred to PGIMS Rohtak, where he succumbed to his injuries on Monday night.

The second incident took place on Tuesday at Yuva Sports Club in Lakkan Majra. Hardik sustained severe injuries when a basketball pole broke and collapsed on him when he reportedly attempted to touch the basket. Other young players rushed to help after noticing him trapped under the pole. He was taken to the hospital, but died of his injuries. The incident was also captured by the CCTV camera installed near the basketball court.

"Over 35 boys come daily to Yuva Sports Club to practice basketball. The basketball poles had been in a dilapidated condition for a long time, but no one paid attention despite repeated complaints," said one of the village boys.
