Chairing a high-level meeting to review prevention and awareness measures against drugs, Stalin said all police superintendents and collectors should say with pride that their regions are completely ganja-free. Such a time should blossom and only then people would feel that their children are safe. Everyone should work towards making entire Tamil Nadu fully drug-free. In ganja and Gutkha

cases, charge sheets should be immediately filed. If warranted, separate teams should be set up for this purpose. In each and every district, such cases in courts should be expeditiously conducted and completed to ensure conviction for offenders.

Vigil should be intensified in areas in and around schools and colleges to prevent prescription drug abuse. 'the use of classes of medicine as drugs,' the Chief Minister advised.
