

Meghalaya to reopen schools for Classes 1-5 from Feb 14, end mandatory Covid testing for double-dosed entrants

SHILLONG, FEB 10 --/ Meghalaya chief minister Conrad Sangma has said schools will reopen for Classes 1-5 from February 14, and no mandatory testing will be required on entry into the state for double-vaccinated people. Sangma, who chaired a high-level meeting to review the COVID-19 situation late on Wednesday, also said the night curfew from 10 pm to 5 am will be withdrawn from Friday. "No RT-PCR test will be needed for double-vaccinated individuals coming to the state starting Friday. The

schools (Classes 1 to 5) will be fully functional from Monday," he said.Teaching via the offline mode for Classes 6-12 and in colleges and universities had already begun last week. Sangma also said entry into bars, restaurants and movie theatres will only be allowed for fully-vaccinated people, and that the odd-even system of plying of vehicles will continue in Shillong.The northeastern state had reported 125 fresh COVID-19 cases on Wednesday, which pushed the tally to 92,646, while the death toll mounted to 1,554 with two more fatalities. Assam tells HC rules followed in police encounters; petitioner asked to file response

GUWAHATI, FEB 10 --/ The Gauhati High Court on Thursday directed a petitioner, who filed a PIL against police encounters in Assam, to submit a response to the state government affidavit that said due process of law and all guidelines of the National Human Rights Commission (NHRC) were followed in such incidents. A division bench comprising Chief Justice Sudhanshu Dhulia and Justice Soumitra Saikia asked the petitioner to file the response within 10 days and said the matter will be heard again on February 21. The court had on January 11 asked the state government to file a detailed affidavit on the police encounters that have been taking place since the BJP returned to power in May last year. The government had on February 7 submitted the affidavit. "The opposition

party sought time to file an affidavit in reply to our affidavit. The Court accordingly granted them time and fixed February 21 as the next date (of hearing)," Assam Advocate General Devajit Lon Saikia told news agency PTI. In the affidavit, the government said that due process of law and all guidelines issued by the NHRC were followed in all cases of police encounters. It also informed the court that 28 people were killed and 73 others were injured in police actions from May 10, 2021, when chief minister Himanta Biswa Sarma assumed charge, to January 28 this year. According to the affidavit, the incidents of police firing took place in 27 districts and the highest number of 10 people were killed in Karbi Anglong district. Guwahati city recorded the maximum number of injuries at nine. Besides the

Assam government, state police DGP, law and justice department, National Human Rights Commission and Assam Human Rights Commission have been named as respondents in the PIL filed by advocate Arif Md Yeasin Jwadder. The petitioner sought an enquiry into the encounters by an independent agency such as CBI, SIT or any police team from other states under the supervision of the court. He has also sought a judicial enquiry by a sitting Judge of the Gauhati High Court in the incidents and monetary compensation to the victims' families after due verification. The people killed or injured were not dreaded criminals and the modus operandi of the police had been the same in all the encounters, the PIL claimed. (PTI)

Heroin worth over Rs 50 lakh seized, 2 persons arrested

AIZAWL, FEB 10 --/ Mizoram Police arrested two persons and seized heroin worth over Rs 50 lakh from their possession in Champhai town near the Myanmar border, a senior police officer said on Thursday. Champhai Superintendent of Police (SP) Lalrinpuia Varte told

PTI that the two accused were travelling in a maxi cab from Zokhawthar village on the Indo-Myanmar border when police, acting on specific information, intercepted them on the outskirts of Champhai town on Wednesday. The SP said that 1.28 kg of heroin worth over

Rs 50 lakh in the local market was seized from the possession of the two accused, who belonged to Karimganj in Assam. They were booked under relevant sections of the Narcotic Drugs and Psychotropic Substances Act 1985, Varte said. (PTI)
