

Ukraine focus as 8 leaders from Europe to visit India from today

DAYS AFTER British Prime Minister Boris Johnson's visit to India at least eight leaders and ministers from Europe are scheduled to be in the country over the next couple of days, including Ursula von der Leyen, the President of the European Commission.

Von der Leyen, who was Germany's defence minister under Chancellor Angela Merkel until 2019, will meet Prime Minister Narendra Modi on Monday, where the crisis arising out of the Russia-Ukraine conflict is expected to come up for discussion.

The foreign ministers of Poland, Lithuania, Slovenia, Portugal, the Netherlands, Norway, and Luxembourg are also expected to be in India.

While they are all coming for the Raisina Dialogue, the flagship conference on geo-politics and geo-economics organised by the Ministry of External Affairs and the Observer Research Foundation on

April 25-27, the war in Ukraine is likely to dominate their conversations with Indian interlocutors. Prime Minister Johnson too discussed the war with the Indian leadership. The foreign ministers of Argentina, Armenia, Guyana, Nigeria, Madagascar, and Philippines too are expected to attend the conference.

Also likely to be present are the former PM of Sweden Carl Bildt, the former PM of Canada Stephen Harper, the former President of the Maldives Mohamed Nasheed, and the former PM of Australia Anthony Abbott. The conference comes a week before Prime Minister Modi leaves for Germany and Denmark on his first overseas visit this year. He may also go to France, depending on the outcome of Sunday's French presidential election.

In Berlin, the Prime Minister will meet with Chancellor Olaf Scholz on May 2, before heading to Copenhagen where he will meet the Prime Ministers of Denmark, Finland, Iceland, Sweden and Norway for the India-Nordic summit. There too,

the Ukraine-Russia crisis is expected to top the agenda.

Earlier this month, President Von der Leyen became the first European leader to visit Bucha, the suburb of Kyiv where evidence of possible war crimes was found after the Russian soldiers retreated. She told Ukraine that the EU would continue to support the country and would make Russia's President Vladimir Putin pay a "heavy price" for his war.

Before Von der Leyen's April 8 visit to Ukraine, the Prime Ministers of Poland, Slovenia, and the Czech Republic had traveled to Kyiv by train in mid-March.

Ukrainian officials say more than 300 people were killed by Russian forces in Bucha, and around 50 were executed. Moscow denies the accusations. India has condemned the civilian killings in Bucha, but has not named Russia, and has called for an independent probe. New Delhi has been engaged by European countries over the last two months — British Foreign Secretary Liz Truss visited last month, apart from the German National Security Adviser and other European officials — on its

position on the war, which is seen to be neutral. Russian Foreign Minister Sergey Lavrov and Chinese Foreign minister Wang Yi too visited India in March.

External Affairs Minister S Jaishankar met with his counterparts from the Philippines, Argentina, and Nigeria on Sunday. After the meeting, Jaishankar tweeted: "Appreciated his insights and perspectives on Indo-Pacific, Europe, Myanmar, Ukraine and Multilateralism. Reviewed the progress in bilateral ties since our last meeting in February."

On the meeting with Argentina's Santiago Cafiero, Jaishankar tweeted, "A productive meeting with FM @SantiagoCafiero of Argentina on his first visit to India. Discussed expanding our bilateral trade and cooperating in agriculture, pharmaceuticals, electronics, e-mobility, defence & atomic energy. Will work closely in G20 and multilateral forums."

On his meeting with Nigeria's Geoffrey Onyeama, Jaishankar tweeted: "Agreed to expand our development partnership focusing on health, infrastructure, education, agriculture and capacity building..."

PM Modi receives first Lata Deenanath Mangeshkar award

ON SUNDAY evening, Prime Minister Narendra Modi received the first Lata Deenanath Mangeshkar Award at an event in Mumbai. "What can be a greater privilege than to have received the love of a sister from Lata Didi, who has given the gift of love and emotion to generations," he said in his acceptance speech.

Renowned singer Lata Mangeshkar passed away in February at the age of 92. The award is instituted in her memory and will be given annually on April 24.

Master Deenanath Mangeshkar Smruti Pratishthan, Pune, a registered public charitable trust established by the Mangeshkar Family, felicitated achievements in arts, culture, medicine and social work, among which Modi was the recipient of the "special individual award".

"He is indeed one of the greatest leaders our great nation has seen in its glorious history of thousands of years," read a statement from the trust.

The award ceremony was in honour of the 80th Memorial Day of the late Marathi theatre actor and classical singer, Deenanath Mangeshkar. Among his children are Lata Mangeshkar and Asha Bhosle. "When it comes to receiving honours, I stay away from them. I can't adjust to them but when the award comes in Lata Didi's

Other recipients included actors Jackie Shroff and Asha Parekh, who were awarded the Master Deenanath Puraskar for cinema, classical singer Rahul Deshpande for Indian music, and Mumbai's dabbawallas for social service.

Keep bows and arrows at home to deal with 'jihadis', says Sakshi Maharaj

CONTROVERSIAL BHARATIYA Janata Party MP Sakshi Maharaj on Sunday asked Hindus to keep bows and arrows at their home, saying police will not come to their rescue when a crowd arrives to carry out "jihad". He also posted a picture of a crowd wearing skull caps and holding sticks on his Facebook page with the comment.

"If this crowd suddenly comes to your street or house, then do you have any way to save yourself? If not then make some arrangements. Police will not come to your rescue, they will hide somewhere to save themselves," he said in his Facebook post.

"Police will come only when these people return after carrying out jihad. The matter will go to an inquiry committee and it will end there after some time. For such guests, keep a couple of boxes of cold drink and some original bows and arrows in every house. Jai Shri Ram," he added.

When asked about the post, Sakshi Maharaj said he completely agrees with its content.

The BJP MP did not give any direct reply as to why the post was needed but said, "Are Hindus only to take a beating."

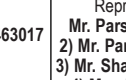

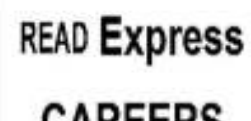

Court to take call on Mevani bail plea today

GUJARAT MLA Jignesh Mevani, arrested in connection with an allegedly defamatory tweet against Prime Minister Narendra Modi, was produced at the Chief Judicial Magistrate court in Assam's Kokrajhar district on Sunday. The court, however, reserved the judgment on his bail petition for Monday, and sent Mevani to judicial custody for a day.

"Considering the nature of the matter the court needs sufficient time to go through the materials on record to decide the bail petition. The bail petition will be decided tomorrow," said the court. An Independent MLA who had in September last pledged

support to the Congress, Mevani was arrested in Gujarat by the Assam Police on Thursday and flown to Assam where a court remanded him in three-day police custody. The arrest followed an Assam BJP leader's complaint over an allegedly defamatory tweet by Mevani against Modi.

During Sunday's hearing, the Assam Police had sought 10 days' custody, a senior police official said.

Angshuman Bora, Mevani's counsel, said there was no "prima facie evidence for the charges" against the MLA. "...there is no prima facie evidence for the charges against him. All these sections he has been booked for... these are not applicable to the facts of this case," Bora told *The Indian Express*.
