Hyd court acquits Akbaruddin Owaisi in 'hate speech' cases

Hyderabad: A court here on Wednesday acquitted AIMIM MLA Akbaruddin Owaisi in the "hate speech" cases filed against him in 2013, citing insufficient evidence.

Judge K. Jaya Kumar of the special sessions court for trial of MPs/MLAs, who pronounced the verdict, observed that there was no sufficient evidence to prove the cases against the accused and gave him benefit of doubt.

Akbaruddin Owaisi, the younger brother of All India Majlis-e-Ittehadul-Muslimeen (AIMIM) chief and Hyderabad MP Asaduddin Owaisi and floor leader of AIMIM in the Telangana Legislative Assembly, was present in the court when the judgement on his acquittal was delivered.

Akbaruddin allegedly used inflammatory and derogatory language against a community during his public speeches delivered at Telangana's Nizamabad on December 8, 2012 and at Nirmal town on December 22, 2012.

Subsequently, cases were registered against Akbaruddin on January 2, 2013 under Indian Penal Code Sections 153A (promoting enmity among people on grounds of religion), 295A (deliberate and malicious acts, intended to outrage religious

feelings of any class by insulting its religion or religious beliefs), and other sections for making "hate" speeches. He was arrested and later released on bail.

Delivering the judgment, the court on Wednesday found him not guilty for the charges under relevant IPC sections and accordingly, acquitted him of the charges.

However, the judge orally told Akbaruddin not to repeat this type of provocative speech in future and also not to hold celebrations in such a way that may cause inconvenience to the general public.

The court noted that the video with alleged provocative speech which was produced by the police was not in sequence and lacked continuity (there was no chain-link in between the contents in the video of the alleged provocative speech) besides the speech footage submitted before the court was not in full and said it cannot be taken into consideration.

The Crime Investigation Department (CID) investigated the Nizamabad case and filed the chargesheet in 2016 while the district police which probed the Nirmal case also submitted the chargesheet in the same year.

A total of 41 witnesses were examined in the Nizamabad case while 33 people were examined in the Nirmal case. However, most of the independent witnesses turned hostile.

Defence counsel M. A. Azeem told reporters that as per observation of the court in both the cases, the prosecution was not able to prove the evidence against the accused and was given benefit of doubt.

Reacting to the judgment, the BJP in Telangana alleged that the TRS government colluded with the AIMIM, and did not "intentionally" submit proofs to the court in the cases against Akbaruddin Owaisi leading to his acquittal.

The acquittal is surprising as the whole world has seen Ak-

baruddin Owaisi's "hate speech" against a community, state BJP president and MP Bandi Sanjay Kumar claimed in a statement.

"We don't find fault with the verdict given by the court in this matter. We are not attributing any bad intentions to the court. What the court requires is proof and evidence. But, the state government did not intentionally submit proof. What more proof is required to show that the TRS government colluded with the AIMIM," Kumar said.

The BJP leader demanded that the state government should go for an appeal if it is sincere.

He also alleged that the then Congress government in 2009 had also diluted a case against Akbaruddin.

Meanwhile, AIMIM president Asaduddin Owaisi hailed the acquittal of his younger brother.

"Alhamdulillah Akbaruddin Owaisi has been acquitted by MP/MLA Special Court in two criminal cases against him for alleged hate speeches. Grateful to all for their prayers & support. Special thanks to Advocate Abdul Azeem sb & senior lawyers who provided their valuable assistance," Asaduddin Owaisi tweeted. ❁

'No riots in UP during Ram Navami': Yogi

Lucknow: Chief minister Yogi Adityanath has said there is no place for riots in Uttar Pradesh, stressing that the Ram Navami celebrations coinciding with Ramzan went off without any incident of violence – not even an altercation or "tu-tu, main-main". His remark at an event Tuesday came against the backdrop of recent cases of communal violence in Rajasthan, Madhya Pradesh, West Bengal and Gujarat.

Adityanath said the situation during Ram Navami reflected the "new thinking of development" in UP.

He said Ram Navami-related processions were taken out at 800 places in the state that has a population of 25 crore.

It is also the month of Ramzan and "roza-iftar" programmes are also being held, he added. "Nowhere has there been any 'tu-tu, main-main' (altercation), leave alone rioting."

"There is no place for danga-phasad (rioting)," he said, adding that the state al-

so has no room for anarchy, goadism and rumour-mongering.

"Uttar Pradesh has proved this on the occasion of Ram Navami, the pious 'jyanti' of 'Maryada Purshottam Shri Ram'," he said.

No communal riot was reported during Ram Navami in the state. However, the opposition Samajwadi Party has targeted the BJP government over "inaction" after a hate speech against Muslims by a seer, Bajrang Muni Das.

The provocative re-

marks were allegedly made in Sitapur on the first day of Ram Navami. The seer has been booked, but no arrest made so far.

In the run-up to the assembly polls that brought Adityanath to power for a second consecutive term recently, law and order was projected as one of the main agenda of the Bharatiya Janata Party. ❁

4 more cases against Digvijaya over Khargone violence tweet

Bhopal: Police have registered four more FIRs against Congress MP Digvijaya Singh for allegedly promoting religious enmity after he tweeted a picture of a mosque in another state while commenting on communal violence at Khargone in Madhya Pradesh, an official said on Wednesday.

Earlier, a First Information Report (FIR) was registered against Singh in Bhopal on Tuesday evening after a complaint by local resident Prakash Mande. The four other FIRs were registered on Tuesday night in Gwalior, Jabalpur, Narmadapuram

and Satna, the official said. Meanwhile, Singh wrote a letter to Bhopal police commissioner, seeking that an FIR be registered against Chief Minister Shivraj Singh Chouhan for allegedly posting a fabricated video about Congress MP Rahul Gandhi on May 16, 2019.

In a tweet on Wednesday morning, Singh said, "Instead of answering my question they have filed FIR against me. Is that Democracy BJP Model or Modi Model? What about the Hate speeches made by BJP and RW fraud Babas?" ❁

Cong modern-day Muslim League, says Tejasvi Surya

BJP MP Stopped From Visiting Karauli In Raj

Jaipur: Comparing Rajasthan CM Ashok Gehlot to Aurangzeb, BJP MP Tejasvi Surya accused the Congress the "modern-day Muslim League" of committing atrocities on Hindus after he was stopped from visiting violence-hit Karauli town.

Surya, BJP's Rajasthan chief Satish Poonia and Bharatiya Janata Yuva Morcha (BJYM) workers were stopped near Mahua on the Jaipur-Agra highway, with the authorities citing law and order concerns.

Surya and other leaders started a dharna on the spot. They were asked to get into a bus and taken away from the spot but they kept demanding that they be allowed to meet victims of the April 2 violence, which broke out after a bike rally being carried out to mark Hindu new year was pelted with stones.

Over 30 people were injured in the violence.

Surya, who is also the chief of the BJYM, the BJP's youth wing, later at a press



conference said they oppose the "appeasement policy" of the ruling Congress in Rajasthan.

He said, "This is Rajasthan and not Afghanistan. The state government should stop giving second grade treatment to Hindus. I condemn the anti-Hindu and anti-India policy of the state."

Today's Congress is the "modern-day Muslim League", he said.

"The way Indian Muslim League was dividing Hindus and committing atrocities against them, today Sonia Gandhi and Rahul Gandhi and Ashok Gehlot are continuing the same tradition," Surya alleged.

According to Surya, Hindus had brought idols from Mathura's Madan Mohan temple to Karauli 300 years ago when Mughal ruler Aurangzeb launched an attack.

They had hoped that they would get protection in Ka-

rauli, he said. "Today, Aurangzeb's place has been taken by people like Gehlot," he said.

Our forefathers' hope that they would get protection in Karauli is being "shattered" by Gehlot, said Surya who called the CM Aurangzeb.

Surya alleged the law and order has completely collapsed in Rajasthan and there is a jungle raj prevailing in the state.

"The atrocities against the Hindus in the state are increasing. Here, victims are prosecuted and the guilty are set free," he alleged.

Earlier in the day, BJYM workers took out a "Nyay Rally" to meet victims of the violence in Karauli. They were stopped near Mahua on the Jaipur-Agra highway while on their way to Karauli.

As the protesters kept demanding that they be allowed to meet the victims and raised anti-government slogans, police were told to get into a bus and taken away from the spot. ❁
