Bengal post-poll violence: Calcutta HC cancels anticipatory bail of 13 accused

THE CALCUTTA High Court on Monday cancelled the anticipatory bail of 13 accused in connection with the killing of one Haran Adhikari, a BJP worker, during the post-poll violence in West Bengal last year, officials said.

The CBI took over the case in September last year on the High Court's orders.

"It was alleged that at 8pm on May 2, 2021, the said accused

and others had beaten deceased Adhikari and other persons with bricks, sticks, 'shovels' and da (chopper) in front of house of one of accused in connection with bursting fire crackers," a CBI spokesperson said.

Adhikari succumbed to injuries during treatment.

The CBI had filed a supplementary charge sheet in the court of the Baruipur additional chief judicial magistrate against 17 accused, including Kurban, Yunus, Humayun, Rakhibul Molla, Usman Molla, Maiuddin

Molla, Momrej Molla, Akhtar Molla, Reshma Molla, Supriya Bibi, Sirajul, Safikul Kazi and Dud Ali Molla who were given anticipatory bail by the district and sessions judge, South 24 Parganas, Alipore.

In its order, the High Court said, "Clearly on the ground of materials available in the case di-

ary as on the date of the order granting anticipatory bail, it can be said that there were at least two statements recorded under Section 164 of the Criminal Procedure Code of two injured

eye witnesses who had implicated all the opposite parties." "Statement of injured eye witnesses recorded under Section 164 of the Criminal Procedure Code has to be given due emphasis while considering an application for grant of anticipatory bail," it said.

"In such circumstances, we find that the order granting anticipatory bail to the private opposite parties suffers from perversity." The Bench of Justices Debangsu Basak and Bibhas Ranjan De said,

CBI arrests 7 accused in Cooch Behar murder case

THE CBI has arrested seven people in connection with the murder of a man in May last year when incidents of violence broke out after the West Bengal Assembly elections, officials said on Monday.

The accused, identified as Pranab Barkait, Pritam Roy Sarkar, Ratan Roy Sarkar, Liton Shil, Liton Bhaumik, Nakul Roy Sarkar and Biswajit Barman, were arrested from Cooch Behar, Kolkata among other places after sustained surveillance, they said.

On the basis of inputs confirming the presence of the accused, the CBI carried out co-ordinated searches at eight locations where they were nabbed, the officials said.

The CBI had taken over the case on August 19, 2021 on Calcutta High Court orders.

It was alleged that around 2 pm on May 4, 2021, Sridhar Das was beaten with sticks, 'bat-tam' and iron rods by unidentified people, the agency said in a statement.

When the victim's wife tried to rescue him, the accused attacked her as well, it was alleged.

"After the incident, Sridhar Das was admitted to Dinhat Hospital, and later, in other hospitals in Cooch Behar where he died during treatment a month later," the agency said.

Large-scale violence had erupted in the state after results of the bitterly fought assembly elections in the state were announced on May 2, 2021.

Opp obstructing govt work as they couldn't implement any when in power: Modi

PRIME MINISTER Narendra Modi on Monday targeted the Opposition, especially the Congress, for opposing the decisions taken by his government, saying that some Opposition parties were putting obstacles in the work of his government because when they were in power, they could not implement their decisions.

Addressing the 10th death anniversary of late Samajwadi Party (SP) leader Harmohan Singh Yadav virtually, the PM said that the interests of the country and society are always bigger than ideologies. "In recent times, there has been a trend to put ideological or political interests above the interest of the society and the country. Many times, Opposition parties put obstacles in the work of the government because when they were in power, they could not implement the decisions taken by themselves," Modi said, adding that people do not like such behaviour.

"It is the responsibility of every political party that oppos-

ing a party or an individual should not turn into opposition to the country. Ideologies and political ambition have their place, and they should have. But, country, society and nation come first," the PM said as he cited the 1971 war, the nuclear test and the fight against Emergency.

Recalling the words of former prime minister Atal Bihari Vajpayee, Modi said: "Vyakti se bada dal, dal de bada desh kyuki dalon ka astitva loktantra ki vajah se hai aur loktantra ka astitva desh ki vajah se hai (Parties exist because of democracy and democracy exists because of the country). Most of the parties in

our country, especially all the non-Congress parties have also followed this idea and the ideal of cooperation and coordination for the country," PM said as he targeted the Congress.

Addressing the gathering, the Prime Minister paid tributes to Harmohan Singh Yadav, a towering figure and leader of the Yadav community. Yadav, who was a Shaurya Chakra awardee, later joined politics and served as a Member of Parliament, Legislative Council as well as Assembly.

Modi also invoked Dr Ram Manohar Lohia's concept of cultural strength and said that in the original Indian thought, society was not an issue of contention or debate and was seen as a framework of cohesion and collectivity. He said that Dr Lohia worked to strengthen the cultural strength of the country by organising Ramayana fairs and caring for the Ganga river.

With Droupadi Murmu taking oath as the President on Monday, the PM said for the first time after Independence, a woman from the tribal community has assumed the highest office of the country and called it a "big day for India's democracy".

CLAIM OVER SHIV SENA SYMBOL

Uddhav faction moves SC, seeks stay on proceedings before EC

THE UDDHAV Thackeray faction in the Shiv Sena has approached the Supreme Court, challenging the Election Commission proceedings over the claims for the party's election symbol 'bow and arrow' by the Chief Minister Eknath Shinde group.

The application was filed in an already pending petition filed by the party general secretary Subhash Desai, challenging the June 30 invitation by the Maharashtra Governor to Shinde to form the government.

Desai pointed out that when the petition was taken up by the

SC on July 11, the bench had orally directed the Speaker of the Maharashtra Legislative Assembly not to proceed further on the disqualification petitions pending before him and to keep the same in abeyance. Thereafter on July 20, the counsel appearing for Speaker had assured the court that no further proceedings will be conducted in the matter of disqualification under the Tenth Schedule. The matter was fixed for final hearing in the first week of August.

However, in the meantime, the Election Commission of India "purportedly initiated proceedings" under Para 15 of the Election Symbols (Reservation and Allotment) Order, 1968.

Fresh rumblings in NDA as Nitish skips central events

DAYS AFTER it appeared that Prime Minister Narendra Modi's recent Bihar visit has patched up the strained ties between the two ruling NDA coalition partners in the state, Chief Minister and Janata Dal (United) supreme Nitish Kumar may have got miffed with his senior ally, the Bharatiya Janata Party (BJP), afresh.

Nitish seems to have registered his displeasure with the BJP by skipping three major back-to-back central meetings or events, including the swearing-in of the new President of India, Droupadi Murmu on Monday. First, the Bihar CM kept himself away from the July 17 CMs' meeting on matters concerning the national flag, which was convened by Union home minister Amit Shah. On July 22, Nitish also chose not to attend the farewell dinner event hosted by Prime Minister Modi for the outgoing President Ram Nath Kovind.

Sources said Nitish has been "upset" with Bihar Assembly Speaker Vijay Sinha's "inept handling" of the concluding function of the Assembly's centenary celebrations, which was attended by PM Modi on July 12. While the PM and Nitish praised each other on the occasion, the latter was reportedly not pleased with Sinha, who is from the BJP, for not mentioning his name in the invitation card for the event. The Bihar BJP seems to be intrigued as it believes that PM Modi and Union minister Dharmendra Pradhan have already assuaged the CM's bruised sentiments by sending out signals that he will continue to lead the NDA in the state.

New Delhi: Former Congress MP Naveen Jindal has hailed the Central government for changing the country's flag code to allow Tricolour's hoisting day and night, saying it is a "very progressive decision" that will definitely encourage more people to display the flag with dignity and pride. Jindal, who is the president of Flag Foundation of India, had given a representation to the government in this regard in 2009. Earlier, the Tricolour was allowed to be flown from sunrise to sunset. Jindal said the move will boost the government's 'Har Ghar Tiranga' campaign as part of the 'Azadi Ka Amrit Mahotsav'.
