

Wheat Prices Hit a Record in Delhi

Pune: Wholesale wheat prices are at a record ₹29/kg in New Delhi, hovering near the psychologically sensitive level of ₹30, said traders and processors.

In most parts of the country, wheat prices are already ruling 30-40% above the minimum support price (MSP) of ₹20.15/kg.

"The current wheat prices are the highest ever recorded. During the past four months, prices have gradually increased from ₹23/kg to ₹29/kg," said Rajesh Jain Paharia, a Delhi-based exporter of wheat.

After having initially encouraged exports at the beginning of 2021-22 wheat season, India had to ban the outbound shipments as a severe heat wave reduced the country's production of the staple.

The government decided to not sell wheat from its granaries, which could be filled less than 50% of the previous year's stock, in the open market.

"Prices are likely to touch ₹3,000/quintal in a week due to low availability. There will be no correction in prices until the government intervenes in the market," said Navneet Chitlangia, senior vice president, the Roller Flour Millers' Federation of India.

The wheat market is heating up across the country. According to processors, prices have touched ₹29.50/kg in West Bengal. "The markets in the eastern parts are fast approaching previous highs and I fear that prices are on the way to new highs," said Rohit Khaitan, a wheat processor from Raniganj in West Bengal. "Prices of aata and other wheat products have been moving in tandem."

Govt Working on ₹3,500-cr Toy PLI, may Allow Imported Parts

New Delhi: The government is working on a ₹3,500-crore production-linked incentive (PLI) scheme to promote domestic manufacturing of toys.

With many toy components not being manufactured in India, such as certain electronic parts and fabric used in soft toys, the government may incentivise toys made with imported parts, officials aware of the developments said.

"Many raw materials and components used in toys are not made in India, at present. So, imported components would be needed," one of them said.

An announcement on the scheme is likely in the upcoming budget for 2023-24, officials said.

The Department for Promotion of Industry and Internal Trade (DPIT) is also developing similar schemes for bicycles and footwear, they said.

BIS certification and quality testing, and raised the basic customs duty to 60% from 20% to curb import of cheap toys, especially from China.

"Since the toy sector has many small players, the incentive and turnover slabs could be as low as ₹5-7 crore," an industry representative said.

The government has issued around 1,000 licences for toys of which majority are with the small and medium players.

Imports of dolls, wheeled toys, puzzles, videogame consoles, and novelty jokes and tricks shrank 70.35% in three years to \$110 million in FY22 from \$371 million in 2018-19.

All-party Meet on G20 Plan Today

New Delhi: The Centre will convene an all-party meeting on Monday to solicit suggestions, discuss and finalise strategies for the G-20 summit which India will host in September next year.

Presidents of nearly 40 parties have been invited to the meeting by Parliamentary Affairs Minister Pralhad Joshi where Prime Minister Narendra Modi will be present. External Affairs Minister S Jaishankar is also likely to attend the meeting at the Rashtrapati Bhavan.

India officially assumed the G20 Presidency on December 1. New Delhi is expected to host over 200 preparatory meetings across the country, including at Hyderabad, beginning this month.

ESIC can Invest 15% of Surplus into ETFs

Social security body has surplus of ₹65k cr, which increases by ₹8-9k cr every year

New Delhi: The government Sunday gave its go-ahead to the Employees State Insurance Corporation to invest up to 15% of its surplus funds into equity through exchange traded funds.

A decision in this regard was taken at the 189th meeting of Employees' State Insurance Corporation under the labour minister Bhupinder Yadav, who is the chairman of ESIC.

ESIC has a surplus of nearly ₹65,000 crore, which increases by over ₹8,000-9,000 crore every year, and could be higher than this in coming years as ESIC plans to substantially expand coverage by bringing even the gig workers in its fold.

"Due to the relatively low returns on debt instruments coupled with the need to diversify, the ESIC Corporation accorded its approval for investments of surplus funds in equity, restricted to ex-

changed traded funds," the labour ministry said in a statement, after a two-day meeting that ended Sunday.

Initially ESIC will invest 5% of its surplus and gradually raise it up to 15% after review of two quarters. The investment will be confined to Nifty50 and Sensex ETFs and will be managed by fund managers of AMCs.

The equity investment will be monitored by existing custodian, external concurrent auditor and consultant looking after the debt investments in addition to the management of the ETF for equity.

The labour ministry had in 2015 allowed the Employees Provident Fund Organisation to invest up to 15% of its surplus in equity for better returns as the retirement fund body pays annual interest to its 55 million subscribers on its investments.

ESIC is one of the two main statutory social security bodies under the labour ministry, the other being the EPFO. All employees earning ₹21,000 or less per month as wages are covered under the ESIC Act. As per the Act, the employer contributes 3.25% while the employee contributes 0.75%, which is used to provide medical and cash benefits to its subscribers and their family.

FMCG Cos Keeping Close Watch on Softening Commodity Prices

New Delhi: Leading FMCG companies say they are keeping a close watch on prices of major commodities, which have fallen in case of some items like palm oil, but the decline has not been "secular and

broad-based". While prices of palm oil have eased and sugar is stable, FMCG firms pointed out that rates of some other major items including wheat are still firm and hence they would wait and watch before taking any call on reducing the price. Softening of commodities prices

will help the FMCG firms in improving their profit margins and also some elbow room to pass on the benefits to consumers by lowering the MRP (maximum retail price) of their products. Nestlé India Chairman and Ma-

naging Director Suresh Narayanan said the company is watching the situation. However, he said softening in commodity prices is not secular and broad-based.

"We will watch the situation and evaluate our next step. The price decline in commodities is not secular and broad-based," Narayanan

told PTI on the sidelines of an event here.

When asked about launches of new products this fiscal, he said: "There will be some new initiatives."

Besides palm oil, in recent months there has been also a drop in the prices of edible oil.
