ही तर रस्ते अपघातांची भयंकर महामारी

गेल्याच आठवड्यात शिर्डीला जाणाऱ्या बसला अपघात होऊन दहा जण मृत्यूमुखी पडले. आणि गेल्या चार दिवसात राज्य परिवहन मंडळाच्या दोन बसेसना आग लागण्याचा प्रकार घडला. दोन खासगी बसेसला अपघात झाले आणि आता मुंबई-गोवा महामार्गावर झालेल्या भीषण अपघातामध्ये एकाच कुटुंबातील दहा जण जागीच ठार झाले. अशा पध्दतीने खराब रस्ते आणि तांत्रिक चुकांमुळे होणारी मनुष्यहानी अत्यंत वेदनादायक ठरते. जगातील सर्वाधिक लोकसंख्या भारतामध्ये आहे याचा अर्थ इथल्या माणसांना रोज किड्यामुंग्यांप्रमाणे मरण यावे असा होत नाही. दर दोन दिवसाआड पाच पन्नास लोक हे या वाहनांच्या अपघातात चिरडले जातात. रस्ते डांबरी असो किंवा सिमेंटचे असोत परंतु ते परिपूर्ण नसतातच. यामुळेच ते रोजच्या अपघातांमुळे आणि चेंदामेंदा झालेल्या माणसांच्या रक्तांनी माखले जात आहेत. धक्कादायक गोष्ट अशी आहे की, जागतिक विक्रम नोंदण्याचे काम भारतातल्या रस्ते अपघातांनी केले आहे. दरवर्षी दीड लाख लोक केवळ रस्ते अपघातात मृत्यूमुखी पडतात म्हणजे कोरोनाच्या दोन वर्षात तीन चार लाख लोक मृत्यूमुखी पडले असतील. परंतु गेल्या दहा वर्षांपासून दरवर्षी दीड लाख लोकांचा बळी जातो आहे. ही तर कोरोनापेक्षाही महाभयंकर महामारी ठरते. दहा वर्षात पंधरा लाख लोकांचे जीव या रस्ते अपघातांनी घेतले आहेत. सरकार या भयंकर महासंकटाकडे अक्षरशः षंड प्रवृत्तीने पाहते आहे. अपघात या नावाखाली मनुष्यशक्तीची ही हानी दडपून नेली जात आहे. कधी वाहन चालक तर कधी वाहनामधील दोष आणि क्वचित प्रसंगी रस्त्यांची दुर्दशा सांगून या अपघात नावाच्या महासंकटाचे समर्थन करण्याचा तितकाच निर्लज्ज प्रयत्न होत असतो. वाहन चालवताना सावधानता असावी याबद्दल कोणाचे दुमत होणार नाही. परंतु ही सावधानता टिकवून ठेवण्याकरिता सरकारने आपले अवधान ठेवण्याची वेळ आलेली आहे. ते नसल्यामुळेच सातत्याने अपघात होत असल्याचा स्पष्ट निष्कर्ष दिसून येतो. यापुढे या अपघातांसाठी कोणतेही कारण सांगून वेळ मारून नेता येणार नाही. याची जबाबदारी सरकारवरच टाकण्याची वेळ आली आहे.

सर्वाधिक मनुष्यहानी करणारा देश

कोरोनाची महामारी जागतिक स्वरूपाची असल्याने मोठ्या प्रमाणावर खबरदारी घेतली गेली. लोकांना वाचवण्यासाठी युध्दपातळीवर उपाययोजना केल्या गेल्या. परंतु जीव वाचवण्याचाच मुद्दा जर लक्षात घेतला तर वर्षाकाठी दीड लाख लोक मरत असतील तर कोरोनातल्या महामारीपेक्षाही अधिक व्यापक स्वरूपाची उपाययोजना अत्यंत शीघ्रगतीने आवश्यक ठरते. भलेही कोरोना नावाच्या व्हायरसने जगभरात बळी घेतले असतील. परंतु भारताचा विचार केला तर कोरोनापेक्षाही अधिक घातक असा हा रस्ते अपघातांचा व्हायरस पसरतो आहे आणि तो रोखण्यात सरकार म्हणून केंद्र आणि कोणत्याही राज्य सरकारला यश आलेले नाही. देशाच्या विविध भागांत वेगवेगळ्या वेळी वेगवेगळ्या ठिकाणी आणि वेगवेगळ्या परिस्थितीत

हे अपघात होत असल्याने त्याची गंभीरता लक्षात घेतली जात नाही. पण देशभरातला एकत्रित आकडा काढला तर रोज जवळपास चारशे ते सव्वाचारशे बळी अपघातांमध्ये जात असतात आणि आता जगातील सर्वाधिक रस्ते अपघातांचा विक्रम भारताच्या नावाने नोंदला जातो आहे. अलिकडे जिनेव्हा येथील इंटरनॅशनल रोड फेडरेशनच्या अहवालाचा आधार घेऊन केंद्रीय रस्ते वाहतूक मंत्रालयाने आपली आकडेवारी सादर केली आहे. जगातील २०७ देशांमध्ये सर्वाधिक अपघाती मृत्यू भारतात होत असल्याचे त्यातून स्पष्ट झाले आहे. तथापी अपघातांचा उच्चांक अमेरिकेच्या नावाने नोंदला जातो. तिथे दरवर्षी १९ लाखांपर्यंत अपघात होतात. परंतु केवळ ३६ हजार लोक मृत्यूमुखी पडतात. भारतात मात्र चार लाख बत्तीस हजार अपघात होतात आणि त्यात दरवर्षी एक लाख एकावन्न हजार चारशे सतरा लोक मृत्यूमुखी पडतात. जपानसारख्या पुढारलेल्या देशात जवळपास भारताइतकेच म्हणजे ४ लाख ३० हजार रस्ते अपघात होतात, पण मृत्यूमुखी पडणाऱ्यांची संख्या केवळ ४ हजार १६६ असते. भारतासारखीच मोठी लोकसंख्या असलेल्या चीनमध्ये दरवर्षी २ लाख ४४ हजार रस्ते अपघात होतात आणि त्यात ६३ हजार लोकांना बळी पडावे लागते. मृत्यूमुखी पडणाऱ्यांच्या क्रमवारीत चीन दुसऱ्या क्रमांकावर आहे. म्हणजे लोकसंख्या जवळपास सारखी असूनही भारतातील अपघातांची संख्या आणि मृत्यूमुखी पडणाऱ्यांचे चीनमधील प्रमाण पन्नास टक्क्यांच्याही खाली जाते.

वेळेवर कधीच मदत मिळत नाही

या आकडेवारीचा अभ्यास केला तर भारतातल्या या भीषण मनुष्यहानीची कारणे खूप गंभीर स्वरूपाची ठरतात. त्यातला पहिला मुद्दा असा की, अपघात होऊ नयेत यासाठी प्रचंड काळजी घेतली जाते. ठिकठिकाणी वाहतूक पोलीसची गस्त चालू असते. आणि दुसरा महत्त्वाचा मुद्दा असा की, अपघात झाल्यानंतर पुढच्या पंधरा मिनिटांत सर्व प्रकारची वैद्यकीय आणि तांत्रिक मदत उपलब्ध होते. अपघाताची गंभीरता लक्षात घेऊन हेलिकॉप्टर किंवा विमानाच्या मदतीने उपचार उपलब्ध करून दिले जातात आणि लोकांचे प्राण वाचवण्याला सर्वाधिक महत्त्व दिले जाते. आपल्याकडे या दोन्ही स्तरावर अत्यंत बेजबाबदारपणा पाहायला मिळतो. रस्ते खराब आहेतच. परंतु वाहनांचा वेग रोखण्याकरिता ठिकठिकाणी गस्त घालणारी पोलीस पथकं नसतात आणि अपघातांनंतर तासन्तास कोणत्याही प्रकारची मदत उपलब्ध होत नाही. याचा अर्थ स्पष्टपणे असा होतो की, अपघात रोखण्यासाठी सरकारी पातळीवर या प्रकारची खबरदारी आवश्यक आहे. ती घेतली जात नाही. उलट बेजबाबदारपणा दाखवून अपघातातल्या जखमींना मदतीची याचना करीत असतानादेखील विव्छळत ठेवले जाते आणि वेळेत मदत न मिळाल्याने त्यातच सर्वाधिक लोकांचे मृत्यू होतात. म्हणूनच या कोरोनापेक्षाही महाभयंकर असलेल्या महामारीचे गांभीर्य सरकार ओळखणार आहे की नाही.

Shelar said that at the BJP's recent National Executive meeting, everyone expressed confidence that the party would win the elections coming up in nine states—Tripura, Meghalaya, Nagaland, Karnataka, Mizoram, Telangana, Madhya Pradesh, Rajasthan and Chhattisgarh—on the back of the central government's welfare schemes for the poor. PM Narendra Modi's visit kickstarted Mumbai's development in real sense, says CM Eknath Shinde



MUMBAI : A day after Prime Minister Narendra Modi launched infrastructure projects worth Rs 38,800 crore in Mumbai, Maharashtra Chief Minister Eknath Shinde Friday said it was only after the prime minister's visit that the city's development "kickstarted in real sense."

"I have thanked him (Modi) for coming to Mumbai. The development of Mumbai started yesterday in a real sense at the hands of Narendra Modi," Shinde said at a press conference.

On Thursday, Modi launched a slew of infrastructure projects at the MMRDA grounds in the Bandra Kurla Complex in Mumbai, ahead of the Brihanmumbai Municipal Corporation (BMC) elections which are already due. "Several new projects related to Mumbai Metro, STP, concrete roads and clinics that were launched on Thursday by the prime minister have made the life of Mumbai's residents easier," Shinde added.

A number of workers from rural parts of Maharashtra formally joined

Shinde's Balasahebchhi Shiv Sena during the press meet.

Shinde recalled PM Modi saying that he has affection for the people of Mumbai. "He (Modi) said yesterday that money will not be a problem for the development of Mumbai and Maharashtra," said Shinde.

The chief minister also said that Maharashtra has signed Memorandums of Understanding (MoU) worth Rs 1.55 lakh crore at World Economic Forum (WEF) in Davos, Switzerland. "All these projects will be reality soon. Priority will be given to locals in the jobs created under these projects. Unlike the past, we will ensure that MoUs turn out as a reality," he said.

Opposition says Shinde govt went to Davos to sign deals with Maharashtra firms

Maha Vikas Aghadi leaders accuse the government of passing off Indian companies as foreign ones to claim the state has attracted huge investments at the World Economic Forum.



MUMBAI : Leaders from the Opposition Congress and Shiv Sena have alleged that some companies that the Maharashtra government claimed to have signed Rs 1.40 lakh-crore deals with at the World Economic Forum in Davos are from the state.

The Opposition Maha Vikas Aghadi on Friday asked why deals that could have been signed in Maharashtra were signed in Switzerland. Ahead of the Davos summit, the government had announced that it would sign memorandums of understanding (MoU) worth Rs 1.4 lakh crore with a record 20 companies. Atul Londhe, chief spokesperson of the state Congress, said the government's bluff had been exposed and that three of the companies were based in the Aurangabad, Jalna and Chandrapur districts of Maharashtra. "MoUs were signed with three companies from Maharashtra and this fabrication of the Shinde government has been

exposed... The number of such companies may be higher," Londhe said, adding that these companies had been passed off as foreign ones to claim that huge investments had been brought to the state from abroad.

A Shiv Sena leader also criticised the Eknath Shinde-Devendra Fadnavis government. "What was the need to sign the MoUs by going to Switzerland? It could have been done in Mantralaya as well," he said.
