# Pliable poll panel surest gateway to acquisition & retention of power. SC

New Delhi: Infusing more independence in the appointment and functioning of the Election Commission, the Supreme Court on Thursday held that political parties of varying hues have been reluctant in framing a law for fixing criteria and procedure for appointment of election commissioners as it may hamper their pursuit of power and it resulted in a legislative vacuum.

Referring to Article 324(2) which says appointment of chief election commissioner and election commissioners would be subject to the provisions of any law made by Parliament, a five-judge constitution bench said parties and

various governments over the years failed to introduce a law as contemplated by the founding fathers and the court should not shy away from filling the vacuum till a law is framed.

The bench of Justices KM Joseph, Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and CJ Ravikumar said the law was not made despite various "noises and voices" made on the issue.

"The founding fathers clearly contemplated a law by Parliament and did not intend the executive exclusively calling the shots in the matter of appointments to the Election Commission. Seven decades have passed by. Political dispensations of varying hues, which have held the reins of power have not unilaterally introduced a law...



The bench said the law was not made despite various 'noises and voices' made on the issue.

The absence of such a law does create a void or vacuum, the bench said.

It said that the reason for political parties not being forthcoming with the law is very obvious as there is a crucial link between the independence of Election Commission and the pursuit

of power, its consolidation and perpetuation.

"As long as the party that is voted into power is concerned, there is not unilaterally a near-instantaneous quest to continue in the saddle. A pliable Election Commission, an unfair and biased overseer of the foundational exercise of

adult franchise, which lies at the heart of democracy, who obliges the powers that be, perhaps offers the surest gateway to acquisition and retention of power," it said.

"Criminalisation of politics, a huge surge in the influence of money power, the rule of certain sections of the media where they appear to have forgotten their invaluable role and have turned unashamedly partisan, call for the unavoidable and unquestionable filling up of the vacuum. Even as it is said justice must not only be done but seen to be done, the impact of demands for impartial mode of appointment of the members require, at the least, the banishing of the impression, that the Election Commission is appointed by less than fair means," it said.

# 'Electorate's faith in election process shaken'

New Delhi: In its verdict running into 378 pages, the constitution bench of Justices K.M. Joseph, Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and C.T. Ravikumar said the appointment of CEC and ECs should be done in a manner that does not frustrate their six-year tenure. A short tenure also hampers the panel's independence, it said.

The court said any perception that "yes man" appointed by the Centre in the poll panel will decide the fate of democracy has to be removed and the commission should be made "freely independent, honest, competent and fair".

"We declare that as far as appointments to the posts of CEC and ECs are concerned, the same shall be done by the President of India on the basis of the advice tendered by a committee consisting of the PM, leader of the opposition in the Lok Sabha, and the CJI. This norm will continue to hold good till a law is made by Parliament," said the bench.

Referring to a very wide spectrum of powers exercised by the commission for holding election and recognising political parties, the bench said if the poll panel acts unfairly or illegally then it has a "telling and chilling effect on the fortunes of the political parties". Therefore, any action or omission by the commission in holding the poll which treats political parties with an uneven hand, and what is more, in an unfair or arbitrary manner would be tantamount to the mandate of Article 14, and therefore, cause its breach," said Justice Joseph, who penned the main judgment.

The bench said "the CEC and the ECs at whose table 'the buck must stop'".

"The faith of the electorate in the very process, which underlies democracy itself, stands shaken. The impact of 'big money' and its power to influence elections, the influence of certain sections of media, makes it also absolutely imperative that the appointment of the EC, which has been declared by this court to be the guardian of the citizenry and its fundamental rights, becomes a matter which cannot be postponed further," it said.

# Ex-CECs: It will boost perception as neutral body

New Delhi: While many chief election commissioners (CECs), at the time of denoting office, may have written to the President of India suggesting a collegium-system for appointment of CEC and election commissioners, the formal proposals of the Election Commission on the electoral reform — as available on the ECI website — do not make a mention of it.

However, the poll panel had over the years pushed for three key electoral reform proposals in the interest of independence and neutrality of the Commission — constitutional protection for election commissioners on par with CEC, internal procedure of removal (as directed by the Supreme Court on Thursday), charging the expenditure of EC on the Consolidated Fund of India, and an independent secretariat for the commission, which currently draws its officers and staff on deputation from departments and ministries of the Government of India.

All former CECs who TOI spoke to on Thursday — N. Gopalaswami, Syed Nasir Zaidi, S.Y. Quraishi and T.S. Krishnamurthy — agreed that the broad-based selection of the CEC and election commissioners would improve the perception of EC as a neutral body. "Having the Leader of Opposition part of the selection process will extend the voters' authority of CEC and the election commissioners. India is the only country where the EC members are unilaterally appointed by the government. In some countries, a parliamentary select committee appoints or even the entire parliament sits in judgement. In other countries, there is heavy debate on national TV among the contenders," former EC Quraishi pointed out, while welcoming the SC verdict.

Gopalaswami said that the broad-based selection would make EC "less of a punching bag". Zaidi called it an "outstanding ruling in that it brings in a law to fill the gap that has been there since 1950."

# Protect tenure of ECs like that of the CEC, says SC

New Delhi: The Supreme Court on Thursday said it for the Parliament to take a call on providing the same protection to election commissioners as given to the chief election commissioner who can only be removed in the same manner as a SC judge that is impeachment but said that parity among the poll panel members was desirable.

A five-judge constitution bench of Justices K.M. Joseph, Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and C.T. Ravikumar also favoured the setting up of an independent secretariat for the Commission and also to provide that the expenditure be charged on the Consolidated Fund. It tasked the central government to "seriously consider bringing in the much-needed changes".

"We only would observe that in the light of the fact that Election Commissioners have become part of the Election Commission, perhaps on the basis of the volume of work, that justices such an appointment and al-

so the need to have a multi-Member body otherwise, it is for Parliament acting in the constituent capacity to consider whether it would be advisable to extend the protection to the Election Commissioners so as to safeguard and ensure the independence of the Election Commissioners as well," Justice Joseph said.

"It is desirable that the grounds of removal of the Election Commissioners shall be the same as that of the Chief Election Commissioner that is on the like grounds as a Judge of the Supreme Court subject to the 'recommendation of the Chief Election Commissioner' as provided under the second proviso to Article 324(5) of the Constitution of India," Justice Rastogi said in his separate but concurrent judgement.

Observing that dependence on Centre for funds could result in compromising the independence of the Commission, the bench said, "One of the ways, in which, the Executive can bring an otherwise inde-

pendent Body to its knees, is by starving it off or cutting off the requisite financial wherewithal and resources required for its efficient and independent functioning. It would not be unnatural if faced with the prospect of it not being supplied enough funds and facilities, a vulnerable independent functionary to the pressure from the Executive and, thus, it would result in an invidious but inevitable conquest of an otherwise free and independent Commission".

"We cannot be oblivious to the need for articulation of details in regard to the expenditure, which is a matter of policy, which may come in from doing. We would only make an appeal on the basis that there is an urgent need to provide for a permanent secretariat and also provide that the expenditure be charged on the Consolidated Fund of India and it is for the Union to seriously consider bringing in the much-needed changes," it said.

# Congress calls verdict 'timely'

Giving its wholehearted thumbs up to the SC judgement on the appointment of CEC and ECs, Congress said the judgement should be extended to the selection of the head of the Enforcement Directorate, in which the Congress has been overwhelming AIICC-spokesman Abhishek Singhvi called the judgement "timely", as he alleged that the Modi government has been among the worst offenders in violation of electoral safeguards. "It gives the EC an important reminder of its role in maintaining our democracy," he said.

# JNU notification on misconduct set aside

New Delhi: Amid strong opposition from various students' organisations and a day after issuing a notification listing a range of activities, including protests and demonstrations, as "misconduct," Jawaharlal Nehru University (JNU) on Thursday withdrew the notification for "administrative reasons".

The notification had laid down details of penalties to be imposed on students for misconduct, which included

fines as high as Rs 50,000 and even expulsion. The university had also said that the new guidelines had been approved by the varsity's executive council. In the notification issued by Rajesh Kumar Mishra, the university's chief proctor, the administration said, "In view of the administrative reasons, the notification dated February 28, in respect of rules of discipline and proper conduct of students of JNU, is hereby withdrawn".

# Burning wood thrust into girl's mouth over offering 'bhog'

Raipur: A piece of burning wood was thrust into the mouth of a minor girl by three people, who worked as 'sevadars' (volunteers) at an ashram in Chhattisgarh, following a dispute over offering 'bhog'. The girl, who also worked as a volunteer at the ashram, sustained burns on her tongue, lips and throat.

She is under danger, said police, adding that the victim was also beaten by the accused, leading to multiple injuries on her thigh, back, arms and throat. The incident took place at Jal Ganga Mantra Ashram, Bagbahara in Raipur, on February 23. Three accused have been arrested, Bagbahara police said. Police registered a case against the trio under relevant IPC sections. The victim's elder brother filed a complaint on February 28 and the trio was admitted to the crime. The wooden stick used in the crime and a piece of burnt wood were seized from the spot.
