Khalistani threat to Assam CM: Security intensified at airport, stns

Chief minister Sarma will continue to be a part of the existing security measures

SNS & AGENCIES GUWAHATI, 3 APRIL

After a threat was issued by a Khalistani outfit to Assam Chief Minister Himanta Biswa Sarma, the police on Monday reviewed the CM's security and also that of the airports and railway stations.

A top police officer of the state told IANS that as of now, Chief Minister Sarma will continue to be a part of the existing security measures. He has Z+ security cover currently.

However, police have stepped up security vigilance at railway stations and airports



across the state. Additional Director-General of Police (DGP) Hiren Nath has been looking after the security measures. An FIR was lodged on Sunday evening at the Special Task Force police station in Dispur. Earlier on Sunday evening, a section of journalists in Assam received calls from

different mobile numbers. On receiving the calls, allegedly, a person claiming to be Gurpatwant Singh Pannu of the 'Sikh for Justice' outfit issued 'threats' for Sarma.

The voice said, "Pro-Khalistan supporters imprisoned in Assam have been tortured. Listen very carefully, CM Sarma, the fight is between pro-Khalistan Sikhs and the Indian regime."

"We are seeking the liberation of Punjab from Indian occupation through the peaceful democratic process of the Khalistan referendum. If your government is torturing and harassing the six, you will be held accountable," the voice

added.

G.P. Singh, Assam DGP, said, "Reference an audio clip threatening the Chief Minister of Assam by a person called Gurpatwant Singh Pannu, a designated individual terrorist under Indian law and heading an unlawful association called Sikhs for Justice (SFJ)."

He added, "The security component of the Chief Minister has been adequately sensitised. In view of global events, the threat is being taken very seriously by the Assam Police, and the central agencies have been kept in the loop on the issue."

The Lok Sabha had a few minutes' sittings both in the morning and the afternoon before being adjourned till Wednesday as Tuesday is a holiday due to Mahavir Jayanti.

The Rajya Sabha passed the Competition Amendment Bill, 2023 in the afternoon without discussion. The Bill, already passed by the Lok Sabha, was taken up for consideration amidst protests from the Congress and other Opposition parties.

Chairman Jagdeep Dhankhar called for a voice-vote on the Bill as there was no member coming forward to discuss it, and declared the Bill as passed. The House was adjourned till Wednesday. Leader of the Opposition Mallikarjun Kharge failed to

He said the Council of States, as defined in the Constitution, plays a critical role in India's polity. Jharkhand HC seeks response from govt, ED over CM Soren, family mining case

RANCHI, 3 APRIL

The Jharkhand High Court on Monday issued notice to the state government and the Enforcement Directorate (ED) while hearing a PIL in the matter of allotment of mining lease in the name of Chief Minister Hemant Soren and his relatives.

A bench headed by Chief Justice Sanjay Kumar Mishra, sought answers from both in the matter and has fixed the next hearing on May 1. The PIL has been filed by advocate and RTI activist Sunil Kumar Mahto.

During the hearing, Advocate General Rajeev Ranjan, on behalf of the state government, questioned the maintainability of the PIL and said that it was not worth hearing.

Ranjan stated that in a similar case, the order passed by the division bench of the high court against Soren and others in the PIL filed by Shiv Shankar Sharma and others has been dismissed by the Supreme Court.

He added that the same issue should not be raised again in the petition.

Appearing on behalf of the petitioner advocates Vinod Singh and Vishal Kumar told that Soren had misused his constitutional position while holding the post of Minister of Mines and had allotted a mining lease to himself, his wife, and his sister-in-law.

BJP, Congress engage in a war of words over ED's action in Chhattisgarh

AGENCIES RAIPUR, 3 APRIL

Enforcement Directorate's (ED) fresh action in Chhattisgarh has struck a 'war of words' in the political arena here as Chief Minister Bhanup Singh Baghel called the raids a politically motivated move.

At the same time, the BJP rejected the allegations and questioned the role of those arrested by the central agency in the politics of Congress. "BJP questioned two officials (who were arrested by ED) against whom the central agency conducted a probe under the most stringent law in the country. As nothing was found against them, the case has been given to the state for undertaking the probe," said CM Baghel, questioning that if they (ED) would have found anything concrete, the question of forwarding the case to the state would not arise.

Baghel stated this while talking to the media at Swami Vivekananda Airport in Raipur on Monday.

Following the letter received from the ED Director, the state government has launched a probe but what about the letters we have sent to the agency requesting to probe the chit fund and NAN (civil supplies corporation) scam, said Baghel.

When would the ED, which is probing the NAN scam,



reveal who is CM sir and CM madam and when they will conduct a probe against people indulged in chit fund scam, questioned the Chhattisgarh CM.

"Congress and Chief Minister Bhanup Singh Baghel are repeatedly levelling allegations on ED that their actions are political. I wanted to ask them businessman Suryakant Tiwari, officer Saumya Chaurasia and IAS Sameer Vishnoi, who were arrested by ED in connection with an alleged coal leavyscam, were holding which post in Congress," said IAS-turned-politician OP Choudhary, who is a BJP spokesperson.

He said what relations these people have with the politics of Congress and if they don't have any connection with the ruling party then why is CM Baghel not taking action against them?

The name of the officer was also not removed from the government website, Choudhary alleged.

It may be recalled here that earlier, in the case, ED had arrested IAS Sameer Vish-

no, businessman Sunil Agarwal and Suryakant's uncle Laxmikant Tiwari on October 13. ED arrested Suryakant Tiwari on October 30 and on December 2 the federal agency arrested Saumya Chaurasia. On December 9, ED filed a prosecution complaint against Suryakant Tiwari, IAS Sameer Vishnoi, Laxmikant Tiwari, Sunil Agarwal and others before the PMLA Special Court, Raipur.

The money laundering investigation was launched after the ED took cognisance of an Income Tax department complaint. The financial crimes probe agency in October carried out multi-city raids in the state as part of its probe. The ED on March 29 had carried out searches against Congress leader and Raipur Mayor Ajaz Dhebar, his brother Anwar Dhebar, liquor businessman Baldev Singh Bhatia alias Pappu Bhatia and others.

4 days after stepwell collapse, Indore temple demolished

Four days after the tragic death of 36 people in the stepwell (baawdi) collapse at the Beleshwar Mahadev Jhulelal Temple in Indore, the district administration and Indore Municipal Corporation (IMC) authorities demolished the temple on Monday and filled up the stepwell using the temple's debris.

A heavy police force was deployed early morning at the demolition site, as many people gathered at the spot protesting against the government's action and tried to prevent the demolition drive.

However, the temple was reduced to rubble using JCB machines in the presence of the police to prevent any untoward incident or trouble by the protesting members of several Hindu religious organisations.

The old structure of the temple along with several columns constructed for a new structure and the temple's dome top were demolished



in the action today. According to officials, before the demolition drive began, the idols inside the temple were taken out safely and shifted to the nearby Kantafod temple at the Agrasen Square in the city.

Officials said that besides the demolition drive at the temple in the Patel Nagar locality of Juni Indore area, the IMC and district administration authorities also demolished illegal religious and other structures created over wells at the Dhakkanwala kuan site, the Khattu Shyam Temple in Gadakhedi and at the well in the Sukhalia area.

Massive landslide at hydroelectric project construction site triggers panic: A massive landslide, triggered by incessant rainfall in Arunachal Pradesh on Monday, caused damage in the main part of the under-construction dam in the Lower Subansiri hydroelectric power project in Assam's Dhemajiri district. Mud and large boulders crashed after the huge landslide hit the hydroelectric project and the labourers had to be evacuated to a safe place. According to police, no casualty was reported from the construction site.
