SC issues contempt notice to Nagaland, state poll panel on urban bodies election

New Delhi: Taking strong exception to the Nagaland SEC's decision to cancel urban local bodies' elections in the state in violation of the SC's order, the apex court on Wednesday issued notice to the state govt and the SEC on contempt proceedings. Senior advocate Co-

lin Gonsalves, appearing for NGO People's Union for Civil Liberties, on whose plea the apex court nudged the state to hold election with 33% reservation for women candidates, brought to the court's notice violation of the order and pleaded the bench headed by

Justice Sanjay Kishan Kaul to initiate contempt proceedings against CM chief minister N. Phiso Rio, chief secretary T. N. Toy and state election commissioner Mhabemo Yanthan "for playing a leading role in disobeying the order of this court". **TNN**
