Shinde, Fadnavis hail top court verdict as 'triumph of truth'

Alliance leaders said all the doomsayers who predicted the govt's downfall have been silenced

Soon after the Supreme Court verdict, the ruling Shiv Sena-Bharatiya Janata Party alliance on Thursday hailed the verdict as "a triumph of truth" which has 'vindicated' their stance as the state government now has got a stamp of approval.

Speaking to the media, a visibly relieved Chief Minister Eknath Shinde and a beaming Deputy CM Devendra Fadnavis said that all the doomsayers who predicted the downfall of the state government have been silenced by the SC judgement.

"We fully support the SC ruling... It was on expected lines. We are happy, our stand has been upheld by the highest court of the land," the duo said, 11 months after they toppled the Maha Vikas Aghadi government headed by former CM Uddhav Thackeray in June 2022.

Shinde added that for all these months, the Opposition



had been spreading canards that the government was illegal and unconstitutional and "would collapse anytime, but all their predictions were proved false".

"The majority is important in a democracy and we enjoy the majority... There is a Constitution in this country and nobody can go beyond it, this is clear from the SC judgement. It is evident that the government we have established was within the laws," Shinde

pointed out. On the resignation of former CM Uddhav Thackeray, Shinde took a pot-shot saying he (Thackeray) knew that he had lost the majority and had no options but to quit his office.

After resigning he attempted to prove it as a principled stand, "but we have preserved morality", and saved the Shiv Sena formed by Balasaheb Thackeray's ideals which he (Uddhav Thackeray) had mortgaged with the Congress and

Nationalist Congress Party, Shinde averred.

Referring to the point of disqualification of the 16 MLAs, including himself, Shinde said that now the final decision on this would be taken by the Speaker (Rahul Narwar) following the rule of law.

"Today, our government has got the approval of the SC as a full majority government... We welcome the judgement," declared Shinde.

Fadnavis termed it as a

victory of the people and democracy, and the SC has "completely turned the tide against the MVA".

"The SC has made it clear that Uddhav Thackeray cannot be made the CM again, the right of disqualification of the 16 MLAs vests with the Maharashtra Assembly Speaker, who will take the decision and the SC has refused to interfere in this," Fadnavis pointed out.

He also took a swipe at Thackeray saying after realising that he did not have a majority, he (Thackeray) quit as the CM and then took a high moral ground.

"Those who adopted an unprincipled stand by breaking off with the BJP and joining hands with the Congress-NCP have no right to give lessons on ethics to others," said Fadnavis sharply.

The Sena-BJP activists in Mumbai and other parts of the state erupted into celebrations, distributing sweets and congratulating each other after the much-awaited SC judgement was delivered this afternoon.

Former JD-U president RCP Singh joins BJP

Former Union Minister and Janata Dal-United (JD-U) president R C P Singh today joined the Bharatiya Janata Party (BJP), praising Prime Minister Narendra Modi for the country's all-round development.

He was formally inducted into the party by Union Minister Dharmendra Pradhan at the BJP headquarters.

Mr Singh quit the JD(U) last year following sharp differences with Bihar Chief Minister Nitish Kumar after the Janata Dal (United) sought a reply from him on corruption allegations related to 'discrepancies in immovable properties'.

Talking to reporters after joining the BJP, Mr Singh launched a frontal attack on Nitish Kumar, saying he was 'hungry' for 'Chair'. He said; "Nitish Babu says he is against crime and corruption but he is doing everything for another 'C' i.e. chair".

He wondered why Nitish Kumar was going from one state to another for Opposition unity and the people of Bihar voted him to power for the welfare of the state.

Mr Singh also heaped praise on the PM, saying it was because of the work being done by his government that India has now become the fifth-largest economy in the world.

Jaishankar to leave for B'desh, Sweden & Belgium

External Affairs Minister S Jaishankar is leaving today on a three-nation tour of Bangladesh, Sweden and Belgium.

He will be in Dhaka today and tomorrow to participate in the sixth edition of the Indian Ocean Conference. The conference will be attended by President of Mauritius Prithviraj Singh Roopun, Vice President of Maldives Faisal Naseem, Prime Minister of Bangladesh Sheikh Hasina and several ministers from across the world.

From Bangladesh, Jaishankar will be travelling to Sweden (13-15 May). This will be his first visit as foreign minister to Sweden and comes at a time when the two countries are celebrating 75 years of the establishment of diplomatic relations.

Sweden currently holds the Presidency of the Council of the European Union. In Sweden, he will participate in the second EU Indo-Pacific Ministerial Forum (EIPMF). He will hold bilateral meetings with the foreign ministers of several countries on the margins of EIPMF. During his stay, he will call on leadership in Sweden and meet with key Ministers. He will also participate in the inaugural session of the India Trilateral Forum (India, Europe and US) with his Swedish counterpart.

In the last leg of the visit, Jaishankar will be visiting Brussels (15-16 May) for bilateral engagements with Belgian and EU officials. He will also be attending the first ministerial meeting of the India-EU Trade and Technology Council along with Minister of Commerce & Industry Piyush Garg and Minister of Railways, Communications, Electronics and Information Technology Ashwini Vaishnaw. The TTC ministerial meeting is scheduled to be held on 16 May.

'Shinde must resign if he has any morality': Uddhav Thackeray

Former Maharashtra chief minister Uddhav Thackeray in his first reaction to Thursday's Supreme Court verdict on the face-off with his successor Eknath Shinde stated that the latter should step down on "moral grounds" alleging he "murdered democracy" to assume power. Noting that the apex court in its verdict stated that he would probably have been reinstated as chief minister had he not resigned from the post in 2022, Thackeray said he was not fighting for himself but for the people of Maharashtra.

At a joint press conference which was also attended by Bihar chief minister Nitish Kumar, Thackeray said, "People who left my party have no right to ask me questions. If this CM (Shinde) has any morality, he must resign as I did. They betrayed my party and the legacy of my father. I may have done wrong



by resigning but I did it on moral grounds."

"I would have become CM of Maharashtra again today if I would have not resigned by myself in 2022, but my struggle is for saving democracy, my state and my country and that is why I stepped down on moral grounds and now Shinde should do the same," he added.

"If the current Maharashtra CM and deputy CM have any ethics, then they should resign," Thackeray said. Meanwhile, Maharashtra deputy chief minister Devendra Fadnavis said, "It doesn't suit Uddhav Thackeray to talk about morality. I want to ask him if he had forgotten his morals when he went with NCP and the Congress for the CM post. He had not resigned

on moral grounds but due to fear after people who were with him left him." Fadnavis also termed the Supreme Court verdict as a victory for democracy and the democratic process and that "no one should doubt that the Maharashtra government is completely legal."

A Constitution bench of the apex court today ruled that then Maharashtra Governor BS Koshiyari's decision to call for a floor test in June 2022 was not in accordance with the law. The bench added that a Floor Test cannot be used as a medium to resolve inter-party disputes or intra-party disputes. The court was hearing a batch of petitions in connection with the political crisis in Maharashtra last year that led to a vertical split in the Shiv Sena. It led to the then chief minister Thackeray, who led the tripartite Maha Vikas Aghadi government in the State to resign after 16 of his party's MLAs, including Eknath Shinde, rebelled and broke away in June 2022.

Punjab: Five men arrested for low-intensity blasts in Amritsar

Punjab Police arrested five persons on Thursday in connection with the low-intensity blast incidents near the Golden Temple in Amritsar.

The accused are identified as Azadvir Singh, Amrik Singh, Sahib Singh, Harjit Singh and Dharminder Singh. The Director General of Police (DGP) Gaurav Yadav said Azadvir, a resident of Amritsar and Amrik, resident of Gurdaspur, were the main perpetrators while Sahib, Harjit and Dharminder, residents of Amritsar, were the persons who sourced and supplied the explosives, the DGP said. He said Sahib Singh has a licensed agency for storing explosives.

The police also recovered 1.10 kilograms of low-intensity explosive, which is normally used in firecrackers.

Mr Yadav said the first explosive device was assembled in the bathroom of a 'sarai' (inn) on 6 May with 200

grams of explosive in two energy drink cans. A metallic tiffin was also filled with the same explosive material.

"All these three containers were placed in a polythene bag. Azadvir had gone to the rooftop of the heritage parking building and then he hung the polythene bag with the help of a rope at about 11 p.m. on 6 May. The first explosion took place at 11:25 p.m.," said the DGP.

The second IED was assembled by using two metallic bowls which were then joined together and it was again done in the bathroom of the sarai on 7 May.

The arrests came hours after a third explosion took place on Wednesday midnight in Galiara, the pathway and park around the Golden Temple, behind Guru Ramdas Ji Niwas (inn) building, police said.

The DGP said a special investigation team will be formed to further investigate the matter. He said the motive behind the explosions is yet to be ascertained.

Minor clashes during 2nd phase of civic polls in Uttar Pradesh: Over 50 pc voters exercise franchise

Amidst reports of minor clashes and charges of rigging, the second phase of polling in 38 districts were held peacefully on Thursday with over 50 per cent of the total 1.92 crore voters exercising their franchise.

In Meerut supporters of BJP and Independent candidates clashed in Modipuram area after which several people were taken in custody. In Azamgarh, there was a clash between police and BJP supporters over fake voting at Waisly College booth while in Ballia six people were taken in custody for fake voting.

In Ballia, Congress nagar palika chairman candidate Raj Kumar Gupta contesting from Rasra was critically injured in an attack on Thursday morning.



In Basti, BJP MLA Ajay Singh had a verbal feud with SP leader Kaushlendra Singh in Harriya. A husband of the BSP woman candidate was arrested in Hamirpur for threatening voters.

Police said reports of minor clashes between supporters of political parties were received from Badaun, Bareilly, Amethi, Ayodhya, Kanpur, Auriya and Mainpuri.

There were also reports of malfunctioning of EVMs used in the Corporation polls while in several booths people complained of deletion of their names from the electoral rolls.

State Election Commissioner Manoj Kumar told The Statesman here on Thursday that the second phase of polling in 38 districts passed off peacefully.

He said there were some

reports of minor disputes in some areas but it was resolved immediately. "We have sought reports from observer's on the complaints received from the political parties," he said.

Meanwhile, Samajwadi Party president Akhilesh Yadav has alleged rigging of polls by the ruling BJP in several areas with the support of the official machinery.

"Such polling makes mockery of the democracy where the voters felt cheated," he said here in a statement on Thursday.

Over 2 lakh policemen along with 35 companies of central forces and 85 companies of PAC have been deployed in the second phase of polling where 1.92 crore voters will elect candidates in 6929 posts in the three-tier civic polls. There are 39,146 candidates in the fray in this phase.

The polling for the first

phase were held in 37 districts, including for 10 mayoral posts, on 4 May. Votes of both the phases will be counted on 13 May.

The Mayoral posts for which polling was held on Thursday are those for Kanpur, Aligarh, Meerut, Shahjahanpur, Ghaziabad, Bareilly and Ayodhya.

The districts went to polls in the second phase are Hapur, Gautam Buddha Nagar, Ghaziabad, Baghpat, Bulandshahr, Meerut, Bareilly, Badaun, Shahjahanpur, Pilibhit, Hathras, Kasganj, Etah, Aligarh, Kanpur, Kanpur Dehat, Farrukhabad, Etawah, Kannauj, Auriya, Hamirpur, Chitrakoot, Mahoba, Banda, Ayodhya, Sultanpur, Ambedkar Nagar, Barabanki, Amethi, Basti, Sant Kabir Nagar, Sidharthnagar, Azamgarh, Mau, Ballia, Sonbhadra, Bhadoi and Mirzapur.

Record 30,000 criminals punished in UP over last three years

Over 30,000 criminals have been convicted and awarded various forms of punishment in the last three years of the Yogi Adityanath government, setting a record of sorts.

The Adityanath government has adopted a zero tolerance policy as part of its mission to rid the state of Uttar Pradesh of crime.

According to the latest statistics of the Directorate of Prosecution, as many as 10,520 criminals were given punishment by the court under the Arms Act from the year 2020 to 2022.

Besides, 4078 criminals were given punishment under the POCSO Act, 1218 for

involvement in rape cases, 8,646 for crimes against women and children, 2,387 for murder, 1,152 for dowry deaths, 1,141 for robberies and 279 in cow slaughter cases.

The Directorate of Prosecution has also bagged several honours for the award of punishments to a record number of criminals.

Even as UP Police have killed 184 miscreants in encounters so far, criminals and gangsters also are being punished through effective prosecution in the court.

Prosecution Directorate's ADG Ashutosh Pandey said here on Thursday that in the last three years, effective prosecution in the court and 100 per cent testimony of witnesses has ensured punish-



ment of the criminals.

Against punishments given to 535 criminals in the year 2020 in POCSO Act cases, 2,313 criminals were penalized in 2022, registering an increase of 332 per cent.

In the cases of rape, 671 criminals were punished in 2022 against 177 in 2020, registering an increase of 280 per cent. Similarly, in the year 2020, in the cases of crime

against women and children, 1048 criminals were punished while in the year 2022, 5351 criminals were punished, recording an increase of 411 per cent. In murder cases, 420 criminals were awarded punishment in the year 2020 while 1180 criminals were punished in 2022, registering an increase of 181 per cent.

A total of 572 criminals were awarded punishment in 2022 in dowry death cases as against 182 criminals in 2020.

Similarly, in the year 2022, 745 criminals were penalized in 2022 against 177 in 2020 in robbery cases, registering an increase of 321 per cent. In cow slaughter cases, 200 criminals were penalized in 2022 against

29 in 2020.

However, in the last three years maximum number of punishment was given in Arms Act cases. A total of 6373 criminals were punished under Arms Act in 2022 against 1960 in 2020, registering an increase of 225 per cent.

Mr Pandey, ADG of the Directorate of Prosecution, said that in the year 2021, the Ministry of Home Affairs, Government of India, on behalf of the National Crime Report Bureau under the ICJS system, had awarded Uttar Pradesh for prosecution work in the country. This award was also given to the Prosecution Directorate of Uttar Pradesh in the year 2022. Similarly, in the year 2022, the SKOCH Award was awarded for e-Prosecution.

Due to continuous absence of Dr. Biswas from appearing before the IO during inquiry proceedings, the proceedings were held ex-parte by the IO as per extant rules and the IO submitted the Inquiry report dated 20.01.2023 holding the charges of unauthorized absence as stands substantiated. The DA had provisionally accepted the said Inquiry report and the same was accordingly sent to the last known address of Dr. Biswas(CO) by Regd. Post with A/D as well as sent by Special messenger enabling him to submit his representation / submission, if any, thereon for the consideration of Disciplinary Authority before taking final decision, but the CO refused to receive the Inquiry report.

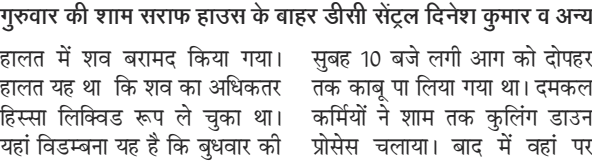
