

‘Can’t release water to TN as per SC order in distress years’

POINTING out to the “distress condition” which has arisen in Karnataka’s Cauvery basin due to failure of southwest monsoon, Karnataka govt has told the Supreme Court that the state is not obliged and cannot be compelled to ensure stipulated release of water totalling to 177.25 TMC to Tamil Nadu.

Calling TNs application “wholly misconceived”, Karnataka govt in its affidavit filed by Additional Chief Secretary, Department of Water Resources,

Karnataka has said, “The prayer (demanding the release of 24,000 cusecs per day from the reservoirs in Karnataka is based on an assumption that this water year is a normal water year. The prayer (for ensuring “the stipulated release from the month of September, 2023 (36.76 tmc)” has no legal basis, since the said quantity is stipulated in a normal water year and this water year being a distressed water year so far, it is not applicable.”

The response has been filed in TN govt’s plea to direct di-

rect Karnataka to release forthwith 24,000 cusecs of water from its reservoirs to save the standing paddy crops.

Tamil Nadu in its petition said the Cauvery Water Management Authority (CWMA) had on August 11, 2023, reduced the water to be released by Karnataka for 15 days (from August 11) from KRS and Kabini reservoirs to be realised at Billigundlu on the interstate border to 10,000 cusecs (0.864 tmcft per day) from 15,000 cusecs.

“But even this has not been complied with by the Karnataka government,” Tamil Nadu said.

FALSE AFFIDAVIT

Gadwal MLA’s election invalid, HC imposes fine

JUSTICE T Vinod Kumar of the Telangana High Court on Thursday ruled the election of BRS MLA Bandla Krishna Mohan Reddy from the Gadwal Assembly constituency as invalid and declared BJP leader DK Aruna as the MLA in his place.

Additionally, the judge imposed a penalty of ₹2.5 lakh on Krishna Mohan Reddy for the submission of a false affidavit to the Returning Officer and the Joint Collector, who also holds the role of the Additional District Magistrate for the 79-Gadwal Assembly constituency. Moreover, the court also directed the BRS leader to reimburse the petitioner, Aruna, ₹50,000 for costs incurred.

In the 2018 Assembly elections, Aruna had contested on a Congress ticket but eventually lost to the BRS (then TRS) candidate Krishna Mohan Reddy by a margin of around 28,000 votes.

WHILE this was Telugu cinema’s big moment under the sun as the industry took home the lion’s share of the prize from the South in the 69th National Awards, Malayalam cinema contributed wins in four categories — Best Audiography (Chavittu), Best Debut Film (Meppadiyaan), Best Film on Environment (Aavasavyuham), Best Screenplay (Shahi Kabir for Nayattu) — and Tamil cinema bagged just one with Shreya Ghoshal winning her fifth National Award for her rendition of the AR Rahman song, ‘Maayava’ from Iravin Nizhal.

This edition of the National Awards has a number of controversial choices, but the elephant in the room is The Nargis Dutt Award for Best Film on National Integration, which went the way of The Kashmir Files. This film that polarised audiences, has been heralded as a film that integrated the nation. There were plenty of snubs too for films that seemed like sure-shot winners across categories. Tamil

films like Jai Bhim, Sarpatta Parambarai, Master, and Karnan won nothing. While Pushpa had Allu Arjun deliver his career-best performance, social media expressed anguish about Dhanush, a two-time winner for Best Actor, not making it a hattrick. Last year’s winner Suriya, incidentally, was one of the first people to congratulate Allu Arjun for joining the prestigious list of National Award-winners.

Telugu industry stalwarts like Chiranjeevi and SS Rajamouli too praised Arjun, and the other winners for creating an indelible mark in their history. Meanwhile, Karan Johar-backed Shershaah received a Special Mention, and this also came the way of actors like the late Nallandi, who featured in M Manikandan’s Kadaisi Vivasayi, and Indrans for Home. Incidentally both films won the Best Regional Film in Tamil and Malayalam, respectively. Director Rojin Thomas (Home) said, ‘I’m particularly delighted with Indrans etan’s win. He truly deserved it after

all these years of hard work. Most of our team members hail from a non-film background. We hope this honour will inspire many others to dream big and pursue it.”

The biggest winners at this year’s National Awards are films that reopened the film market and brought audiences back to the theatres after the pandemic. If Pushpa managed to create box-office records and become a bonafide pan-Indian success, Gangubai Kathiawadi was a film that reinvigorated the Hindi cinema audience and convinced them to return to theatres.

With the 2021 National Awards drawing to a close, let it also be noted that this marks the end of the ‘stop-gap years’... a result of the pandemic. With the two years finally getting tallied out, it is time to see how the colour of the awards changes. But for now, the South remains on top... but Hindi cinema has convincingly gained lost ground.
