Wait is over: Congress list with seven names out

AFTER extensive deliberation spanning five days, Congress has finally unveiled its candidates for seven out of nine Lok Sabha constituencies. The announcement made late Saturday night brings a mix of incumbents and fresh faces into the fray. Notably, former IAS officer Sasikanth Senthil, who voluntarily retired, emerges as a new entrant, securing the ticket for Tiruvallur reserved seat. The candidate list includes former MLA K Gopinath for Krishnagiri, incumbent MP S Jothamani for Karur, Arani MP MK Vishnu Prasad for Cuddalore, Karti P Chidambaram for Sivaganga, B Manickam Tagore for Virudhunagar and Vijay Vasanth for Kanniyakumari.

However, the party is yet to declare candidates for the remaining two constituencies — Mayiladuthurai and Tirunelveli—newly added to the party's roster. This stag-

gered approach to candidate announcements mirrors the strategy employed during the 2019 elections. Sources within the party attribute the delay to the pressure exerted by incumbent MPs eager to retain their seats and aspirants vying for selection in contested constituencies. The intensity of this internal tussle underscores the party's confidence in securing a significant number of seats, bolstered by its alliance strength.

Pressure from the Vanniyar community to secure representation in key constituencies like Cuddalore or Krishnagiri has influenced candidate selection. While Vishnu Prasad has

been named for the Cuddalore seat, the decision has sparked dissatisfaction among some Vanniyar leaders advocating for Rama Suganthan's candidacy. Similarly, rumours of nominating a Chennai-based leader for Tirunelveli have met with resistance from local leaders, who advocate for a native candidate. The sources added that it was the main reason the candidate hadn't been announced for the Tirunelveli seat in the first list.

Meanwhile, incumbent Trichy MP Su Thirunavukkarasar is lobbying intensively for a ticket in the Mayiladuthurai seat, sources added.

With over 40 influential individuals, including former elected representatives, vying for candidacy, only a few have succeeded, such as former Gopinath and Sasikanth Senthil. However, the cadres of the seven constituencies heaved a sigh of relief after the announcement of candidates for their respective constituencies.



AIADMK replaces candidate for Tirunelveli

CHENNAI: AIADMK general secretary Edappadi K Palaniswami on Saturday announced that the party has changed its candidate for Tirunelveli Lok Sabha seat. The party replaced Shimla Muthuchozhan, who recently joined the party, with M Janshi Rani, a party

functionary and Thisaiyanvilai town panchayat president.



Muthuchozhan was earlier with the DMK and came to limelight when she contested against former chief minister J Jayalalithaa in the 2016 Assembly election. It is believed that the AIADMK replaced her

in response to discontent among party cadre over the choice.

Meanwhile, TMC (M) president GK Vasan named SDR Vijayaseelan as the party's candidate for Thoothukudi seat. The party had already announced its candidates for the other two constituencies - Erode and Sriperumbudur. ENS

Banker swindles ₹15.7L from woman's bank a/c

A 39-year-old private bank official was arrested for allegedly swindling over ₹15 lakh from a woman's bank account by misusing her banking credentials in Karaikal.

As per police, M Rajarajeswari(57) of Praharan Street, rented out the first floor of her house to a private bank and the accused, J Dakshinamurthy of TR Pattinam, was working as an operations manager in the said bank. Around November last year, she handed over her phone to Dakshinamurthy to help her register in another bank's mobile application. The latter, however, found that she have a fixed deposit of ₹20 lakh in a joint account with her husband, who died in 2021. He then took note of her login credentials, police said. "He applied for an overdraft loan on the deposit and transferred ₹15.75 lakh of it to a Rajkumar," said Inspector V Purushothaman.

When Rajarajeswari's son

Maresh, visited the bank on February, he came to know about the "overdraft loan". Based on her complaint, the cyber crime police launched an investigation. During inquiry, Rajkumar allegedly told that he thought he received a loan from his bank, for which he sought Dakshinamurthy's aid. Mentioning Rajkumar also having limited knowledge on banking matters, Karaikal Senior Superintendent of Police Manish told TNIE, "We learnt that Dakshinamurthy had sought a commission of ₹2.5 lakh from Rajkumar for the loan he 'brokered'." The suspect was arrested on Friday and was remanded on jail.
