Corpn begins nosecount of strays after a gap of six years

AMIDST an increase in the number of human-dog conflict cases being reported in the city, the Greater Chennai Corporation on Wednesday commenced the street dog survey. The last dog census was carried out in 2018 when the civic body pegged the number of stray dogs at 57,336, a marked decrease from the 82,438 dogs recorded in the 2014 census. However, with a lull in animal birth control surgeries during the Covid 19 pandemic, officials estimate the number to have gone up to at least 90,000 now.

The present survey is being conducted by Worldwide Veterinary Service India in association with the city corporation and TN Animal Welfare Board. Trained volunteers on two-wheelers will collect data of dogs sighted on transect routes from 6.30 am. Average value will be arrived at from three replicates of survey data from each route. Each route will comprise three to five wards and trained surveyors in over 50 teams will be part of survey.

Speaking to *TNIE*, Dr Karlette Anne Fernandes, Director of Companion Animal Management, WVS, said that the survey would not include pet dogs

and would focus on the community dogs. She added that along with surveying the number of dogs, the team will also focus on demographics with information on the dogs' gender and age. In addition, the surveyors will look for lactating dogs, which is an indicator of a growing population in the area and their sterilisation status.

"We will also note down the general well-being of the animals - if they have severe skin issues or tumours, if they are lame and other visible health issues to get an overview of the general health of the commu-

nity dogs," said Fernandes.

This data is to be entered into a mobile application along with a geo-tag. The survey is expected to be completed in the next two months. At the end of the survey, the city corporation will have information on the number of dogs per kilometre, which is considered a more accurate estimation of the dog population along with an overall estimate with a 95% confidence interval. The survey had been originally planned for every four years. However, corporation officials gave the survey a miss in 2022 when it was due.

Trans woman lodges cheating complaint against Home Guard

Chennai: A 38-year-old trans woman has lodged a police complaint against a Home Guard attached to a city police station for allegedly cheating her of ₹10 lakh under the pretext of marrying her. According to a police source, the Home Guard officer was in a relationship with the trans woman for the past four years. The duo also lived together for a while. In her complaint lodged on Tuesday, the trans woman said that over the past few years, the man obtained a total of ₹10 lakh from her in several instalments. He had also promised to marry her. However, the man stopped talking to her several months ago and also refused to return the money. The police source said that the suspect is currently at a drug rehabilitation centre in Coimbatore.

An FIR is yet to be registered, the police source further said. ENS

Lawyer murdered on busy Thiruvannmiyur street

A 31-year-old lawyer was hacked to death allegedly by three men on a busy street in Thiruvannmiyur on Tuesday evening. Police arrested N Kamalesh (27), M Nithyanandam (27) and K Parthiban (31), residents of Kannagi Nagar and Kottivakkam, in connection with the case the following day.

The deceased, Gowtham of Avvai Nagar in Thiruvannmiyur, practised at the Saidapet court. While returning from



work on his two-wheeler on Tuesday, Gowtham stopped at an ATM a few metres away from his home and was talking to his friends there, when a gang arrived and attacked him with knives. Though the lawyer ran away, the trio chased him down and hacked him.

As people gathered on the busy street, the gang fled. Passersby rushed Gowtham to a nearby private hospital, but despite intensive treatment, he soon succumbed to his injuries. Personnel attached to the Thiruvannmiyur

police station rushed to the spot and conducted an inquiry. Later, Gowtham's body was shifted to the Royapettah government hospital for postmortem.

Based on a complaint filed by the victim's brother B Aswin Babu, the police have filed a case and subsequently arrested Kamalesh, Nithyanandam and Parthiban. Police sources said Kamalesh had attacked Gowtham's friend Madhankumar last year. Irked over this, Gowtham met Kamalesh and threatened him. This might have led to the lawyer's murder, police alleged.

24-year-old man hacked to death at Korukkupet

A 24-year-old man was hacked to death by a gang at Korukkupet on Tuesday. RK Nagar police identified the deceased as Dharma, a daily wage labourer. On Tuesday night, Dharma got home from work and went to consume alcohol with his friends near the Korukkupet railway tracks. "Late at night, four men came to the spot and asked Dharma about his elder brother Surya's whereabouts. When Dharma ignored them, an argument broke out and the gang attacked Dharma with knives and fled," a police officer said.

Dharma's friends rushed him to Government Stanley Hospital, where he succumbed to injuries later. Upon information, RK Nagar police recovered the body and sent it for postmortem. Preliminary inquiries revealed that Dharma's brother Suryamoorthy and the gang had some conflict for over a year. A few months ago, Suryamoorthy attacked the gang. The police suspect that the gang attacked Dharma to exact revenge for the attack. J Jaganathan (24), R Kesavan (20) and L Kishore (25) have been arrested in the case.

Two men arrested for hurling petrol bomb at woman's house in city

Chennai: The TP Chatram police on Tuesday arrested two men who were on the run after hurling a petrol bomb at a woman's house on Sunday. The police said the duo was angry at the woman for complaining about their illegal activities to the police last year. "The suspects, A Santhosh Kumar alias Janda (22) and P Manoj Kumar (19) were arrested last year after the woman, S Amudha (29), complained about them creating a ruckus near her house in an inebriated state. They were also later arrested for waylaying and assaulting Amudha's brother-in-law. The suspects were released from prison on Saturday," police said. ENS

Two youth arrested for selling tablets and ganja

Chennai: A 22-year-old man and his 28-year-old associate were arrested by the MGR Nagar police in Nesapakkam for allegedly selling Tydol pain relief tablets and possessing 1.5 kg of ganja on Tuesday evening.
