SC to hear Bhojshala case along with pleas against Worship Act

New Delhi: In view of its recent ruling on religious conversions, the Supreme Court on Thursday ordered that the right over the Bhojshala temple-Kanal Masala mosque complex in Dhruv District of Madhya Pradesh be tagged and heard along with petitions challenging the validity of the Places of Worship Act which is being heard by a bench headed by the CJI.

Free treatment to SMA kids to cost ₹35-40k cr/yr: Centre

The bench agreed that the treatment would be given free of cost till further orders and that it would examine the policy of free treatment to such patients. On Dec 15, the bench had rushed to the aid of a 12-month-old child afflicted with SMA on finding that her father, working as a corpora in IAE is unable to arrange for her treatment at the cost of Rs 1.2 crore. The Arunachal Pradesh High Court had said five treatment had been provided all along to the child at the R&R hospital.

SC orders recreation of 40-yr-old Kamrup anti-Sikh riot FIR

New Delhi: The Supreme Court on Thursday ordered the Assam government to reconstitute a Special Investigation Team (SIT) to probe the 1984 anti-Sikh riots case and asked the state police to provide forensic evidence to the central government.

Gujarat cops arrest Russian acting as gang's 'gatekeeper'

Ahmedabad: A Russian national was arrested by Gujarat police in connection with a 'digital arrest' case in which a man was duped of Rs 17 lakh, an official said on Thursday. Anasky Mironov, a resident of Orenburg city in Russia, used to work as a 'gatekeeper' for a gang run by a Chinese national and helped in transferring the proceeds of crime into various accounts and converting some of it into cryptocurrency.
