# BIRD FLU: DUCK FARMERS DEMAND COMPENSATION FOR FINANCIAL LOSS

To stage dharna tomorrow; will hold indefinite agitation if govt fails to distribute damages

THE duck farmers of Alappuzha district are planning an indefinite agitation demanding the distribution of compensation to farmers who suffered a loss due to the spread of bird flu and the culling of ducks after the spread of the disease. Aikya Tharavu Karshaka Sangam president B Rajasekharan said that as part of the agitation, a dharna will be held in front of district animal husbandry office in Alappuzha on Thursday. "We will begin an indefinite agitation if the government fails to distribute the compensation," he said.

"Nine months have passed since the culling of ducks pushed farmers into financial

distress, yet they remain without compensation. The Union government had released its share of ₹3 crore for compensation three-and-a-half-months

ago. However, the state government has yet to provide its 40% share, as farmers are left struggling for survival," Rajasekharan said.

"Due to the ban in place until December 31, duck farmers have been unable to sell eggs and meat during key festive seasons such as Easter, Christmas and New Year, and the restriction is expected to affect the upcoming Easter as well. This prolonged ban has worsened the financial crisis faced by farmers and their families," he said.

"Adding to these woes, banks are unwilling to provide loans to duck farmers, forcing them to borrow money from private lenders at high interest rates. Many farmers depend on such loans to sustain their duck farming businesses. Now, unable to repay their debts, several farmers have become trapped in financial distress," said Sangam secretary K Samuel.

# Hearing on draft ward division proposals to be held in Alappuzha today

THE State Delimitation Commission will hold a district-level hearing on complaints related to the draft ward division proposals for grama panchayats and municipalities in the district on Wednesday. The hearing will take place at the district panchayat conference hall on the collectorate premises.

Those who have submitted objections or opinions within the stipulated time frame will be allowed to participate in the hearing. Additionally, in cases where mass petitions have been submitted, only one representative will be permitted to attend, officials said.

Complaints related to grama panchayats under Thaikattussery, Pattanakad, Kanjikuzhi, and Aryad block panchayats, as well as Cherthala municipality, will be addressed at 9am.

Complaints concerning grama panchayats under Ambalapuzha, Champakulam, Veliyanad, and Chengannur block panchayats, along with Alappuzha and Chengannur municipalities, will be reviewed at 11am.

Issues related to grama panchayats under Hariipad, Mavelikkara, Bharanikkavu, and Muthukulam block panchayats, as well as Hariipad, Mavelikkara and Kayamkulam municipalities, will be examined at 2pm.

# CPM urges Election Commission to invalidate Bipin Babu's candidature

CPM district secretary R Nazar has submitted a letter to the State Election Commission (SEC) demanding the invalidation of the candidature of Bipin C Babu, representative of Krishnapuram division in Alappuzha district panchayat.

The letter stated that Bipin had joined the BJP after resigning from the CPM, however, he was not willing to resign from his position as the division's representative. As per the anti-defection law, if a person joins another party after being elected as a representative of a particular party, action can be taken against them. The letter urged the SEC to take action against Bipin based on the law.

As per the law, the right to submit a complaint for disqualification belongs to a voter from

### ANTI-DEFLECTION LAW

Bipin had resigned from the CPM and joined the BJP on November 30. At the time of his resignation from the party, he had declared that he would step down as a district panchayat member. However, even after two months, he has not resigned from the post. According to the anti-defection law, if a person joins another party after being elected as a representative of a particular party, action

his division, a member of the district panchayat, or the leader of the party that allotted him the election symbol. Since the CPM had allotted him the symbol, party leader Nazar filed a petition with the SEC.

Bipin had resigned from the CPM and joined the BJP on November 30. At the time of his resignation from the party, he had declared that he would step down as a district panchayat member. However, even after two months, he has not resigned from the post.

The SEC has the authority to invalidate his candidature, and the CPM expects action to be taken based on the complaint. If Bipin resigns from his position it will not affect the ruling of the district panchayat.

#### Boulder falls down on house in Idukki, 1 hurt

Idukki : One person was injured after a huge boulder fell down on a house in Vattayar near Kallar in Pallivasal, Idukki, on Monday around 10am. The huge boulder rolled down from a cardamom plantation located in the upside area of the house owned by Aneesh of Parakkattil house in Vattayar. Aneesh's elder daughter Anjali was sitting in the bedroom of the house when the boulder rolled down and plunged into the house. Anjali suffered injuries after the bricks from the wall fell on her.

As Aneesh, his wife and two children were sitting in another room, they escaped unhurt. Anjali was immediately taken to the Adimaly taluk hospital and given primary medical support. Revenue officials inspected the damage on Tuesday. Local residents said they live in fear as there are more boulders that could roll down anytime.

#### 38-yr-old arrested for sexually abusing minor

Pathanamthitta: The Keezhavaipur police have arrested a 38-year-old man who broke into a house and sexually abused a 15-year-old girl. The arrested is Vinu C John, a resident of Kaniyanpara. His arrest was recorded on Saturday, following the information from the District Child Protection Unit to the cops. According to police, the incident took place in September 2023. Vinu, after breaking into the house grabbed the girl, who was sleeping, and sexually assaulted her. Following information from the Child Protection Unit, the police went to the Kozhencherry Sakhi One Stop Centre, recorded the child's statement, and registered a case. After conducting a medical examination of the accused at the Kozhencherry District Hospital, his statement was recorded at the Thiruvalla JFM Court. He was taken into custody on January 24.
