 ৬. প্রক বি এর জন্য নিলাম সফলভাবে সমাপ্ত হলে প্রক এ নিলাম বাধ্য হবে।
 ৭. বিক্রয় বিক্রয়টি ই-নিলাম প্রক্রিয়া তথ্য নথি সাথে পড়তে হবে এবং <https://ibbi.baanknet.com> এ উপলব্ধ শর্তাবলীর সাথে একমত হতে হবে।
 ৮. সনদে বিক্রয়কারী কেবলমাত্র বাছনোট নিলাম প্রক্রিয়ায় নিয়মের মাধ্যমে বাসনা জমা (ইএমটি) জমা দিতে হবে।
 ৯. সনদে বিক্রয়কারী ই-নিলামের নিয়ম প্রক্রিয়ায় নিয়মের মাধ্যমে স্টেটের এবং স্টেটের কোডের ধারা ২৯এ অধীনে যোগাযোগ তথ্য সহ প্রয়োজনীয় নথি প্রদান করা দিতে হবে।
