Take steps to achieve greater jointness: PM to defence min

Slow Progress In Tri-Service Integrated Theatre Commands

New Delhi: PM Narendra Modi on Monday directed the defence ministry to 'swiftly implement concrete steps' to achieve greater jointness, atmanirbharta and innovation to meet future challenges, amid the continuing differences among the Army, Navy and IAF over the creation of theatre commands for an integrated and cost-effective war-fighting machinery. Inaugurating the biennial three-day combined commanders conference (CCC) at Kolkata, the PM also reviewed the security situation and operational readiness of the armed forces in the context of the "new normal" created by Operation Sindoor, while being briefed on the future of warfare in the backdrop of emerging technology and tactics.

As per the "new normal" laid down by Modi after the strikes against Pakistan during the May 7-10 hostilities, any act of cross-border terrorism will be treated as an act of war and be met with a decisive response. "Moreover, the PM has made it clear that Pakistan's nuclear sabre-rattling will not prevent India from striking terror bases, with no

distinction being made between terrorists and their sponsors," an official said.

The PM complimented the armed forces for the success of Operation Sindoor as well as the integral role they play in nation-building, anti-piracy, safe return of Indian citizens from conflict zones and providing humanitarian assistance to friendly countries.

The CCC is being attended by defence minister Rajnath Singh, national security adviser Ajit Doval, the chief of defence staff, the three Service chiefs and other top military officers and bureaucrats.

Reviewing the defence reforms implemented over the last two years, and the plan for the next two years, the PM's main thrust was on the urgent need for jointness among the armed forces, self-reliance in defence production and innovation to en-

Will remain in NDA henceforth: Nitish to Modi

Purnea: Bihar chief minister Nitish Kumar on Monday assured Prime Minister Narendra Modi that he will remain in the NDA, while regretting short-lived alliances with the RJD-Congress combine, which "always indulged in mischief" when we shared power.

Kumar was speaking at a rally in Purnea in the presence of the announcement of assembly polls. "It was the JD(U)-BJP combine which had formed a government in Bihar, for the first time, in November, 2005. For one or two times, I went to the other side, upon prodding of some of my own party colleagues, one of whom is sitting here," said Kumar, pointing towards Union minister Rajiv Ranjan Singh 'Lalan', whom he replaced as the party's national president nearly two years ago.

"But, that is a thing of the past. I could never be comfortable with those people. They always indulged in mischief when we shared power... I am now back. And, I will not go anywhere henceforth," said the JD(U) supremo, evoking a smile and applause from the PM. Kumar lauded Modi for the measures taken by the Union govt for the state.

SC: No law violation in running Vantara, any animal smuggling

New Delhi: Based on the finding of SC-appointed SIT headed by its retired judge J Chelameswar who told the court that there had been no violation of law in running of Vantara at Jamnagar in Gujarat, the apex court on Monday not only closed the case against it but also directed that no further complaint upon same allegations shall be entertained before any judicial authority.

A bench said the SIT, whose inquiry covered the entire range of allegations—acquisition of animals, smuggling, laundering, welfare and husbandry conservation and breeding, climatic and location issues, and financial and trade improprieties etc, did not find any wrongdoing. It said the Court has no hesitation in accepting the conclusion drawn in the report which said that there was no contravention of law and there is no merit in the allegations of animal smuggling or laundering.

SC refuses to entertain plea by slain Maoist leader's kin

New Delhi: The Supreme Court on Monday refused to entertain a plea by the kin of top Maoist leader Nambala Keshav Rao, who was killed in an encounter in Chhattisgarh in May, over his handing over of his body for performing final rites.

Rao, widely known as Basavaraju, along with 26 others was killed in a fierce encounter with security forces in Chhattisgarh's Bastar region. Hailing from Andhra Pradesh, Basavaraju was considered the top leader and ideological backbone of the Naxalite movement.

ED files 7k-page prosecution complaint against Ch'garh ex-CM's son in liquor scam

Raipur: ED on Monday filed a prosecution complaint (chargesheet) in a Raipur special court in connection with the alleged Rs 2,100-crore liquor scam in Chhattisgarh, naming former chief minister and Congress leader Bhupesh Baghel's son Chaitanya Baghel as one of the accused.

The 7,039-page prosecution complaint was submitted along with a hard disk containing digital evidence and supporting documents, ED counsel Saurabh Kumar Pandey told reporters.

According to the document, Chaitanya "handled" more than Rs 1,000 crore worth of "proceeds of crime" generated through the scam and diverted a significant share into his business ventures. ED said it had gathered "solid evidence" showing Chaitanya used at least Rs 22 crore of illicit funds, including Rs 16.7 crore invested in a real estate project. "He had intermixed the pro-

ceeds of crime with his real estate firms and utilised the money in development works," the counsel said.

Chaitanya was arrested on July 18 after ED sleuths raided his Bhillai residence, which he shares with his father. The central probe agency alleged that the scam took place between 2019 and 2022 during Congress govt in the state, and resulted in a massive loss to the state exchequer while benefitting a liquor syndicate to the tune of over Rs 2,100 crore.

Bhupesh Baghel strongly refuted the charges, accusing the central govt of misusing probe agencies to target opposition leaders. "We trust the judiciary and will cooperate," he maintained. The liquor scam probe has led to the arrests of several other senior leaders and bureaucrats, including a former excise minister. The economic offences wing/anti-corruption bureau had first registered an FIR in connection with the alleged scam in Jan last year, naming 70 individuals and companies.



3 killed, 10 injured in accident in Jharkhand

Chaibasa: Three persons were killed and 10 others suffered injuries in a head-on collision between a truck and a van in West Singhbhum on Monday, police said.

The accident occurred under Hatgamaria police station area in West Singhbhum district. "All the injured were shifted to nearby hospitals, including Champua in the Jharkhand-Odisha border and Kumardungu in the district," officer-in-charge of Hatgamaria police station, Uttam Tiwary, said.
