

Sidda: Will Murthys skip national caste survey too

Says It Is Not Limited To Backward Classes

Bengaluru: "Will they skip the national caste census too," Karnataka CM Siddaramaiah said Friday days after Katja Sabha MP Sodha Murthy and her husband, Infosys founder N R Narayana Murthy declined to participate in the state's ongoing socio-economic and education survey saying they do not belong to any backward communities.

The CM wondered if they considered themselves Brahmins—Hindu deity for wisdom—and said the survey covered all communities and extended beyond caste identity. "We've said 20 times it's not a backward class survey but a survey for everyone. Merely because they are from Infosys does not mean they are all-knowing," Siddaramaiah said.

Referencing a likely caste census by the Union govt, the CM asked, "Will they refuse to cooperate?" He suggested their stance stemmed from "some misunderstanding" or "some miscommunication." In a self-factored letter, the couple has written: "We and our family will not participate in the census, and we are confirming it through this letter." The CM said both the poor and the upper caste benefit from welfare schemes. "Aren't upper caste women and those

17-year-old apprehended with ₹1.5cr hashish oil in Andhra

Hyderabad: A 17-year-old boy from Andhra Pradesh was apprehended on Friday for allegedly transporting 51 kg of hashish oil worth ₹1.5 crore, police said. It is alleged approximately 40 to 50 kg of ganja to produce 1 kg of hashish oil.

In a joint operation, deaths from the Special Operations Team (SOT), Malajajri, and Chittoor police stopped the juvenile near Ghatikar Railway Station Road, where he was acting suspiciously. A search revealed the hashish oil, packed in two polythene covers inside a single backpack. Rachakonda commissioner of police G Sudheer Babu said in a release. "The main accused from Odisha, who procured the hashish oil, is absconding. The juvenile came into contact with him, and together they hatched a plan to supply ganja and hashish oil in Hyderabad and surrounding areas for quick financial gain." The release added. HC seeks govt response on Kerala school hijab row

Kochi: The Kerala High Court on Friday sought the state govt's response to a plea by a church-run school challenging an education department directive allowing a Muslim girl to wear a hijab in class. Justice V G Arun directed the govt pleader to seek instructions on the matter and listed it for further hearing on Oct 24. St Rita's Public School, Pallarey, which filed the petition, also sought an interim stay on the directive. The court, however, declined to pass any order, noting that "no coercive steps" would be taken against the CBSE-affiliated institution. The school argued that "the individual rights of a student cannot override or be imposed upon the larger interest, discipline, and uniform regulations."

It alleged that after the student was barred from wearing the hijab her father "instigated" other parents to send their children wearing black scarves "with the ulterior motive of creating communal tension." The school further contended that the education department's directive was "illegal" and "without jurisdiction," as state officers have no authority over CBSE-affiliated, unaided minority institutions. The petitioner seeks to quash the department's notice that the state govt cannot compel the school to alter its uniform policy.

2 held from Andhra for JeM terror links

Dharmavaram: The Andhra Pradesh police have arrested two people from Uttar Pradesh and Maharashtra respectively, for their alleged links to a local terror suspect and the Pakistan terror outfit Jaish-e-Millat. Sri Satyasaee District Superintendent of Police (SP) Sushil Kumar said the arrested, Sajjad Hussain from Amroha in Uttar Pradesh and Taufeeq Akbar Shaikh from Malegaon in Maharashtra, were arrested following the intelligence gathered during the ongoing investigation into Noor Mohammad's alleged terror network linked with Jaish-e-Millat (JeM). Noor Mohammad, a radicalised chef from Sri Satyasaee district, was previously detained by Dharmavaram police for involvement in JeM-linked WhatsApp groups allegedly backed by Pakistan's Inter-Services Intelligence (ISI). Electronic gadgets and alleged jihadi propaganda material were seized. A single-barrel rifle was recovered from Hussain's residence at Jhampurva in Uttar Pradesh. Preliminary investigation revealed that the two allegedly was in contact with JeM operatives, including Talha Dhal, brother of JeM chief Maulana Masood Azhar, who is reportedly radicalising Indian youth for militant training in Pakistan. Kumar suspects that the accused might have links with remnants of the banned organisation Popular Front of India (PFI), whose former cadres are alleged to continue radical activities under the guise of social work.
