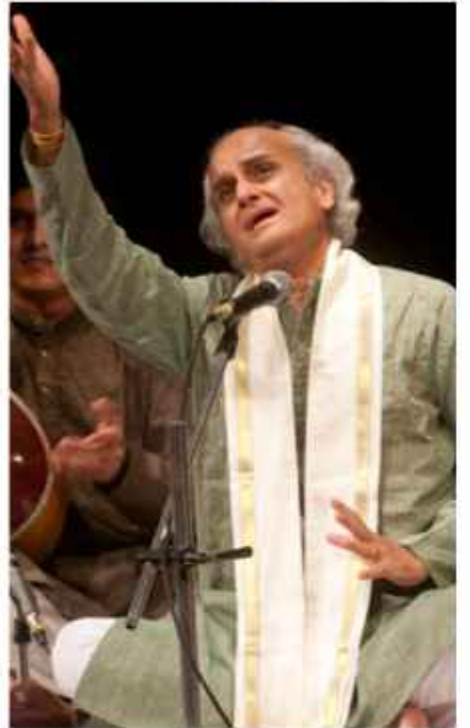

Maharashtra best state in National Water Awards

Navi Mumbai Municipal Corporation ranks first in the local self-government body category



New Delhi, Sunil Thakur :

The 6th National Water Awards (2024), given by the Department of Water Resources, River Development and Ganga Rejuvenation of the Union Ministry of Jal Shakti to encourage excellence in water conservation and water management, were announced today. Maharashtra has secured the first position in the best state category, Gujarat is second and Haryana is third. In the local government body category, Navi Mumbai Municipal Corporation has secured the first award and in the water use body category, Kanfnath Institute of Nashik district has secured the second position. Jal Shakti Minister C. R. Patil announced these awards today. The award distribution will be held on November 18 at VigyanBhawan in New Delhi in the presence of President Draupadi Murmu. On this occasion, Jal Shakti Minister Patil said that the main objective of these awards is to promote water conservation and water literacy at every level in the country. To implement the concept of 'JalSamridhi Bharat', it is necessary to recognize everyone from policy to

individual efforts. These awards are linked to the Prime Minister's 'Catch the Rain', 'Per Drop More Crop' and 'AmritSarovar' schemes, and will strengthen the policy of making India water-stress free by 2030. This year, a total of 46 institutions and individuals, including joint winners, will be honoured with awards in 10 different categories. 751 applications were received from across the country for these awards. The Central Water Commission (CWC) and the Central Ground Water Board (CGWB) conducted field visits and submitted detailed reports. After that, an independent jury selected the winners through a transparent scorecard method. The major categories of the awards include Best District, Gram Panchayat, Urban Local Body, School or College, Industry, Water User Association, Institution or Research Centre, Civil Society or NGO and Individual Contribution (Jalyoddha). The awards consist of a citation, a silver trophy and a cash prize ranging from Rs 1 lakh to Rs 5 lakh depending on the category.
