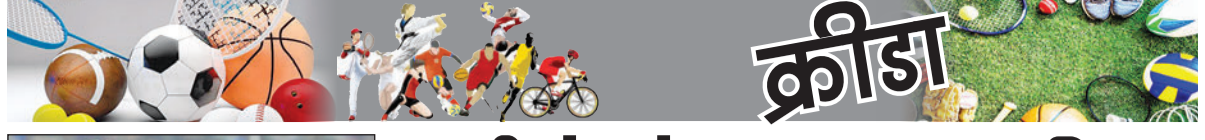
महाराष्ट्रावर अकाली अनाकलनीय आघात

नियतीचा घाला हा कित्ती अनाकलनीय असू शकतो आणि काळदेखील केव्हा कसा कृतघ्न होईल हे सांगता येत नाही. अजितदादा पवार यांचे हे अपघाती अकाली निघून जाणे हा नियती आणि काळाचा कृतघ्नपणाच म्हणावा लागतो. महाराष्ट्राला जी काही दमदार नेतृत्वाची शृंखला लाभली त्यात अजितदादा पवार हे एक कणखर आणि तितकंच सामान्यांचा जिवाळा संपादन करणारे सहृदयी व्यक्तिमत्व होते. राजकारण हे क्षेत्र नेहमीच बेभरोशाचे क्षेत्र सांगितले जाते. परंतु याच राजकारणातून सर्वसामान्यांनी भरोसा ठेवावा अशी नेतृत्व तयार होतात. अशा नेत्यांना सत्तेपेक्षाही आपण जनतेची कामे करीत आहोत आणि जनता आपल्याला भरभरून प्रेम देते आहे याचे एक मोठे भावनिक समाधान असते. किंबहुना आपल्या कामातून, कर्तृत्वातून संपादन केलेले प्रेम हाच अशा नेतृत्वासाठी सतत प्रेरणा देणारा स्रोत असतो. अजितदादांवर महाराष्ट्रातल्या कानाकोपऱ्यातल्या सामान्य माणसाने असेच प्रेम केले होते. राजकीय मतभेद कसेही असले तरीमुद्दा एक दिलदार व्यक्तिमत्व आणि सामान्यांच्या प्रश्नाला थेट भिडण्याची मनोवृत्ती ही मतभेदापेक्षाही अशा नेतृत्वाविषयी मनामध्ये एक मुस आपलेपणा निर्माण करून जाते. महाराष्ट्रातील कोट्यवधी जनतेच्या मनात अजितदादांनी आपलेपणा निर्माण केला होता. ज्यावेळी त्यांच्या या अपघाती निधनाची बातमी वाऱ्यासारखी महाराष्ट्रभर पसरली तेव्हा प्रत्येकाला आश्चर्याचा प्रचंड धक्का बसला. त्याचे महत्त्वाचे कारण म्हणजे एकतर अशा प्रकारचे अपघाती निधन आणि दुसरे म्हणजे महाराष्ट्राच्या राजकीय क्षितिजावरचे एक आश्वासक आणि प्रभावशाली नेतृत्व म्हणून महाराष्ट्र त्यांच्याकडे पाहत होता. त्यांचे इतक्या अचानकपणे निघून जाणे अनेकांना सहन करण्यापलिकडचे वाटू शकते. प्रामुख्याने गेल्या वीस-पंचवीस वर्षांचा राजकीय पटल पाहिला तर एकाअर्थी अल्पावधीत यशस्वी ठरलेलं आणि राजकारणाचा आवाकाही तितक्याच वेगाने आत्मसात केलेले अजितदादांचे एकमेव व्यक्तिमत्त्व ठरतं. राजकारणासाठी लागणारी गुणसंपदा तर त्यांच्याकडे होतीच. परंतु नेतृत्व करण्यासाठी ज्या प्रकारची तयारी असावी लागते, तीदेखील दादांनी आपल्या मेहनतीने कमवली होती.

अत्यंत काटेकोर मानले जात असत. मग पहाटे लवकर उठून आपल्या कामकाजाला सुरुवात करण्यापासून ते दिवसभरासाठी ठरलेल्या कामांचा तितक्याच वेगाने आणि क्रमाने निपटारा करण्यापर्यंत त्यांचा झपाटा अनेकांनी अनुभवला होता. लोकांची कामं वेळेत झाली पाहिजेत. मग कटाक्षाने वेळ पाळणाऱ्या या नेत्यावर काळाने असा घाला घालावा याच्याइतके दुसरे दुःख नाही. राजकारणात राहून अशा प्रकारची शिस्ताने जनहिताची कामे करणारे नेते दुर्मिळ असतात. आणि ही गोष्ट खरीच आहे की, देशासाठी लढणारा सैनिक तयार करण्यासाठी बरीच वर्षे घालवावी लागतात. अगदी त्याच पद्धतीने जनहितासाठी समर्पित असलेलं नेतृत्व तयार होण्याकरीता बराच मोठा कालावधी लागत असतो. वरकरणी राजकारणात सत्ता, अधिकार आणि सुखसोयी जरी दिसत असल्या तरी बारा ते सोळा तास सतत लोकांच्या गराड्यात राहून आणि राज्याच्या हितासाठी परिश्रम किंवा मेहनत करण्याची सवय अंगी बाणवावी लागते. अजित पवारांनी ती सवय अंगी बाणवली होती. आणि तितक्याच काटेकोरपणे ही सवय ते अंमलातही आणत होते. त्यांना लोक आदराने जरी दादा म्हणत असले तरी त्यांचा कामाचा वेग आणि निर्णयक्षमता तितकीच आगळ्यावेळच्या स्वरूपाची होती. ज्यावेळी ही कामे वेळच्या वेळी पूर्ण होतात, त्याचवेळेला त्या कामांवरची पकड ही दादा या विशेषनामाला लौकिक प्राप्त करून देते.

अपेक्षा वाढवणारे व्यक्तिमत्त्व

या अपघाताचा महाराष्ट्राला मोठा धक्का बसला आहे. यातून सावरण्यासाठी बराच मोठा कालावधी जाईल. या सगळ्या प्रकरणाच्या अनेक गोष्टींची उकल होण्यासाठीदेखील कालावधी लागू शकतो. अपघाताबाबत नेहमीच तांत्रिक बिघाड किंवा चुकांची कारणे सांगितली जात असतात. परंतु पुढच्या अवघ्या तीन साडेतीन मिनिटांत लँडिंग होणाऱ्या विमानाचा अपघात होतो. धुक्यामुळे हा प्रकार घडला असण्याची शक्यता व्यक्त होते आहे. परंतु ज्या कंपनीचे विमान होते, त्या कंपनीचा गेल्या तीन वर्षांतील दुसरा अपघात आहे. स्वाभाविकपणे अशा विमानांची देखभालही आता तपासाच्या कक्षेमध्ये येते. आणि ती तपासलीही गेली पाहिजेत. या विमानात दोन महिला आणि सिक्युरिटीच्या अन्य दोघांचाही मृत्यू झाला आहे. अत्यंत गंभीर स्वरूपाची ही घटना असल्याने या संदर्भातील नेमकी कारणेदेखील तितक्याच गांभीर्याने शोधली गेली पाहिजेत. हा भलेही एक अपघात असू शकेल. परंतु महाराष्ट्रात नेतृत्वाची मोठी पोकळी निर्माण करणारा तितकाच मोठा आघात आहे. महाराष्ट्र तर शोकाकुल वातावरणात आहेच. परंतु लाखो अनुयायांशी अगदी घरोब्याचे संबंध निर्माण करणारे किंबहुना राजकारणाच्या पलिकडे जाऊन दादा नावाचे एक अतूट नाते त्यांनी निर्माण केले होते. स्वाभाविकपणे अनेकांच्या मनातील हे वेदनादायक दुःख सांतवण करण्यापलीकडचे आहे. संघर्षाला सामारे जाऊन समन्वयाची भूमिका घेऊन संयमाने दादांविषयी महाराष्ट्राच्या अपेक्षा उंचावल्या होत्या म्हणूनच त्यांचे हे अकाली निघून जाणे अनाकलनीय ठरते.



न्यूझीलंड संघाचा भारतावर विजय शिवम दुबेची वादळी खेळी वाया



सलामीवीर संजू सॅमसन मोठी खेळी करण्यात पुन्हा अपयशी

शिवम दुबेने २३ चेंडूंत ७ षटकार आणि ३ चौकारांसह ६५ धावा करून देखील भारतीय संघाला न्यूझीलंडकडून ५० धावांनी पराभव पत्करावा लागला. विशाखापट्टणममध्ये झालेल्या पाच टी-२० मालिकेतील चौथ्या सामन्यात न्यूझीलंडने भारतीय संघासमोर २१६ धावांचे मोठे आव्हान ठेवले होते. या आव्हानाचा पाठलाग करताना भारतीय संघाची १०.३ षटकांत ५ बाद ८२ धावा अशी अवस्था झाल्यानंतर शिवम दुबेने जोरदार फटकेबाजी केली. शिवम दुबे अनपेक्षित धावचिंत झाला. सर्व सामन्यातील हवाच निघाली आणि भारतीय संघ सर्वदबा २१६ धावा करू शकला.

आणि सात षटकार ठोकले. त्यामुळे सामन्यात रांगत आली. मात्र हर्षित राणाने टोलावलेला चेंडू गोलंदाजाच्या हाताला लागून स्टम्पला लागला आणि शिवम दुबे (६५ धावा) धावचिंत झाला. सामन्याची हवाच निघून गेली. त्यानंतर आलेल्या फलंदाजांना फारसे काही करता आले नाही. परिणामी भारताने १८.४ लापून स्टम्पला लागला आणि शिवम दुबे (६५ धावा) न्यूझीलंडने ५० धावांनी धावचिंत झाला. सामन्याची हवाच निघून गेली.
