- Legal Disclosure**-The property was earlier attached by the Directorate of Enforcement but released by the Hon'ble NCLT, Mumbai Bench vide order dated 18.03.2025 in IA 4769/2024 in C.P. (IB)/1967(MB)/2019.
- The Enforcement Directorate has challenged the order before the Hon'ble Bombay High Court in W.P. (L) No. 21670 of 2025 related to ECIR/MBZ0-1/01/2022. The matter is sub judice.
