Jailor hangs us, we'll sing only two stanzas: Karnataka Cong chief on Vande Mataram

New Delhi, 18 August

Karnataka Pradesh Congress Committee (KPCC) President B K Hariprasad (*photo*) on Tuesday, strongly defended the Congress' position amid allegations that former Congress President Sonia Gandhi had stopped the national song from being sung during an Independence Day event. He said: "Even if they (Union government) send us (Congress workers) to jail or hang us, we will sing only two stanzas of *Vande Mataram*."

Speaking to reporters in Delhi, Hariprasad dismissed the allegations as part of a "conspiracy and cunning scheme" by the Rashtriya Swayamsevak Sangh (RSS) and the Bharatiya Janata Party (BJP), and said Sonia Gandhi had only objected to the manner in which *Vande Mataram* was being sung.

"Sonia Gandhi pointed out that *Vande Mataram* was being sung incorrectly and insisted that it should be sung



properly. At the same time, AICC President Mallikarjun Kharge is 84-years-old and has problems with his legs and cannot stand for a long time. She asked for a chair for him," he said.

He questioned the BJP and RSS over their criticism of the incident and challenged them to explain how often they sing *Vande Mataram* and the national anthem after singing the RSS prayer *Namaste Sada*

Vatsale. "They (RSS) were anti-nationals when the freedom struggle was going on. We need not learn from them about whether to sing a particular song or not," Hariprasad said.

Responding to questions about a purported video in which Congress leader Rahul Gandhi is allegedly heard saying that the party would not sing *Vande Mataram*, the KPCC President said he had not heard the remarks.

However, he made the Congress' position clear, saying: "As a Congress party worker and State party President, I want to clearly convey that we will sing only two stanzas. Let them (BJP) put us in jail or hang us, let them do whatever they want."

Hariprasad said the country's freedom fighters had made sacrifices that gave the nation its freedom, national anthem and *Vande Mataram*.

He said slogans such as *Azad Hind Zindabad*, *Vande Mataram* and *Inquilab Zindabad* were part of the freedom struggle and questioned whether the BJP and RSS had adopted even one of those slogans. "We need not learn from those who joined hands with the British and worked against the freedom movement," he added. When asked about his visit to Delhi, he said the Congress high command had appointed observers for every district to spend time with local party workers and submit reports on strengthening the organisation.

"All of them have submitted their reports. I have been called to Delhi to discuss these reports," he added.

On the killing of three alleged poachers in the Hanur forest encounter, Hariprasad said a magisterial inquiry had already been ordered.

"This incident should not have happened, but it has happened. A magisterial inquiry has already been ordered. After the inquiry, we will see the outcome and take further action," he added.

TVK government will not allow projects harming fishermen, environment: TN minister Dr V K Rajeev

The Tamilaga Vettri Kazhagam (TVK) government will never allow any project that adversely affects the interests of fishermen or the environment, Tamil Nadu Minister for Environment and Climate Change Dr V K Rajeev (*photo*) declared in the State Assembly on Tuesday.

The Minister was replying to concerns raised by several members on a Special Calling Attention Motion taken up on the environmental impacts caused by setting up of development wells by Hindustan Oil Exploration Company

Limited (HOEC) at Parangipettai in Cuddalore district of the State. During the discussion, Thamimun Ansari of Manithaneya Jananayaga Katchi urged the government to reject the HOEC's proposal to establish a hydrocarbon well at Parangipettai. He said local residents had been continuously protesting against the proposed drilling of four new wells, citing its possible impact on the livelihood of fishermen and the marine environment.

He also urged the government to conduct a detailed assessment of the environmental consequences and reject the proposal if it posed a threat to the region.

CPI member Marimuthu said hydrocarbon projects could affect marine resources along the entire coastal stretch from Pudukcherry to Kanniyakumari.

In his reply, Rajeev said permission had been given for three wells during the previous DMK regime and for another one during the AIADMK regime. Pointing out that the company has submitted another proposal to establish a well to the Coastal Zone Management Authority on 1 June, he categorically stated that the TVK government would not permit projects that adversely affect fisheries or the environment. "The TVK government will not allow any project that affects fishermen or the environment. We will take action without compromising on protecting the livelihood of fishermen," Rajeev said.

Responding to the Minister, Thamimun Ansari said earlier governments might have granted permissions at a time when environmental awareness was not as widespread as it was today.

Madras HC questions challenge to pardon for 21 AIADMK MLAs

The Madras High Court on Tuesday questioned what was wrong in dropping the disqualification proceedings against 21 AIADMK MLAs after they were pardoned by the party for defying the whip and voting in favour of the TVK government in the Tamil Nadu Assembly during the 13 May confidence vote.

The case was heard by the First Bench comprising Chief Justice Sushrut Arvind Dharmadhikari and Justice G. Arul Murugun on a PIL filed by advocate Selvakumar challenging Speaker JCD Prabhakar's decision to drop the disqualification proceedings against the 21 MLAs.

The issue arose after 25 'Rebel' AIADMK MLAs violated the whip and voted in favour of the TVK government

during the confidence vote on 13 May. AIADMK general secretary Edappadi K. Palaniswami had subsequently sought disqualification action against them. Of the 25 MLAs, four later resigned and joined the ruling TVK headed by Chief Minister Vijay. The remaining 21 'Rebels' later expressed regret and tendered apology in writing. Following this, Palaniswami wrote to the Speaker withdrawing his plea to initiate disqualification proceedings against the 21 legislators. The Speaker accepted the request and dropped the proceedings, while initiating it against the four others, who had since quit the AIADMK.

When the PIL was taken up for hearing, the petitioner's counsel argued that political parties had no power to pardon legislators who had defied a whip and voted against the party's stand.

Major fire breaks out at furniture godown in Rajanna Sircilla district:

Rajanna Sircilla: A major fire broke out at Mahalakshmi Furniture godown on the outskirts of Pedduru in Rajanna Sircilla district on Tuesday morning, reportedly due to a short circuit. After locals alerted the fire department, personnel rushed to the spot with three fire engines and battled the blaze for more than three hours before bringing it under control. A worker from Uttar Pradesh, who was sleeping inside the shop, died in the incident. DSP Nagendra Chari visited the scene and inspected the situation.
