

HC: Maintain peace, have faith in Constitution

Judge: Constitution Is My Bhagwad Gita

Bengaluru: The Karnataka high court, which started hearing arguments on Tuesday on a batch of petitions against the hijab ban in classrooms in the state, has requested students and the public to maintain peace and

tranquility in the state.

"This court has full faith in the wisdom and virtue of the public at large. It hopes the same is put to practice," Justice Krishna S Dixit observed in a brief order while adjourning the hearing to Wednesday afternoon.

The judge said that when the matter is before court, people should have faith in the Constitution. He added that the matter should be left to the judges to adjudicate in

a calm atmosphere. "When I was a student, such things never happened. If it had hap-

pened, I'd have stayed away from college," the judge said. Earlier, advocate general (AG) Prabhukumar Navagi submitted that as per instructions received by him from

MP minister backs hijab ban in schools

Bhopal: Madhya Pradesh school education minister Indar Singh Parmar walked into the hijab controversy on Tuesday by backing a ban on campus, but suggested that the Karnataka issue shouldn't be politicised. "We are working on a school uniform code, which will be implemented before the next academic session," Parmar said on Tuesday.

Asked about the hijab, he said: "Hijab is not a part of the school uniform and I think it should be banned. The school education department will hold a review to see if it is happening in MP also. We will take a decision on the ban after that."

A uniform is meant to bring about uniformity among students, he argued.

"Uniform creates discipline among students. Schools will be asked to follow the uniform code from the next session," said Parmar, adding that the hijab issue in Karnataka should not be politicised.

Oppn stages walkout in LS over hijab row

New Delhi: A day after Congress MP TN Pratap Singh said in Lok Sabha that a Muslim woman's 'hijab' is a cultural and religious marker just like "the mangalsutra" for Hindus, the crucifix for Christians, and turbans for Sikhs, opposition parties including Congress, DMK, JUM, JPM, CPI, VCK, MDMK and JMM on Tuesday demanded the government make a statement in the House on its position on the issue.

After the opposition's protests failed to elicit a response from the treasury benches, the parties walked out of the Lok Sabha to register their protest.
