At your request, Bank through its Ganaihat Branch, sanctioned Rs. 3.00 Cr. for Logistics under Sole banking arrangements to the M/s. Savitri Logistics where 1st is Borrower Firm, 2nd is Proprietor and 3rd is Guarantor of the Firm and executed documents / agreements.
Borrower has defaulted in meeting its payment / repayment obligations to the Bank as per terms of sanction.
