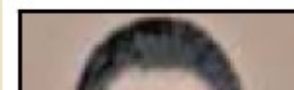

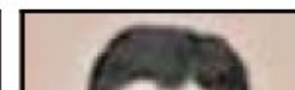
28 August 1991

On 28th August 1991, the 11th Battalion of CRPF, deployed in Punjab for anti-terrorist operations, was escorting a State Minister in Chandigarh when terrorists ambushed them with an IED blast followed by indiscriminate fire. The troops swiftly retaliated. In the blast, Shaheed Constable P. A. Reddy sustained severe injuries but continued to fight alongside his fellow troopers. He succumbed to his injuries on August 30th, attaining martyrdom. His selfless sacrifice and courage remain a lasting
