**Water level in Mullaperiyar dam stands at 116.55 feet**

Water level in Mullaperiyar dam on Thursday stood at 116.55 feet (maximum permissible level is 142 ft.) with an inflow of 53 cusecs and a discharge of 256 cusecs. In Vaigai dam, the level was 54.23 ft. (71 ft.) with an inflow of 222 cusecs and a discharge of 72 cusecs. Combined storage in Periyar credit was 3,582 mcf.

**Change in train services due to maintenance**

In connection with maintenance works taken up by Tiruchi Division, a few changes are made in train services. Train No. 16106 Tiruchendur-Chennai Egmore Express, starting on April 1 to 20 (20 days) will be regulated for 65 minutes between Alapakkam and Pudukhachalam, a statement said. Train No. 20973 Ajmer-Rameswaram Express leaving Ajmer on April 1, 8, 15 and 22 (4 days) will be diverted via Villupuram, Cuddalore Port Junction and Vriddhachalam. Train No.16127 - Chennai Egmore-Guruvayoor Express leaving Chennai Egmore on April 19 and 22 (2 days) will be diverted via Villupuram, Cuddalore Port Junction and Vriddhachalam. Meanwhile, Train No. 12687/12688 Madurai-Chandigarh-Madurai bi-weekly express have been provided stoppage at Chandrapur (Maharashtra) on experimental basis for a period of six months with immediate effect.

**A** temporary facility for Research and Development for Firecrackers Compositions and Emission (RACE) has been set up at AAA College here for emission and noise test-

ing of fireworks products manufactured by fireworks units. The facility, set up by CSIR-NEERI, was inaugurated by Virudhunagar Collector V.P. Jayaseelan and Director, CSIR-NEERI, Atul N. Vaidya, on Thursday. The Collector said the new facility would help in

reducing pollution due to bursting of crackers and also be an impetus to the development of the industry. Mr. Vaidya said the objective of the facility to ensure that green crackers, which emitted lesser emission, were produced. The fireworks manufacturers had hereto been go-

ing all the way to Nagpur for testing, Mr. Vaidya added. Chief Scientist, CSIR-NEERI, Sadhana Rayalu, said those products that cleared the testing would be given green cracker certificate and QR code which would provide recognition to the fireworks manufac-

turer for producing green crackers. Tamil Nadu Fireworks and Amores Manufacturers Association president P. Ganesan said a permanent building for RACE facility was under construction near Sivakasi. It was likely to be commissioned by July.

Till then, the manufacturers could use the temporary facility which could test five products in a day. General secretary of The Indian Fireworks Manufacturers Association (TIFFMA) T. Kannan and college principal M. Sekar among others were present.

**New bus stands for Srirangam, Dindigul and Nagercoil**

The government will develop new bus stands in the municipal corporations of Dindigul, Nagercoil and Tiruchirappalli (Srirangam), said Municipal Administration and Water Supply Minister K.N. Nehru.

Presenting the demand for grants for the Municipal Administration and Water Supply Department, he said municipalities such as Nagapattinam, Mangadu, Srivilliputhur, Komarapalayam, Aranthangi, Pudukkottai, Tiruvarur, Ulundurpet and Padmanabhapuram would

also get new bus stands at a total cost of ₹174 crore. Existing bus stands in municipalities such as Mettupalayam, Perambalur, Sirkazhi, Thiruthurai, Karaikudi, Kayalpatinam, Kuzhithurai, Rasipuram, Senkottai, Mathuranthakam, Thiruvathipuram and Coonoor

will be renovated at a cost of ₹42.8 crore. A total of 25 crematoriums will be developed in urban local bodies in the State at an estimated cost of ₹52.5 crore, Mr. Nehru said. The government will implement a policy to develop modern crematoriums in all urban

local bodies in the State, he added. Crematoriums in municipal corporations, such as Madurai, Salem, Nagercoil, and Tambaram, and municipalities, such as Oddanchatram, Thirumangalam, Tenkasi, Palani, Kambam, Usilampati, Devakottai and Puliangudi, will be moder-

nised at a cost of ₹8.5 crore, Mr. Nehru said. The government will develop 100 parks in urban local bodies at an estimated cost of ₹60.9 crore. Work on development of 307 parks has been taken up at a cost of ₹111.02 crore in the past two years, the Minister said.
