Polytechnics, ITI students to be included in Naan Mudhalvan scheme

Chennai, Apr 4: More than three lakh students, including nearly two lakh from government polytechnics and 80,000 from self-financing institutions besides around 35,000 students from ITIs are expected to benefit.

“For ITI (students), we are giving industry exposure and offer communicative skills,” said Innocent Divya, managing director of the Tamil Nadu Skill Development Corporation. The proposed investment of Rs. 2,880 crore to

improve ITIs will help develop them as hubs for polytechnic and engineering colleges that do not have the facilities.

The Higher Education Department is investing in building centres of excellence in all government engineering colleges, Minister K. Ponnudiy had said in his reply to the debate on the budget for his department.

The constituent colleges of Anna University are already part of the scheme and students of second, third

and final years and being trained. “The government will provide training to faculty members, who in turn will train the students. Our placement coordinator has begun the process,” said a government college principal.

Funds will be allocated to set up Centre of Excellence for advanced manufacturing in all government engineering colleges, the Minister had announced. The centre will include “non-conventional manufacturing

machinery” such as rapid prototyping technology, 3D manufacturing technology, innovation centres, besides improved manufacturing technologies in collaboration with small and medium scale industries, Mr. Ponnudiy said. Computer numerical control machines for improved production has been proposed.

An official involved in polytechnic education said polytechnic colleges had been given some amount for machinery and equipment in the past year. The polytechnic colleges await the approval of the All India Council for Technical Education, which was expected soon.

“We have been assured of syllabi revision and are looking forward to an increase in the remuneration for part-time teachers,” said a polytechnic educator.

Finland joins NATO, Russia beefs up border security

Moscow, Apr 4: Russia will strengthen its military potential in the western and northwestern direction in response to Finland's accession to NATO, Russian Deputy Foreign Minister Alexander Grushko told Sputnik on Monday.

Earlier in the day, NATO head Jens Stoltenberg said that Finland will officially join NATO on April 4. The office of Finnish

President Sauli Niinistoe later confirmed the same.

“Part of the measures have already been announced. We will strengthen our military potential in the western and northwestern direction. In the event of forces and assets of other NATO members being deployed in Finland, we will take additional steps to reliably ensure Russia's military security,” Grushko said.

“This is a historic

week. Tomorrow, we will welcome Finland as the 31st member of NATO,” Stoltenberg told reporters ahead of a ministerial meeting in Brussels, adding that the alliance “will raise the Finnish flag for the first time ... at the headquarters.”

Ukraine support Meanwhile, NATO Foreign Ministers will discuss a multi-year support programme for Ukraine at a meeting from April 4-5, NATO Secretary General Jens Stoltenberg said on Monday.

“Our support is for the long haul, so I

expect that Ministers will agree to start work on developing on a multi-year support programme for Ukraine,” Stoltenberg said at a press conference ahead of the ministerial meeting.

NATO wants to discuss with Ukraine not only urgent military support, but also reforms, the fight against corruption and the rights of national minorities, the alliance's head added.

New Delhi, Apr 4: External Affairs Minister S. Jaishankar called on visiting Bhutanese King Jigme Khesar Namgyel Wangchuck on Monday evening, and said the King's vision for strengthening the unique partnership with India is deeply appreciated. In a tweet, he said: “Deeply privileged to call on His Majesty the King of Bhutan today evening.

“His Majesty's vision for Bhutan's future and for strengthening the unique partnership with India is deeply appreciated.” Earlier, the EAM had received the Bhutanese king at the airport as he arrived on a three-day official visit.

In a tweet on welcoming the Bhutan King, EAM said the visit would further strengthen the close and unique India-Bhutan partnership.

“Honoured to welcome His Majesty the King of Bhutan, Jigme Khesar Namgyel Wangchuck, on his arrival in India.

“His visit will further strengthen the close and unique India-Bhutan partnership.” Ministry of External Affairs spokesperson Arindam Bagchi in a tweet said: “Warm welcome to

India, Your Majesty! “His Majesty the King of Bhutan, Jigme Khesar Namgyel Wangchuck arrived in India a short while ago. His Majesty was received by EAM @DrSJaishankar at the airport.” Bhutan King Jigme Khesar Namgyel Wangchuck, who is visiting India on the invitation of President Droupadi Murmu, will hold talks with Prime Minister Narendra Modi on Tuesday morning.

On Tuesday morning, after a wreath-laying ceremony at Rajghat, the Bhutan King will meet Prime Minister Modi at his 7, Lok Kalyan Marg

official-residence.

He will meet President Murmu the same evening at Rashtrapati Bhavan, and depart on Wednesday early morning.

The Bhutanese King is accompanied by Foreign Minister Tandi Dorji, and senior officials of the Royal Government of Bhutan.

The visit of the King of Bhutan is in keeping with the long-standing tradition of regular high-level exchanges between the two countries, an

official statement said.

India and Bhutan enjoy unique ties of friendship and cooperation, which are characterized by understanding and mutual trust.

The visit would provide an opportunity to both the sides to review the entire gamut of bilateral cooperation and to further advance the close bilateral partnership, including economic and development cooperation, the statement said.
