**CBI summons TVK chief Vijay on March 15 in Delhi over Karur stampede case**

CHENNAI : The Central Bureau of Investigation (CBI), on Tuesday, summoned actor-turned-politician and Tamilaga Vettri Kazhagam (TVK) Chief Vijay to appear before its officials in New Delhi on March 15 in connection with the Karur stampede case that claimed 41 lives during a party event held last year.

Confirming the development, TVK Joint General Secretary C.T.R. Nirmalkumar said the party had received fresh summons from the CBI earlier in the day asking Vijay to present himself for questioning in the national capital.

The summons is part of the ongoing probe into the tragic stampede that occurred on September 27, 2025, during a massive rally addressed by Vijay in Tamil Nadu's Karur.

The incident led to the deaths of 41 people and left more than 60 others injured, triggering widespread criticism and calls for accountability over crowd management at the political event. According to party sources, Vijay had earlier been asked to appear before the CBI on March 10. However, the TVK leadership sought a 15-day extension, citing prior commitments. The party had also requested the central agency to record his statement.

**Cabinet approves changes in investment guidelines for countries sharing land border with India**

NEW DELHI : The Union Cabinet, chaired by Prime Minister Narendra Modi, on Tuesday approved changes in the guidelines governing investments from countries that share land borders with India, aiming to provide clarity to investors and boost foreign direct investment (FDI) flows.

The government said the existing policy has been reviewed and amended to introduce clearer rules on determining the 'beneficial owner' of an investment and to streamline approvals in certain sectors.

Under the revised guidelines, the definition and criteria for determining a beneficial owner will now align with the framework used under the Prevention of Money Laundering Rules, 2005. The beneficial owner-



ship test will be applied at the level of the investor entity.

According to the government, investors from land border countries with non-controlling beneficial ownership of up to 10 per cent will now be allowed to invest

through the automatic route, subject to sectoral caps and other conditions.

However, such investments will require the investee company to report the relevant details to the Department for Promotion of

Industry and Internal Trade.

The Cabinet also approved faster processing of investment proposals in specific manufacturing sectors.

Investments from land border countries in areas such as capital goods manufacturing, electronic capital goods, electronic components, polysilicon and ingot-wafer production will now be processed and decided within 60 days.

The list of these specified sectors can also be revised by the Committee of Secretaries headed by the Cabinet Secretary.

In such cases, the government said that majority shareholding and control of the investee company will remain with resident Indian citizens or entities owned and controlled by them at all times.

The move comes as part of a review of the restrictions introduced during the COVID-19 period through Press Note 3 (2020).

That policy had mandated that entities from countries sharing land borders with India, or where the beneficial owner was from such countries, could invest in India only through the government approval route.

The measure was originally introduced to prevent opportunistic takeovers of Indian companies during the pandemic.

However, the government later found that the rules were also affecting investment flows from global private equity and venture capital funds where investors from these countries held only small, non-controlling stakes.

**Madurai Airport's declaration as international airport to boost tourism, trade: PM Modi**



CHENNAI : The Union Cabinet, chaired by Prime Minister Narendra Modi, on Tuesday, approved the declaration of Madurai Airport in Tamil Nadu as an international airport, a move expected to significantly enhance connectivity and economic prospects in southern parts of the state.

Announcing the decision on social media platform X, the Prime Minister said: "The Union Cabinet has approved the declaration of Madurai Airport as an international airport. This will boost tourism, trade and economic opportunities, especially across southern Tamil Nadu. Madurai, known for its timeless culture and spiritual heritage, is set to strengthen

its global connectivity."

According to a statement released by the Union government, Madurai Airport -- located in the historic temple city of Madurai -- is among the oldest airports in Tamil Nadu and plays a vital role as a key gateway to the southern districts of the state.

The airport has long served as an important hub for domestic air travel connecting cities across India.

The elevation of the airport to international status is expected to strengthen regional connectivity and create new opportunities for tourism, pilgrimage travel and business activity.

Madurai is home to the world-renowned Meenakshi

Amman Temple and attracts millions of pilgrims and tourists each year.

Officials said that international status for the airport will further boost visitor inflow, not only to Madurai but also to other tourist destinations across southern Tamil Nadu. The state government noted that the move would encourage greater trade and investment while improving access for global travellers. Enhanced connectivity is also expected to support economic development in the region by facilitating faster movement of people and goods.

Industry observers say the decision could lead to the launch of direct international flights to destinations in Southeast Asia and the Middle East, which have significant Tamil diaspora population.

This would reduce travel time for passengers from southern districts, who currently depend on airports in Chennai, Tiruchirappalli (Tamil Nadu) or Thiruvananthapuram (Kerala) for many international connections.

The announcement has also drawn attention in the

political arena as Prime Minister Modi is scheduled to visit Tamil Nadu on March 11 to attend an NDA election campaign rally in Tiruchirappalli. The Union Cabinet decision and the Prime Minister's post on social media platform X regarding Madurai Airport have generated considerable

public and political interest across the state. With its elevation to international status, Madurai Airport is expected to emerge as a major aviation hub for southern Tamil Nadu, strengthening the region's connectivity with global destinations while supporting tourism, trade and economic growth.

**Govt fully committed to protecting Aravalli range, says Environment Minister Bhupender Yadav in RS**

NEW DELHI : Union Minister for Environment, Forest and Climate Change Bhupender Yadav on Tuesday reaffirmed the government's strong commitment to protecting the Aravalli Range while responding to a discussion in the Rajya Sabha.

During the debate on the functioning of his ministry, Yadav said that the Supreme Court of India had positively acknowledged the ministry's Green Aravalli Project in its recent decision. He noted that the initial paragraphs of the court's judgment praised the government's initiative and recognised its efforts, while also advising continued vigilance in protecting the mountain range. The minister was responding to remarks made by a member of Congress regarding the Aravalli range and the Supreme Court's observations. Taking a swipe at the opposition, Yadav said that in the past, court rulings during previous governments often raised questions about their efficiency. However, he emphasised that the recent judgment acknowledged the government's efforts to conserve the Aravalli region. "I want to make it clear that we are fully committed to the conservation of the Aravalli mountain range. If the court requires any positive assistance from the government in this matter, we are ready to extend complete cooperation," he said. Yadav also mentioned that the Supreme Court had suggested the formation of a High-Power Committee (HPC) to monitor conservation efforts. He stated that the government's approach towards this proposal is entirely positive and that it will fully comply with the court's directions. Highlighting ongoing initiatives, the minister said the government has already launched the Aravalli Green Wall Project aimed at restoring and protecting the ecosystem of the Aravalli region. Conservation work is being initiated across 29 districts.

**'Suddenly they respect Nehru': Priyanka Gandhi takes swipe at BJP in Lok Sabha**

NEW DELHI : Congress MP Priyanka Gandhi Vadra on Tuesday took a swipe at the ruling party in the Lok Sabha, saying it was ironic that leaders who frequently criticise India's first Prime Minister Jawaharlal Nehru were now quoting him in support of their arguments.

Speaking during a debate on a resolution seeking the removal of Om Birla as Speaker, Priyanka Gandhi said she found it amusing that those who regularly attack Nehru had suddenly begun praising him for strengthening India's democracy. "I was laughing today because the person whom they criticise every day - Nehru ji - they are quoting the same person today. Suddenly, they have.

**India gaining more weight as stable and wise actor in all circumstances: Italian envoy**

NEW DELHI : Italy's Ambassador to India, Antonio Bartoli on Tuesday highlighted the urgent need to end the ongoing conflict in West Asia, stating that both India and Italy are on the same page and continue to bat for holding a dialogue to stop the war as soon as possible. Speaking to IANS, Bartoli said that it was important that the conflict in West Asia ends soon to ensure the regularity and stability of energy resources at reasonable prices. "Italy and India have the same priorities in this war, which is to encourage the parties to de-escalation, diplomatic dialogue, pacification, so to stop the war as soon as possible. Second, we are taking care, as you are doing, of thousands of Italian fellow nationals in the Gulf region and abroad. Also here, you know, 1,500 tourists were stuck in Maldives, for example. So, we are not only talking about the theatre of war. And third, it is important to end this as soon as possible to ensure the regularity and stability of energy at reasonable prices. We don't want to see oil above \$100 per barrel and so we are working for this," Bartoli told IANS.

Oil prices declined sharply on Tuesday, trading below \$90 per barrel after US President Donald Trump predicted the war in the Middle East could end soon. Trump also cautioned Iran against attempting to disrupt global energy supplies through the Strait of Hormuz, one of the world's most critical oil shipping routes. Bartoli said that India is gaining more weight in the international arena as a stable and wise actor in all circumstances. He also mentioned about the recent telephonic conversation between External Affairs Minister (EAM) S Jaishankar and his Italian counterpart Antonio Tajani.

**CBI summons TVK chief Vijay on March 15 in Delhi over Karur stampede case**

CHENNAI : The Central Bureau of Investigation (CBI), on Tuesday, summoned actor-turned-politician and Tamilaga Vettri Kazhagam (TVK) Chief Vijay to appear before its officials in New Delhi on March 15 in connection with the Karur stampede case that claimed 41 lives during a party event held last year.

Confirming the development, TVK Joint General Secretary C.T.R. Nirmalkumar said the party had received fresh summons from the CBI earlier in the day asking Vijay to present himself for questioning in the national capital.

The summons is part of the ongoing probe into the tragic stampede that occurred on September 27, 2025, during a massive rally addressed by Vijay in Tamil Nadu's Karur.

The incident led to the deaths of 41 people and left more than 60 others injured, triggering widespread criticism and calls for accountability over crowd management at the political event.

According to party sources, Vijay had earlier been asked to appear before the CBI on March 10.

However, the TVK leadership sought a 15-day extension, citing prior commitments. The party had also requested the central agency to record his statement in Chennai instead of requiring him to travel to New Delhi.

This is the third time the CBI has asked the actor-politician to appear before it in connection with the Karur stampede case.

Vijay had earlier appeared before investigators on January 12 and January 19 this year, during which the officials questioned him about the arrangements and planning related to the public rally where the fatal stampede occurred. Meanwhile, the central agency has also summoned V. Senthilbalaji, a DMK legislator from Karur and former Tamil Nadu Minister, to appear before it for questioning on March 17.

**Cabinet approves changes in investment guidelines for countries sharing land border with India**

NEW DELHI : The Union Cabinet, chaired by Prime Minister Narendra Modi, on Tuesday approved changes in the guidelines governing investments from countries that share land borders with India, aiming to provide clarity to investors and boost foreign direct investment (FDI) flows.

The government said the existing policy has been reviewed and amended to introduce clearer rules on determining the 'beneficial owner' of an investment and to streamline approvals in certain sectors.

Under the revised guidelines, the definition and criteria for determining a beneficial owner will now align with the framework used under the Prevention of Money Laundering Rules, 2005. The beneficial owner-



ship test will be applied at the level of the investor entity.

According to the government, investors from land border countries with non-controlling beneficial ownership of up to 10 per cent will now be allowed to invest

through the automatic route, subject to sectoral caps and other conditions.

However, such investments will require the investee company to report the relevant details to the Department for Promotion of

Industry and Internal Trade.

The Cabinet also approved faster processing of investment proposals in specific manufacturing sectors.

Investments from land border countries in areas such as capital goods manufacturing, electronic capital goods, electronic components, polysilicon and ingot-wafer production will now be processed and decided within 60 days.

The list of these specified sectors can also be revised by the Committee of Secretaries headed by the Cabinet Secretary.

In such cases, the government said that majority shareholding and control of the investee company will remain with resident Indian citizens or entities owned and controlled by them at all times.

The move comes as part of a review of the restrictions introduced during the COVID-19 period through Press Note 3 (2020).

That policy had mandated that entities from countries sharing land borders with India, or where the beneficial owner was from such countries, could invest in India only through the government approval route.

The measure was originally introduced to prevent opportunistic takeovers of Indian companies during the pandemic.

However, the government later found that the rules were also affecting investment flows from global private equity and venture capital funds where investors from these countries held only small, non-controlling stakes.

**Madurai Airport's declaration as international airport to boost tourism, trade: PM Modi**

CHENNAI : The Union Cabinet, chaired by Prime Minister Narendra Modi, on Tuesday, approved the declaration of Madurai Airport in Tamil Nadu as an international airport, a move expected to significantly enhance connectivity and economic prospects in southern parts of the state.

Announcing the decision on social media platform X, the Prime Minister said: "The Union Cabinet has approved the declaration of Madurai Airport as an international airport. This will boost tourism, trade and economic opportunities, especially across southern Tamil Nadu. Madurai, known for its timeless culture and spiritual heritage, is set to strengthen its global connectivity."

According to a statement released by the Union government, Madurai Airport -- located in the historic temple city of Madurai -- is among the oldest airports in Tamil Nadu and plays a vital role as a key gateway to the southern districts of the state.

The airport has long



served as an important hub for domestic air travel connecting cities across India.

The elevation of the airport to international status is expected to strengthen regional connectivity and create new opportunities for tourism, pilgrimage travel and business activity.

Madurai is home to the world-renowned Meenakshi Amman Temple and attracts millions of pilgrims and tourists each year.

Officials said that international status for the airport will further boost visitor inflow, not only to Madurai but also to other tourist desti-

nations across southern Tamil Nadu.

The state government noted that the move would encourage greater trade and investment while improving access for global travellers.

Enhanced connectivity is also expected to support economic development in the region by facilitating faster movement of people and goods.

Industry observers say the decision could lead to the launch of direct international flights to destinations in Southeast Asia and the Middle East, which have significant Tamil diaspora popu-

lation.

This would reduce travel time for passengers from southern districts, who currently depend on airports in Chennai, Tiruchirappalli (Tamil Nadu) or Thiruvananthapuram (Kerala) for many international connections.

The announcement has also drawn attention in the political arena as Prime Minister Modi is scheduled to visit Tamil Nadu on March 11 to attend an NDA election campaign rally in Tiruchirappalli.

The Union Cabinet decision and the Prime Minister's post on social media platform X regarding Madurai Airport have generated considerable public and political interest across the state.

With its elevation to international status, Madurai Airport is expected to emerge as a major aviation hub for southern Tamil Nadu, strengthening the region's connectivity with global destinations while supporting tourism, trade and economic growth.

**'Suddenly they respect Nehru': Priyanka Gandhi takes swipe at BJP in Lok Sabha**

NEW DELHI : Congress MP Priyanka Gandhi Vadra on Tuesday took a swipe at the ruling party in the Lok Sabha, saying it was ironic that leaders who frequently criticise India's first Prime Minister Jawaharlal Nehru were now quoting him in support of their arguments.

Speaking during a debate on a resolution seeking the removal of Om Birla as Speaker, Priyanka Gandhi said she found it amusing that those who regularly attack Nehru had suddenly begun praising him for strengthening India's democracy.

"I was laughing today because the person whom they criticise every day - Nehru ji - they are quoting the same person today. Suddenly, they have started respecting Nehru ji. Today they said that the person who made democracy the strongest was Nehru ji," she told the House, drawing loud support from the Opposition benches.

Her remarks came amid a heated political exchange during the discussion on the motion against Speaker Birla. Priyanka used the moment to highlight what she described as a contradiction in the ruling party's stance towards Nehru's legacy. She also strongly defended Leader of Opposition Rahul Gandhi, claiming that he had remained steadfast despite repeated attacks from the government.

"There is only one person in this country who has not bent before them in the last 12 years - that is the Leader of the Opposition, Rahul Gandhi. Because he stands here and speaks the truth without hesitation, and that truth is something they cannot digest," she said.

Earlier in the debate, Parliamentary Affairs Minister Kiren Rijiju said that all members of Parliament - whether from the ruling side or the Opposition - must operate within the framework of rules and the Constitution.

"When any individual considers himself above everything else, it is important that he be called out," Rijiju said, in what was widely seen as a pointed remark aimed at Rahul Gandhi.

**India gaining more weight as stable and wise actor in all circumstances: Italian envoy**

NEW DELHI : Italy's Ambassador to India, Antonio Bartoli on Tuesday highlighted the urgent need to end the ongoing conflict in West Asia, stating that both India and Italy are on the same page and continue to bat for holding a dialogue to stop the war as soon as possible. Speaking to IANS, Bartoli said that it was important that the conflict in West Asia ends soon to ensure the regularity and stability of energy resources at reasonable prices.

"Italy and India have the same priorities in this war, which is to encourage the parties to de-escalation, diplomatic dialogue, pacification, so to stop the war as soon as possible. Second, we are taking care, as you are doing, of thousands of Italian fellow nationals in the Gulf region and abroad. Also here, you know, 1,500 tourists were stuck in Maldives, for example. So, we are not only talking about the theatre of war. And third, it is important to end this as soon as possible

to ensure the regularity and stability of energy at reasonable prices. We don't want to see oil above \$100 per barrel and so we are working for this," Bartoli told IANS.

Oil prices declined sharply on Tuesday, trading below \$90 per barrel after US President Donald Trump predicted the war in the Middle East could end soon. Trump also cautioned Iran against attempting to disrupt global energy supplies through the Strait of Hormuz, one of the world's most critical oil shipping routes.

Bartoli said that India is gaining more weight in the international arena as a stable and wise actor in all circumstances. He also mentioned about the recent telephonic conversation between External Affairs Minister (EAM) S Jaishankar and his Italian counterpart Antonio Tajani, where they discussed the ongoing crisis in West Asia. "India as a country is gaining more and more weight in the international arena, not only for the econo-

my and for demography, but also for the international role as a stable and wise actor in all circumstances. And so we think that India is a reliable and friendly partner, not only for more and more integrated value chains, but in close dialogue also in geopolitics. And it's not by chance that yesterday evening our two ministers of foreign affairs have exchanged notes on this crisis in the Middle East."

He said that war in West Asia has an impact on internal market, consumers and is causing higher prices of transportation, insurance policies and other products.

"The impact is on internal market, consumers, higher prices, transportation, higher insurance policies, higher prices of everything. So, it's not good for the economy, it's not good for peace in general. So, we hope that this war can be ended as soon as possible and that we can continue to make trade and economy thrive and we are very confident in the FTA between Europe and India as a boost

for trade and also investments here," Bartoli said.

The ongoing conflict in West Asia began after the joint US-Israel strikes on Iran on February 28, which led to Iran launching drone and missile attacks targeting US assets, regional capitals and allied forces in West Asia.

Bartoli stressed that it is an honour for Italy to be designated as a partner country for the 40th edition of AAHAR - The International Food and Hospitality Fair. He expressed Italy's willingness to collaborate with India in food production. "It's a great honour because it's the first time that such an important and prestigious fair has a partner country and it's very meaningful to us that the first partner country is Italy. I think it's not by chance because apart from being a great producer with also an image for the food industry. I am happy to remind your public that in Delhi in December, UNESCO decided to include the Italian.
