

Decide in 3 months issuance of passport to Mehbooba: Delhi HC

New Delhi: The Delhi High Court on Friday asked the passport authority to take a decision within three months on issuing a fresh travel document to PDP chief Mehbooba Mufti. Justice Pratibha M Singh noted the issue has been pending for two years and, following an appeal against the rejection, it has now been remanded to the passport officer concerned for reconsideration. "Considering that the matter is remanded back to the passport officer and the initial rejection was two years ago, let the passport officer concerned take a decision expeditiously and in any case within three months," ordered the judge. The court's order came on a petition by Mufti seeking a direction to the authorities to take an early decision on her appeal regarding the issuance of a new passport. She said in her plea there was considerable delay in issuing a new passport to her despite reminders.

Those referring hijab over exams may lose current academic year

SC To Hear Plea Against Hijab Ban After Mar 12, Exams From Mar 9

New Delhi: Muslim girl Pre-University College students, who had dropped a year by not appearing in the PUC examination protesting ban on hijab in Karnataka government schools and PU colleges, may lose the current academic year as the Supreme Court on Friday refused urgent listing of the plea to allow them to appear with hijab for this year's examinations starting from March 9.

A hijab clad advocate on Friday sought urgent hearing of an application filed by 'Sharia Committee for Women' seeking allowing hijab wearing Muslim girl students to appear in PUC examinations. The Committee has also challenged a Karnataka HC verdict upholding the state's decision to ban students from wearing religious clothings, including hijab, to government schools and colleges. On October 13 last year, a two-judge bench of the SC had given a split verdict on the validity of the ban, which would require the CJT to constitute a 3-judge bench for hearing fresh the appeals.

With no working day available before March 9, the SC goes for a week-long Holi festival break. CJT D Y Chandrachud said he would constitute a three-judge bench which would commence hearing on the pending appeals immediately after the court resumes judicial work from

March 13. As the second PUC examination commences from March 9, the advocate said, "Those who want to wear hijab to school and colleges have already lost an academic year last year because they were not permitted to enter the college premises wearing hijab. What about this academic year? Should they lose this also?"

The CJT said, "I cannot answer your questions. I will constitute a bench and it will commence hearing on the pending appeals as soon as possible." The first PUC examination, which commenced on February 20, is scheduled to conclude on March 6. The second PUC examination is scheduled between March 9-29. Even if a 3-judge SC bench hears the pending appeals and plea for interim stay of the order banning hijab into

New Delhi: The law ministry on Monday notified appointment of 20 additional judges of four high courts as permanent judges. The elevation of additional judges is normally made after completion of their two years of initial appointment as high court judges. Friday's appointment includes 12 for the Allahabad High Court, two for the Bombay High Court and three each for the High Courts of Delhi and Madras. There are currently 333 vacancies of judges in 25 High Courts sanctioned strength of 1,114, as on March 1. The Allahabad HC has the highest 57 vacancies, followed by 28 in Bombay, 28 in Gujarat, 22 in MP and 21 in Patna High Court.

SC to reconsider its decision in Alapan case

New Delhi: Just over a year after ruling that only Delhi High Court and no other High Courts would have jurisdiction to entertain a plea against a decision taken by Principal Bench of Central Administrative Tribunal, the Supreme Court on Friday said that its last year verdict in former West Bengal chief secretary Alapan Bandhopadhyay case needed to be re-examined.

The top court in January last year had allowed the plea of Centre and set aside the order of Calcutta High Court which had quashed CAT chairman's order to transfer the hearing on Bandopadhyay plea against disciplinary proceedings from Calcutta Bench of CAT to its Principal Bench in Delhi and held that only Delhi HC would have jurisdiction to deal with petition against Chairman's order.

The same issue cropped up in the legal wrangle between Centre and Megastay award winner IFS officer Sanjay Chaturvedi with Uttarakhand High Court quashing the Principal CAT Bench order to transfer the case from Allahabad bench to itself and the Centre questioning the jurisdiction of the HC in view of apex court last year order.

Observing that the issue of territorial jurisdiction of HCs is important and it would affect many government employees who are posted across the country, a bench of Justices MR Shah and B V Nagarathna said that it has to be adjudicated by a larger bench.

"We think it appropriate that the matter involving the issue of territorial jurisdiction of the concerned High Court to decide a challenge to an order passed by the Chairman, CAT Principal Bench, New Delhi should be considered by a Larger Bench. Let the registry place the matter before the Chief Justice of India for appropriate orders at the earliest so that the afore-said issue is resolved at the earliest," the bench said.

The bench agreed with the contention of senior advocate Shyam Divan who pleaded the court that the last year verdict should be re-examined as it would create enormous hardships to employees who would be forced to come to Delhi from far flung areas to challenge in Delhi HC the adverse order passed against them by CAT's Principal Bench.

"The remedies under Article 226 and Article 227 (before HCs) are extremely valuable remedies available to citizens where they reside or carry on business or are posted. The scheme does not require citizens to come exclusively all the way to Delhi to seek redressal.

6 friends on way home from party killed as truck rams their car

Gurgaon: Six childhood friends returning from a party died when their car in which they were travelling was hit by a truck from behind on the Gurgaon-Faridabad road near Mangar a little after Thursday midnight. The Alto carrying the youths — all in their early 20s

— flipped a couple of times after being hit by the truck and got stuck below the belly of the heavy vehicle. The driver of the truck, registered in Rajasthan, fled the spot, leaving the vehicle behind. The six youths were identified as Akash, Jatin, Baljeet, Sandeep, Vishal and Puneet. They grew up in the same Jawahar Nagar locality in Palwal and

were engaged in small businesses to sustain their families, police said. The friends had left for Gurgaon to celebrate the wedding of Baljeet, who tied the knot on January 22. They were on their way home when the accident occurred near Mangar around 12.30am. By the time a police team reached the spot with an ambulance, all six had died.
