'Every 7th man, 6th woman at cancer risk'

While breast cancer is most common type of cancer in women of K'taka, it is lung cancer in men

WORLD CANCER DAY

ONE in seven men and one in six women are at the risk of developing cancer in Karnataka, a recent report by Indian Council of Medical Research (ICMR) has revealed. While breast cancer is the most common type of cancer in women of Karnataka, it is lung cancer in men. What is more worrying is that the numbers are only increasing, say doctors.

While early screening and detection continues to be the key, doctors claim that nearly 50 per cent of lung cancer patients come

to them only at the fourth stage of the cancer. "When we look at cancer incidence in Karnataka, lung cancer is the leading cause for men. It is imperative to be aware of the risk factors for lung cancer as close to 50 per cent of lung cancer is diagnosed in stage 4," says Dr Nitin Yashas, Medical Oncologist, Manipal Hospitals.

While the data shows that 33 per cent of cancers in men and 14 per cent in women are tobacco related, Dr Nitin says, there is also a trend being noticed where more number

of non-smokers are diagnosed with lung cancer and these cases may be attributable to the impact of environmental factors such as pollution, occupational exposure to carcinogens, diet, etc.

In Karnataka, according to Dr Ramakrishna C, Director, Kidwai Cancer Research Centre, it is estimated that 87,000 new cancer cases are seen in recent years at any point of time and about 2.3 lakh cases are observed in the state. "In Bengaluru, lung, stomach, prostate and esophagus are predominant cancers in men. In women it is breast, cervix, ovar-

ian, corpus uteri," he explains.

As pointed out by the theme of this year's World Cancer Day — "Close the care gap" — emphasising on improving access to quality cancer care for everyone, Dr Vishal Rao, Regional Director, Head and Neck Surgical Oncology HCC Cancer Hospital, says, "Over the years, cancer treatment has been inadvertently impacted by a lot of care gaps attributable to various reasons. These impediments are rooted in various deficiencies like lack of early diagnosis, misdiagnosis, delayed diagnosis, or even poor patient accessibility to care."

Short hospital stay for majority of patients

NEW data from the BBMP War Room report of February 1 shows there are more Covid-19 patients being admitted for shorter durations of time (9-7 days) in hospital, and fewer people being admitted for longer durations such as 8-14 days, 15-21 days and beyond 21 days.

For instance, 315 patients have been admitted for the past seven days, while 94 patients have been admitted for 8-14 days, 39 people for 15-21 days and seven people for more than 21 days.

"In this wave, the average duration of hospital stay is less. This could be a combination of factors, including the new Omicron variant and Covid-19 vaccination coverage. Patients with shorter duration of admission includes those across all age groups. Those on longer stay include people with comorbidities such as neurological issues, chronic kidney disease, and also those who are unvaccinated with comorbidities," said Thirlok Chandra, Special Commissioner (Health), BBMP.

the general ward, 58 in HDU, six in ICU and 41 in ICU with ventilator.

"Those who are mildly sick with fever, cough, cold, body pain are admitted for seven days. These patients are young with strong immunity and good resistance to fight Covid-19. Patients who stay for longer than seven days have other co-morbidities and are immunocompromised. Their bodies have a lower capacity to fight off the infection and ability rebound is compromised," a doctor from Bowring and Lady Curzon Hospital said.

He added that severity of illness is higher in such people. These patients include a mix of vaccinated, partially vaccinated, unvaccinated and even those whose vaccination status is unknown.

The second highest number of active admissions are in the 41-60 age group, with 37 patients in general ward, 41 in HDU, three in ICU and 23 in ICU with ventilator. The 19-20 age bracket has 37 patients in general ward, 54 in HDU, one in ICU and six in ICU with ventilator. The least hospitalised are in the 0-18 age group, with two children in general ward, five in HDU, two in ICU and one in ICU with ventilator.

The trend of hospital admissions in the last 15 days has shown overall decline in Bengaluru.

Ch'nagar sees dip in Covid cases

Mysuru: After witnessing a steep rise in Covid-19 cases, the backward Chamara Nagar district is showing signs of recovery as the infection rate has slowed down in the last three days. The health department's bulletin stated that the number of cases has come down to 196 and 261 on February 1 and 2 respectively. As many as 78 patients are being treated in a government hospital. However, many preferred to remain in home isolation as they had mild symptoms of fever, cough, running nose and bodyache.
