India, Ghana elevate ties to comprehensive partnership

"Today, the president and I have decided to elevate our bilateral partnership to a comprehensive partnership," Modi

said, adding, "India is not just a partner but a co-traveller in Ghana's journey of nation-building."

"In agriculture, it will be our pleasure to lend support towards President Mahama's 'Feed Ghana' programme," he stated. "We've discussed cooperation in vaccine production," he said.

Mahama said Ghana is keen to sign formal agreements with India on defence cooperation, vaccine production and supply of agricultural machinery.

Strong India needed for a prosperous world: Modi

PRIME MINISTER NARENDRA Modi on Thursday said a strong India will contribute to a more stable and prosperous world as he pushed for credible and effective reforms in global governance in the wake of changing circumstances.

In his address to the Parliament in Ghana, Modi also said that progress cannot come without giving voice to the Global South.

"In these times of global uncertainty, India's democratic stability shines as a ray of hope. India's rapid progress is a catalyst for global growth. As the world's largest democracy, India is a pillar of strength for the world. A strong India will contribute to a more stable and prosperous world," the prime minister said.

India may see lower US tariffs: Moody's

INDIA MAY BE subject to lower tariffs than many countries in the Asia Pacific, which could help the economy attract further investment and become a global manufacturing base, Moody's Ratings said on Thursday.

In its outlook on Asia Pacific sovereigns, Moody's Ratings said many export-reliant APAC economies were hit with very high US tariffs in April.

While negotiations will likely lead to some reduction in tariffs and other trade barriers on a bilateral basis, policy uncertainty is challenging investment decisions and disrupting trade.

Uncertainty about trade poli-

cy and a potential overhaul of global trade have raised cyclical and possibly structural credit risks in APAC, it said, adding that economies like Vietnam and Cambodia, which benefited from a diversification of investment and manufacturing out of China and now face high US tariffs, are particularly at risk.

"In contrast to countries like Cambodia and Vietnam, India has the potential to emerge as a beneficiary of a tariff-driven shift in investment and trade flows. India may be subject to lower tariffs than many in APAC, which could help the economy attract further investment flows and support its development as a global manufacturing base," Moody's Ratings said.

"Today, the president and I have decided to elevate our bilateral partnership to a comprehensive partnership," Modi

"In agriculture, it will be our pleasure to lend support towards President Mahama's 'Feed Ghana' programme," he stated. "We've discussed cooperation in vaccine production," he said.

Mahama said Ghana is keen to sign formal agreements with India on defence cooperation, vaccine production and supply of agricultural machinery.

INDIA MAY BE subject to lower tariffs than many countries in the Asia Pacific, which could help the economy attract further investment and become a global manufacturing base, Moody's Ratings said on Thursday.

In its outlook on Asia Pacific sovereigns, Moody's Ratings said many export-reliant APAC economies were hit with very high US tariffs in April.

While negotiations will likely lead to some reduction in tariffs and other trade barriers on a bilateral basis, policy uncertainty is challenging investment decisions and disrupting trade.

Uncertainty about trade policy and a potential overhaul of global trade have raised cyclical and possibly structural credit risks in APAC, it said, adding that economies like Vietnam and Cambodia, which benefited from a diversification of investment and manufacturing out of China and now face high US tariffs, are particularly at risk.

"In contrast to countries like Cambodia and Vietnam, India has the potential to emerge as a beneficiary of a tariff-driven shift in investment and trade flows. India may be subject to lower tariffs than many in APAC, which could help the economy attract further investment flows and support its development as a global manufacturing base," Moody's Ratings said.
