Recruit more field officers for accurate data collection: Parl panel



NEW DELHI: A Parliamentary panel has asked the Ministry of Statistics and Programme Implementation to recruit more field officers in the National Sample Survey Organisation on mission mode for more accurate and reliable data collection.

Parliamentary Standing Committee on Finance in its 58th Report on Demand for Grants (2023-24) of the Ministry of Statistics and Programme Implementation expressed concern over the shortage of manpower in the ministry, especially in the senior and junior statistical cadre. The report was tabled in Parliament on Thursday.

The panel noted that on November 30, 2022, 266 vacancies exist, which is 33 per cent of the total sanctioned strength.

The panel recommended the matter of recruitment with the Staff Selection Commission (SSC) vigorously so that the vacancies can be filled within this financial year. Regarding the shortage of manpower in the Field Operation Division of the National Sample Survey Organisation (NSSO), the committee suggested to recruit more field-based staff on a mission-mode basis for accurate and reliable data collection.

Lok Sabha passes Rs 45 trillion Budget for current fiscal without debate

NEW DELHI: Lok Sabha on Thursday approved the Union Budget envisaging an expenditure of around Rs 45 lakh crore for the fiscal year starting April 1 without any discussion, as the Opposition continued to create ruckus over demand for a JPC probe into allegations against the Adani Group.

The Lower House of Parliament took up the Demands for Grants and Appropriation Bills after two adjournments as the ruling and Opposition MPs engaged in a matching duet over demands for an apology by Rahul Gandhi and the Adani issue.

Most of the second leg of the Budget Session has been washed out due to the protest by both sides and it was one of the rare occasions when the Budget was passed without any discussion.

Soon after the Lok Sabha reassembled at 6 pm after two adjournments, Speaker Om Birla put the Opposition's cut motion or amendments to the government spending plan to vote which was rejected by voice vote. This was followed by Finance Minister Nirmala Sitharman moving the demands for grants for 2023-24 and relevant Appropriation Bills for discussion and voting.

Prime Minister Narendra Modi was present during the passage of Budget for 2023-24. The entire exercise was over in 12 minutes completing two-third of the parliamentary approval for the Budget for 2023-24.

The Finance Bill 2023, which contains tax proposals that Sitharman had moved while presenting the Budget on February 1, will now be taken up by the Lok Sabha possibly on Friday. All the budget-related bills will be transmitted to Rajya Sabha, which cannot make any changes but only return them to the Lok Sabha after

discussion as they are classified as 'money bills' requiring approval of the Lower House only.

The current Parliament session is scheduled to end on April 6. There is speculation that the duration of the session may be curtailed after completion of the budgetary exercise.

Unlike the past, the Lok Sabha this time did not discuss the Demands for Grants of the identified ministries.

The Business Advisory Committee had approved discussion on the ministries of railway, rural development, health and family welfare, Panchayati Raj, tribal affairs and tourism and culture.

However, no discussion could take place because of continuous disruption of the House after it reassembled for the second leg of the Budget session. According to the Budget papers.

No objection, those who did it shouldn't be arrested: Kejriwal on posters

NEW DELHI: Delhi Chief Minister Arvind Kejriwal on Thursday said he has no objection to posters that have been put up demanding his ouster and those behind it "should not be arrested". Posters reading "Kejriwal Hatao, Delhi Bachao" (Remove Kejriwal, Save Delhi) have been put up across the national capital by BJP leaders. This came a day after "Modi Hatao, Desh Bachao" posters appeared across the national capital. The Delhi Police arrested six people and registered 49 FIRs in connection with the anti-Modi posters. In a tweet, Kejriwal said, "People have put up posters against me in Delhi. I have no objection to this. In a democracy, the public has every right to express their views in favour of or against their leader. Those who put up posters against me should not be arrested." The posters against Kejriwal were put up by BJP leader Manjinder Singh Sirsa who accused Kejriwal of being "dishonest" and "corrupt". "He is involved in scams in education, health and excise departments. We are honest people and we are not scared of admitting that we have put up posters against him," Sirsa said. Sounding the bugle for the 2024 Lok Sabha elections, the Aam Aadmi Party has said it will kickstart a 'Modi Hatao, Desh Bachao' campaign from the Jantar Mantar here on Thursday.

The party will hold a public meeting which will be attended by Delhi Chief Minister Arvind Kejriwal and his Punjab counterpart Bhagwant Mann, AAP leader and Delhi Environment Minister Gopal Rai said on Wednesday.

Rahul Gandhi should be booked for insulting national icons: Shiv Sena



MUMBAI: Maharashtra Chief Minister Eknath Shinde-led Shiv Sena on Thursday welcomed the conviction of Rahul Gandhi for his remarks over Prime Minister Narendra Modi's surname and said he should also be booked for insulting national icons like V D Savarkar and defaming the country abroad.

Shiv Sena spokesperson Sheetal Mhatre said Gandhi is used to making personal comments.

He should also be booked for insulting national icons like Veer Savarkar and defaming the country abroad (a reference to Gandhi's recent comments at Cambridge University which has stoked controversy), Mhatre said.

institutional mechanism to deal with corruption in public life.

"However, the performance of the Lokpal seems to be far from satisfactory," said the report of the Department-related Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice.

The Committee is of the view that the Lokpal was established in an effort to promote clean and responsible governance and therefore, it should act as an enabler rather than an inhibitor, it said.

The Committee recommended the Lokpal not to reject genuine complaints merely on technical grounds that a complaint was not in the prescribed format.

"At this juncture when India is heading the G20 anti-corruption working group, the Lokpal should rise to the occasion and make every effort to strengthen the anti-corruption landscape in the country," the report said.

A total of 2,518 complaints (which were not in a prescribed format) were received by the Lokpal during 2022-23.

As many as 242 complaints received during the period were in the prescribed

format. Of these, 191 were disposed of. The panel also highlighted vacancies in the Lokpal and sought details of steps taken to fill them up.

It said Section 5 of the Lokpal and Lokayuktas Act, 2013 lays down that the President shall take or cause to be taken all necessary steps for the appointment of a new chairperson and members at least three months before the expiry of the term of the chairperson or member."The Committee notes that Justice Pinaki Chandra Ghose demitted the office of chairman of Lokpal in May 2022 on attaining the age of 70 years and since then Justice Pradip Kumar Mohanty has been acting as the chairperson of Lokpal," the report said.

The panel said vacancies of two judicial members have also not been filled up since 2020.

"The Committee desires to be apprised about the steps taken by the government to fill up vacancies of chairperson and judicial members of Lokpal. The Committee hopes that the Inquiry and Prosecution wings are constituted soon," said the report tabled in Parliament last week.
