PE, VC investments almost flat at \$7.4 bn in April: Report

Mumbai, May 16

PRIVATE EQUITY AND venture capital fund investments in the country stayed flat at \$7.4 billion in April, a report said on Tuesday. However, when compared with the preceding March, the inflows were 37% higher, the report by industry lobby grouping IVCA and consultancy firm EY said.

"The bid-ask spread between

investors and sellers remains high and convergence on valuation multiples has not happened. This has resulted in deal evaluation periods getting extended," the consultancy firm's partner Vivek Soni said.

Soni said activity is better in sectors like healthcare and financial services, and added that apart from these two, infrastructure and real estate will be the bright spots for investments in the short term.

In terms of the number of deals, April recorded 49 transactions, which is a 55% decline compared to the year-ago period and 32% lower when compared with March. It included 12 large deals of value greater than \$100 million aggregating to \$6.7 billion, which was a 19% increase over the year-ago period.

By deal type, growth investments were the highest in terms of value in April at \$4.5 billion across 12 deals.

INVEST ₹124 CRORE IN 'SAFE HAVEN' ASSET CLASS

Investors throng to gold ETFs

INVESTORS FLOCKED TO gold exchange traded funds (ETFs), which are considered a safe haven during uncertain times, and put in ₹124 crore in April after withdrawing money in the preceding month. This was in comparison to a net outflow of ₹266 crore from the asset class in March, data from the Association of Mutual Funds in India (Amfi) showed.

"Over the past few months, we have witnessed gold prices rising. While gold prices rose, some investors would have chosen to book profits or take



on risk on approach with a view that central banks would pause further rate hikes," Himanshu Srivastava, Associate Director, Manager Research, at Morningstar India, said.

He, further, said that pertinent risks still engulf developed economies and therefore over the course of the month, investors were attracted towards Gold ETFs.

According to the data, 14-gold linked ETFs have seen an inflow of ₹124.54 crore last month, which helped in raising the assets under the management of such funds to ₹22,950 crore at the end of April from ₹22,737 crore in March-end.

Gold, with its superlative performance over the last few years, has attracted significant investor interest, and the consistent surge in its folio num-

bers is a testimony of the same.

The folio numbers in gold ETFs surged by over 12,600 to 471,300 in the month under review from 469,900 in March. This shows that investors have become more inclined towards gold-related funds.

In the entire financial year 2022-23, inflows into Gold ETFs were at ₹653 crore, which was a decline of 74% year-on-year from ₹2,541 crore infusion seen in the segment in 2021-22. This drop was mainly due to profit booking in this asset class and investors' preference for equities.

However, the asset base of

Gold ETFs and investors' account or folio numbers increased in the last fiscal.

Gold ETFs, which track the domestic physical gold price, are passive investment instruments that are based on gold prices and invest in gold bullion.

In short, gold ETFs are units representing physical gold, which may be in paper or dematerialised form. One gold ETF unit is equal to 1 gram of gold and is backed by physical gold of very high purity.

They combine the flexibility of stock investments with the simplicity of gold investments.

Calgary (Canada): The union for Canada's second-biggest airline have issued a 72-hour strike notice to WestJet, and they warn the airline could be shut down before the weekend. The Air Line Pilots Association said in a statement late Monday that pilots

Loud explosions boomed over Kyiv as the nighttime attack combined Russian missiles launched from the air, sea and land in an apparent attempt to overwhelm Ukraine's air defences. No casualties were reported as Western-supplied weapons helped fend off the assault.

The barrage came as European leaders sought new ways to punish Russia for the war and a Chinese envoy sought traction for Beijing's peace proposal.

Russia's latest attack on Kyiv was "exceptional in its density - the maximum number of attacking missiles in the shortest period of time," said Serhii Popko, the head of the Kyiv military administration.

Valentyna Myronets, a 64-year-old Kyiv resident, said she felt "pain, fear, nervousness, restlessness" amid the assaults. "God, we are waiting for victory and when all this is over," she said.

The British ambassador to

Ukraine, Melinda Simmons, tweeted that the barrage was "pretty intense." "Bangs and shaking walls are not an easy night," she wrote.

It was the eighth time this month that Russian air raids had targeted the capital, a clear escalation after weeks of lure and ahead of a much-anticipated Ukrainian counter-offensive.

Six "Kinzhal" aeroballistic missiles were launched from MiG-31K aircraft, nine cruise missiles from ships in the Black Sea and three land-based S-400 cruise missiles targeted the capital, Air Force spokesman

Yurii Ihnat said in a statement on Telegram.

After the first onslaught, Russia also launched Iranian-made Shahed attack drones and conducted aerial reconnaissance, Ihnat said.

Debris fell across several districts in the capital, starting fires, but no losses were reported, Kyiv Mayor Vitali Klitschko said.

Sophisticated air defence systems provided by Ukraine's Western allies, including American-made Patriot missiles, have helped spare Kyiv from the kind of destruction witnessed elsewhere in the country.

Prosecutor ends Trump-Russia investigation

A special prosecutor found that the FBI rushed into its investigation of ties between Russia and Donald Trump's 2016 campaign and relied too much on raw and unconfirmed intelligence as he concluded a four-year probe.

The report on Monday from special counsel John

Durham represents the long-awaited culmination of an investigation that Trump and allies had claimed would expose massive wrongdoing by intelligence officials.

Instead, Durham's investigation delivered underwhelming results, with prosecutors securing a guilty plea from a little-known FBI employee but

losing the only two criminal cases they took to trial. The roughly 300-page report catalogs what Durham says were a series of missteps by FBI and Justice Department as investigators undertook a politically explosive probe in the heat of the 2016 election into whether the Trump campaign was colluding with Russia to tip the outcome.

UK police to re-open murder case of Indian-origin boy after 42 years

IAN S / London

Sussex police are set to re-examine the case of an eight year-old Indian-origin boy who was found dead months after he mysteriously disappeared in 1981 in London, media reports said.

Vishal Mehrotra and his family were on their way home to Putney when he disappeared, having watched Prince Charles and Princess Diana's wedding parade in central London, the Guardian reported.

Part of the child's remains were found in Rogate, West Sussex, seven months later in February 1982. No one has been convicted for his murder despite investigators inter-

viewing more than 14,000 people. After Vishal's father, Vishambar Mehrotra, criticised the Sussex police for failing to re-investigate the case, police officers met him on May 10 and told him that detectives had been given a "clear direction to 'advance' the case.

They also apologised for failing to spot a potential link between Vishal's murder and a document known to them that had been found in the possession of a convicted paedophile, according to Guardian.

This came after a BBC podcast which revealed fresh details about the case, including a potential link between the murder and the document titled 'Vishal'.
