1. Notice is hereby given that the Hon'ble National Company Law Tribunal, Bengaluru Bench, Bengaluru ("NCLT") by its order dated September 8, 2023 (hereinafter referred to as "NCLT Order"), has directed convening of a meeting of the equity shareholders (including public shareholders) of Ujjivan Small Finance Bank Limited ("Company") / "Bank" / "Transferee Company" / "Applicant 2", for the purpose of considering, and if thought fit, approving the Scheme of Amalgamation between Ujjivan Financial Services Limited ("Transferor Company") and the Transferee Company and their respective shareholders and creditors ("Scheme") pursuant to Sections 230 to 232 read with Section 66 of the Companies Act, 2013 ("Act"), the Companies (Compromises, Arrangements and Amalgamation) Rules, 2016 ("Rules") and other applicable provisions of the Act and Rules.

2. In pursuance of the NCLT Order and as directed therein further, this Notice is hereby given that a meeting of the equity shareholders (including public shareholders) of the Transferee Company will be held on Friday, November 03, 2023 at 11:30 AM, IST through video conferencing ("VC") or Other Audio Visual Means ("OAVM") (hereinafter referred to as the "Meeting") in compliance with the applicable laws including circulars issued by the Ministry of Corporate Affairs from time to time and the said equity shareholders are requested to attend the Meeting.

3. The Transferee Company has sent via email the Notice of the Meeting dated September 22, 2023 and the Explanatory Statement as required under Sections 230(3), 232(1) and (2) and 102 of the Act read with Rule 6 of the Rules and the documents as stated in the index of the Notice (collectively referred as "Notice & Annexures") on September 22, 2023 to the equity shareholders of the Transferee Company whose names appear in the register of members/list of beneficial owners as on Friday, September 15, 2023 and whose e-mail addresses are registered with the Transferee Company/ the relevant Depository(ies) as on the said date. Considering that the Meeting is being held through VC / OAVM as per NCLT Order, and in compliance with MCA Circulars, without the requirement of physical presence of the equity shareholders, the facility of appointment of proxies by equity shareholders will not be available for the said Meeting.

6. 7. The equity shareholders shall have the facility of voting on the resolution for approval of the Scheme by casting their votes (a) through e-voting system available at the Meeting to be held through VC / OAVM or (b) by remote electronic voting during the period as stated below:

8. The detailed procedure for attending the Meeting through VC / OAVM and e-voting, including for equity shareholders holding shares in physical form, forms part of the said Notice, and the equity shareholders are requested to read the same. Some of the important details regarding e-voting are provided below:

(i) The e-voting facility will also be made available during the Meeting to enable the equity shareholders who have not cast their vote through remote e-voting, to exercise their voting rights. Equity shareholders who have cast their vote through remote e-voting may attend the Meeting but shall not be entitled to cast their vote again. E-voting during the meeting would commence post the discussion pertaining to the business mentioned in the Notice is concluded and would be available for 30 minutes thereafter.

(ii) The voting rights of equity shareholders except the Promoter of the Bank i.e. Ujjivan Financial Services Limited shall be in proportion to their equity shareholding in the Transferee Company as on Cut-off date i.e., Friday, October 27, 2023.

(iii) Any person, who becomes an equity shareholder of the Transferee Company after dispatch of the Notice of the Meeting and holds shares as on the Cut-off date or equity shareholder who has not registered his/her/its e-mail address, may obtain the user ID and password by sending a request to KFIN. अतिरिक्त दोन लाख टन कांदा खरेदीस केंद्राची मंजूरी

१४० कोटी जनतेच्या विश्वासाला तडा जाऊ देणार नाही : गोयल

कांदा उत्पादन, खरेदी-विक्री दर

◆ नवी दिल्ली, २९ सप्टेंबर

कांदा उत्पादन, खरेदी तसेच विक्री दराविषयी १४० कोटी जनतेच्या विश्वासाला तडा जाऊ देणार नसल्याचे आश्वासन केंद्रीय वाणिज्य मंत्री पीयूष गोयल यांनी दिल्याची माहिती राज्याचे पणन मंत्री अब्दुल सत्तार यांनी आज पत्रप्रतिषेदत दिली. तसेच अतिरिक्त दोन लाख टन कांदा खरेदीसाठी केंद्राची मंजूरी मिळाल्याचे त्यांनी सांगितले.

नाशिक जिल्ह्यातील व्यापारांच्या समस्यांवर केंद्र शासनाच्या सहकार्यातून मार्ग काढण्यासाठी कृषी भवन येथे बैठकीचे आयोजन करण्यात आले होते. या बैठकीत केंद्रीय वाणिज्य

मंत्री पीयूष गोयल, केंद्रीय आरोग्य राज्यमंत्री डॉ. भारती पवार, राज्याचे पणन मंत्री अब्दुल सत्तार, नाफेड संस्थेचे अपर व्यवस्थापकीय संचालक एस. के. सिंग व अन्य वरिष्ठ अधिकारी उपस्थित होते. यावेळी पणन मंत्री सत्तार यांनी केंद्रीय मंत्री गोयल यांनी व्यापारांच्या समस्या संदर्भात तातडीने लक्ष घालून हा विषय सोडविण्यासाठी दाखवलेल्या तत्परतेबद्दल त्यांचे आभार मानले. कांदा उत्पादक शेतकऱ्यांचे कोणत्याही परिस्थितीत नुकसान होऊ नये, यासाठी राज्य शासनामार्फत सर्वतोपरी प्रयत्न करण्यात येणार आहेत. तसेच देशांतर्गत कांदांचे दर नियंत्रणात राहण्यासाठी केंद्र शासनाने सकारात्मक पावले उचलली आहेत. यापूर्वी केंद्र सरकारने कांदाच्या नियातीवर ४० टक्के शुल्क लावले

आहे. या निर्णयामुळे कांदा उत्पादक शेतकऱ्यांचे नुकसान होऊ नये म्हणून केंद्र शासनाने २ हजार ४१० रुपये प्रतिक्विंटल दराने नाफेड आणि एनसीसीएफ मार्फत २ लाख मेट्रिक टन कांदा खरेदी करण्याचा निर्णय घेतला होता. मात्र दोन्ही संस्थांकडून अत्यंत कमी प्रमाणात खरेदी करण्यात आली आहे. त्यामुळे शेतकऱ्यांचे नुकसान होऊ नये म्हणून, नाफेड तसेच एनसीसीएफ या संस्थांनी प्रत्येकी एक-एक लाख टन कांदा आणखी खरेदी करण्याबाबत केंद्र सरकारने परवानगी दिल्याचे सत्तार यांनी यावेळी सांगितले. आता ४०० कोटी रुपयांची आणखी कांदा खरेदी करण्यात येईल. कुठल्याही परिस्थितीत गरीब शेतकऱ्यांचे नुकसान होऊ देणार नाही, असे आश्वासनही त्यांनी दिले.

◆ नवी दिल्ली, २९ सप्टेंबर केंद्र सरकारने पीएम गतिशक्ती राष्ट्रीय मास्टर प्लान (एमएनपी) अंतर्गत एकूण ५१ हजार ७०० कोटी रुपयांच्या सहा पायाभूत प्रकल्पांना मंजूरी दिली. यात रस्ते महामार्ग आणि रेल्वेसंबंधी योजनांचा समावेश असल्याचे सूत्राने सांगितले.

माहितीनुसार, पीएम गतिशक्ती अंतर्गत नेटवर्क प्लानिंग ग्रुप (एनपीजी) च्या ५६ व्या बैठकीत रस्ते महामार्गसंदर्भातील चार योजनांच्या प्रस्तावांना मंजूरी देण्यात आली. यावर ४५ हजार कोटी रुपयांची तरतूद करण्यात आली आहे. याशिवाय ६ हजार ७०० कोटी रुपयांच्या दोन योजनांचा समावेश आहे. पहिल्या महामार्ग योजनेत गुजरात आणि महाराष्ट्र राज्य अंतर्भूत आहेत. यात नवसारी, वलसाड, नासिक, अहमदनगर जिल्ह्यांतील

रस्तेमार्गांचा समावेश आहे. याद्वारे आदिवासी क्षेत्रांचा सामाजिक आणि आर्थिक विकासावर भर देण्यात आला असून, पर्यटन क्षेत्रांसाठी जोडण्यात आले आहेत. दुसऱ्या योजनेत बनासकांठा, पाटण, महेसाणा, गांधीनगर, अहमदाबाद हा भाग अमृतसर-जामनगर आर्थिक क्षेत्रासोबत जोडण्यात येणार आहे.

तिसऱ्या योजनेत बिहारमधील पाटणा-आरा-सासाराम भागाचा समावेश आहे. या जिल्ह्यांमध्ये सामाजिक आणि आर्थिक विकास साधण्यावर भर देण्याचे निश्चित आहे.

याशिवाय हे क्षेत्र जलमार्गासोबतही जोडण्यात येणार आहे. तर, चौथ्या योजनेत उत्तर प्रदेश समाविष्ट असून, मध्यप्रदेश, राजस्थान, उत्तरप्रदेश, उत्तराखंड

राज्यांसोबत महामार्गाने जोडण्यात येणार आहे.

दरम्यान, गतिशक्ती अंतर्गत ओडिशा आणि केरळमधील दोन रेल्वे योजनांना समाविष्ट केले आहे. ओडिशातील गंजम, नयागड, खंडमाल, बौध, संबलपुर, अंगुल जिल्ह्यांचा समावेश करण्यात आला आहे. प्रामुख्याने औद्योगिक मागास क्षेत्राच्या विकासाला प्राधान्य देण्याचे निश्चित केले आहे. केरळमध्ये रेल्वेमार्गाचे विस्तारीकरण होणार असून, यात प्रवासी आणि मालवाहतूक मार्गांचा समावेश आहे.
