पिछले वर्षों के दौरान प्रदेश में सड़कें बेहतर होने से मतदान केंद्रों तक पहुंचने में होने वाली परेशानियां कम हुई हैं। सुदूर गांवों तक पहुंचने के लिए इस बार 40 गांवों में 126 मतदान केंद्र बनाने की पहल की गई हैं। इससे स्थानीय लोगों को मतदान के लिए 8-10

सुरक्षा के लिहाज से बस्तर के 12 विधानसभा क्षेत्रों में सात नवंबर को होने वाले चुनाव के लिए पुलिस, डीआरजी, बस्तर फाइटर, सीआरपीएफ, बीएसएफ समेत अर्धसैनिक बलों की तैनाती की जाएगी।

किलोमीटर की दूरी तय करने के बजाय अब दो-तीन किलोमीटर के दायरे में अपने गांवों में ही वोट देने का वर्षों बाद मौका मिलेगा। छत्तीसगढ़ की मुख्य निर्वाचन पदाधिकारी रीना बाबा साहेब कंगाली ने बताया कि गांवों में मतदान केंद्र बनाए जाने से लोगों को अधिक दूर नहीं जाना पड़ेगा। पहले पहाड़ी, जंगल और नदी से गुजरते हुए मतदान के लिए लोग

मतदान के लिए पहुंचते थे। माओवाद प्रभावित क्षेत्रों में बस्तर संभाग के गांवों में नए मतदान केंद्र बनाए गए हैं।

पहले चरण के चुनाव के दौरान एहतियात के तौर पर सुरक्षा बलों की तैनाती की जा रही है। इनमें बस्तर फाइटर, डीआरजी समेत महिला कमांडो भी शामिल होंगी। पूर्ण तौर पर महिलाओं के लिए 35 मतदान केंद्रों की कमान

भी महिला बल के पास होगी। नक्सल प्रभावित इलाकों से अब गांवों में मतदान केंद्रों को स्थानांतरित किया जा रहा है। सुकमा के सिलगेर, चांदामेटा सहित तमाम गांवों में मतदान केंद्र बनाए जा रहे हैं। नक्सल आधार कमजोर पड़ रहा है और सड़कें सहित दूसरी बुनियादी सुविधाएं बेहतर होने से भी हालात बदल रहे हैं।

एक दिन पहले निर्वाचन प्रक्रिया में शामिल अधिकारियों और कर्मियों को दूर रहने की माओवाद समर्थकों की पश्चिमी बस्तर डिविजन कमेटी ने चेतावनी दी थी। नक्सल आधार वाले क्षेत्रों में पर्चियों के जरिए लोगों को मतदान प्रक्रिया में शामिल होने से रोकने की कोशिश की जा रही है। तीन दिन पहले नक्सलियों ने दहशत फैलाने के इरादे से तीन दिन पहले कांकिर-नारायणपुर सीमा क्षेत्र और गढ़चिरौली (एमएच) जिले के पास 3 लोगों की हत्या कर दी। नक्सल प्रभावित बीजापुर जिले में संदिग्ध नक्सलियों ने पुलिस मुखबिर होने के संदेह में एक 40 वर्षीय व्यक्ति की हत्या कर दी।

बघेल ने अर्धसैनिक बलों के वाहनों की जांच की मांग की

नई दिल्ली, 2 नवंबर।

छत्तीसगढ़ के मुख्यमंत्री भूपेश बघेल ने वीरवार को कहा कि चुनाव आयोग को छत्तीसगढ़ में चुनाव ड्यूटी के लिए तैनात किए जा रहे अर्धसैनिक बलों के सामान और वाहनों की जांच करनी चाहिए। उन्होंने आशंका जताते हुए कहा कि भारतीय जनता पार्टी (भाजपा) मतदाताओं को प्रभावित करने के लिए उनके माध्यम से नकदी और अन्य वस्तुओं को पहुंचा सकती है।

रायपुर में बघेल ने भाजपा पर निशाना साधते हुए कहा कि सत्ता हासिल करने के लिए किसी भी स्तर तक गिर सकती है। उन्होंने कहा, 'ईडी के वरिष्ठ अधिकारी छत्तीसगढ़ का दौरा करते रहे हैं लेकिन सरकारी अधिकारियों के वाहनों की जांच नहीं हो रही है।' हेलिकाप्टर और कार से यात्रा करते वक़्त हमारी जांच की जाती है।' मुख्यमंत्री ने दावा किया, 'सीआरपीएफ का एक विमान बड़े बक्से लेकर आया लेकिन उसकी जांच नहीं की गई।' प्रवर्तन निदेशालय (ईडी) अपनी जांच के

लिए आ सकता है, लेकिन मैं चुनाव आयोग से कहना चाहता हूं कि केंद्रीय जांच एजेंसी के वाहनों की जांच की जानी चाहिए। बघेल ने आरोप लगाया कि भाजपा ने (चुनावों में) अपनी हार स्वीकार कर ली है और यह उनका आखिरी दांव है कि बक्सों में पैसा ला रहे हैं जिसका इस्तेमाल मतदाताओं को प्रभावित करने के लिए किया जाएगा। इसलिए सभी वाहनों की जांच की जानी चाहिए, खासकर ईडी और सीआरपीएफ के वाहनों की।

मुख्यमंत्री ने सवाल उठाते हुए कहा कि जब राज्य में पहले से ही सीआरपीएफ तैनात है तो बाहर से अतिरिक्त बल तैनात करने की जरूरत क्यों है। इसका मतलब है कि जो बक्से लाए जा रहे हैं उनमें नोट (नकदी) या अन्य सामान भी हो सकते हैं, इसलिए इनकी जांच की जानी चाहिए। यह पूछे जाने पर कि क्या चुनाव में अर्धसैनिक बल का दुरुपयोग हो सकता है, बघेल ने कहा, यह बिल्कुल संभव है। सत्ता हासिल करने के लिए वे किसी भी स्तर तक जा सकते हैं..। यह बहुत गंभीर मुद्दा है और चुनाव आयोग को इसका संज्ञान लेना चाहिए। हमारी पार्टी की ओर से शिकायत दर्ज कराई जाएगी।'

नोवाक जोकोविच पेरिस मास्टर्स के दूसरे दौर में बुधवार को टायमस मार्टिन एचेवेरी को 6-3, 6-2 से हराकर रेकार्ड आठवीं बार साल का अंत शीर्ष रैंकिंग के खिलाड़ी के तौर पर करने की राह पर हैं। जोकोविच इस साल सितंबर के मध्य में सर्बिया के लिए डेविस कप खेलने के बाद पहली बार एकल मुकाबला खेल रहे हैं। पेरिस मास्टर्स के छह बार के चैम्पियन जोकोविच ने रैंकिंग में दूसरे स्थान पर काबिज कार्लोस अल्काराज पर अपनी बढ़त मजबूत कर ली है। अल्काराज को मंगलवार को दूसरे दौर में झलीफायर रोमन स्फिउलिन ने हराया था। रूस के दानिल मेद्वेदेव को भी दूसरे दौर के मुकाबले में बुधवार को ग्रेगोर डिमित्रोव ने 6-3, 6-7, 7-6 से हराया जिसके बाद अल्काराज एकमात्र खिलाड़ी हैं जो साल के अंत में रैंकिंग में जोकोविच से आगे निकल सकते हैं। जोकोविच पुरुष वर्ग में रेकार्ड सात बार साल के अंत में शीर्ष रैंकिंग के खिलाड़ी रहे हैं। यह पीट स्मप्पास के रेकार्ड से एक अधिक है। महिला टेनिस में महान खिलाड़ी स्टेफी

इस बीच, टामी पाल और कैस्पर रुड अब एटीपी फाइनल्स के लिए झलीफाई नहीं कर सकेंगे। बारहवीं वरीयता प्राप्त पाल झलीफायर बोटिक वान डी जैंडस्ट्रुल्प से 4-6, 6-2, 3-6 से हार गए, जबकि आठवीं वरीयता प्राप्त रुड को फ्रांसिस्को सेरेंडोलो ने 7-5, 6-4 से हराया। एटीपी फाइनल्स का आयोजन 12 से 19 नवंबर तक इटली के तूरिन में होगा। आठ खिलाड़ियों के इस टूर्नामेंट के लिए जोकोविच, अल्काराज, मेद्वेदेव, यानिक सिनर और एंड्री रुबलेव पेरिस मास्टर्स से पहले ही जगह पक्की कर चुके हैं। बाकी बचे तीन स्थान के लिए
