Indian-US author on UK non-fiction prize longlist

LONDON

INDIAN-American physician-author Dr Siddhartha Mukherjee's *The Song of the Cell: An Exploration of Medicine and the New Human* has been longlisted for the prestigious Baillie Gifford Prize for Non-Fiction on Wednesday.

The New York-based cancer physician and researcher, who is an Assistant Professor of Medicine at Columbia University, will go up against 12 other authors from around the world for the annual GBP 50,000 prize, which aims to recognise and reward the best of non-fiction work and is open to authors of any nationality. Mukherjee's longlisted work has been described as at once panoramic and intimate and the author's "most spectacular book yet."

"The cell is the foundational unit of life. Its discovery reshaped our understanding of our bodies and brains as never before," note the judges with reference to the 53-year-old's latest work.

Russian missile strike on east Ukraine kills 16

One child among dead in the attack in frontline town of Kostyantynivka; 28 injured

KYIV

UKRAINIAN President Volodymyr Zelensky said on Wednesday a Russian strike on a market in east Ukraine had killed more than a dozen people and wounded more.

"At this moment, the artillery of Russian terrorists has killed 16 people in the city of Kostyantynivka, Donetsk region. A regular market. Shops. A pharmacy. People who did nothing wrong. Many wounded," Zelensky said in a post on social media.

Ukrainian Prime Minister Denys Shmygal posted security camera footage of a blast tearing into rows of kiosks, sending residents running for cover and sending off car alarms. He said one child was among those killed.

Ukraine's interior ministry Igor Klymenko said in a post on social media that the strike had left 28 people injured.

Kostyantynivka is a frontline town of an estimated 70,000 people in the eastern industrial region of Donetsk, which has been the epicentre of fighting since Russia launched its invasion in February 2022. Donetsk has been partially controlled by Kremlin-backed separatists since 2014 and Russia claimed to have annexed the region alongside three others late last year.

Meanwhile, Romanian President Klaus Iohannis on Wednesday called for an "urgent investigation" into debris of what it believed to be a drone, which was discovered on its soil following attacks in neighbouring Ukraine. The revelation comes after NATO

member Romanian repeatedly rejected claims by Kyiv that Iranian-made Russian drones fell and detonated on Romanian territory during a strike on the Ukrainian port of Izmail on Sunday night. "Investigators discovered elements resembling drone debris in the evening of 5 September," the defence ministry said. The discovery was made near Plauru, a Romanian village on the other side of the Danube. Technical analysis will now be carried out to "determine (the debris') origin and characteristics", it added. After stating no drone or debris was recovered on its soil earlier this week, Iohannis appeared to row back on Wednesday, calling for "an urgent and professional investigation".

Copenhagen: The Danish defence said on Wednesday that they are abolishing the height requirements for people serving with the Danish Royal Life Guards, mainly known for being a ceremonial unit outside Denmark's royal palaces. Joining the Danish defence "is not about whether you are male or female or tall or short. It is about the ability to solve the task," the armed forces said. Until now, it was required for men had to be at least 175 cm tall and women 169 cm to serve in the unit. The Danish Royal Life Guards is a mechanised infantry regiment of the Danish Army.
