# 5 kanwariyas killed in accident in Outer Delhi

**NEW DELHI :** Five kanwar yatis died while over a dozen of them sustained injuries after a truck ramed into their vehicle on GTK Road in Outer Delhi's Alipur in the early hours of Thursday.

Police said the men were going from Nangloi to Haridwar when a truck coming from the opposite direction crossed the divider and ramed into their vehicle. The accused truck driver fled from the spot. Police said he was later arrested from Sanjay Gandhi Transport Nagar in Samaypur Badli.

According to police, a PCR call about the accident was made around 12.44 am. DCP (Outernorth) Ravi Kumar Singh said, "When we reached the spot, we found that a truck going towards Delhi crossed the divider at GTK Road and ramed into another truck which had 20-23 kanwar yatis. At least 14 people were injured."

The injured were sent to Satyawadi Raja Harish Chandra Hospital in Narela where four of them were declared dead on arrival by doctors. Two more pilgrims were



referred to Balaji Action Centre in Paschim Vihar where one succumbed to the injuries.

The deceased have been identified as Sandeep Kumar (32), Rajat Kumar (24), Aryan Singh (19), Jagminder Balhara (56) and Raju (37). Police said Sandeep, Rajat and

Aryan were residents of Delhi while Jagminder had come from Gurgaon. Five other persons — Lokesh Jha (27), Naveen Rai (30), Shubham Giri (20), Shiva Kumar (28) and Sandeep Chandra (30) — are undergoing treatment at BJRM Hospital in Jahangirpuri.

The other nine injured persons have been sent to different hospitals and are stable. One of the injured persons, Kamal Aggarwal (47), was the coordinator for the yatra. Jagmohan (47), among the injured persons, filed a police complaint about the accident.

"He told us they were all going towards Haridwar when a truck came and hit their truck from the side.

The impact was such that the entire truck was damaged and everyone was injured... locals and police came to rescue them," said a senior police officer.

Police said a case of rash driving and causing death by negligence has been registered against the accused driver, Pappu Kumar from Kannauj. Police said teams are also in touch with the victims and hospitals.

## CBI books EPFO official, 13 ex-employees of Jet Airways in PF claims fraud case

**NEW DELHI :** The CBI has booked a Mumbai-based officer of EPFO and 13 former employees of grounded airline Jet Airways who had paid bribes to him to

settle their provident fund claims, officials said Thursday.

The case was handed over to the CBI after a probe by the Employees Provident



Organisation (EPFO) vigilance found alleged fraudulent activities of Machindra Jagannath Bamne, senior social security assistant posted at accounts section of its regional office in Kandivali(E).

It emerged that Bamne received illegal gratification in his as well as his wife's bank accounts through multiple mode of online banking from employees of various establishments in lieu of their claim settlement.

It is alleged that Rs

1.77 lakh were credited in his and his wife's accounts by 13 employees of Jet Airways which has stopped operations.

"This aspect has been confirmed in the investigation by cross verifying the online credit entries in the accounts of the official and his wife with the corresponding debit entries in the bank accounts of employees of various establishments, whose PF claims were settled by Bamne," the FIR alleged. The CBI has filed a case against Bamne, his wife and 13 former employees of Jet Airways under criminal conspiracy and provisions of the Prevention of Corruption Act, the officials said.

## Delhi High Court refuses to stay call inviting applications for UPSC mains exam

**NEW DELHI :** The Delhi High Court Thursday refused to stay the Union Public Services Commission (UPSC) call inviting applications for Civil Services (Main) Examination, 2023.

A single-judge bench of Justice Chandra Dhari Singh dismissed an application moved by various civil servant aspirants in a pending matter, seeking a direction to stay 'Detailed Application Form-1', dated July 10, issued by the UPSC.

The petitioners, in their application, said the UPSC "arbitrarily" issued the DAF for the mains examination, so their main writ plea before the court seeking the answer key of the preliminary exam



becomes "infructuous".

The application states that by issuing the form the UPSC was showing "undue hastiness" to "subvert the process of law and justice and carry on its arbitrary practices in a covert manner". It also said the UPSC, in the "past" too, had "successfully got cases dismissed" on account of them becoming "infructuous" due to non-compliance, passage of time or change in circumstances".

The aspirants had moved the application in a writ petition against a June 12 press note which stated that the answer key of the preliminary exam would be uploaded only "after the entire process of the Civil Services Examination 2023 is over". The main plea also sought a direction to the body to publish the answer key with immediate effect.

The main writ petition stated that normally when a competitive exam is conducted, the answer key to the questions (multiple choice questions) is prepared in advance so the same can be released after the exam is conducted, giving a "fair evaluation to the candidates".

However, the June 12 press note titled 'result of civil services preliminary examination' mentioned that "candidates are also informed that marks, cut off marks and answer keys of CS(P) Examination, 2023 will be uploaded on the Commission's website i.e. <https://upsc.gov.in>, only after the entire process of the Civil Services Examination 2023 is over, that is, after the declaration of final result".

**new delhi :** Unprecedented rainfall across North India over the past few days hit the movement of about 400 passenger trains between July 7 and 13, the Indian Railways said Thursday. This was in addition to 600 mail or express trains being affected for 6 days previously, it added. The danger level of water under the Old Yamuna Bridge, that takes trains to the Old Delhi railway station, is 204.83 metres. Yamuna breached this a few days ago and stood well above at 208.53 metres on Thursday, the Railways said. Since Sunday, 15 long-

distance mail trains and 122 passenger trains (local, short-distance, intercity) have been cancelled due to the rains. Northern Railway has had to divert 101 mail/express trains and 26 passenger trains to avoid the Yamuna Bridge, while it has partially cancelled or short-terminated 78 such trains. The most number trains were affected over the past two days, as per data released by Railways Thursday. Due to incessant rain and inclement

weather in Delhi, Punjab, Haryana, Himachal Pradesh and Jammu and Kashmir, train services have been affected in Ambala, Delhi, Firozpur and Moradabad divisions of Northern Railway, a Northern Railway statement said. "Passengers were informed through SMS. Help desks were opened to guide the passenger's at all major stations. Regular announcements are being done at stations too," a Northern Railway spokesman said.
