

Kerala CM rejects UDF demand for CBI probe in gold smuggling case

THIRUVANANTHAPURAM, JULY 21 /--/ Kerala chief minister Pinarayi Vijayan on Thursday rejected the Opposition Congress-led UDF's demand for a High Court-monitored CBI probe into the sensational gold smuggling case, in which a prime accused had levelled serious allegations against him, his family members and some top bureaucrats.

Replying to a submission by Leader of Opposition V D Satheesan in the Assembly, Vijayan said the smuggling case was completely the Centre's subject and does not come under the purview of the state government and so it cannot make any request about which agency should probe the case. "The state government cannot say which agency should probe the gold smuggling case as it is not a state subject. There is no need for the state government to take up that responsibility," he said.

Several agencies including the Enforcement Directorate, NIA and Customs are currently probing the case and if any of them felt any limitation in their present investigation, it was up to them to take the decision to hand over the case to others. Vijayan also alleged that the CBI was an agency which had been widely misused by the Central governments in various cases across the country. Irked over the rejection of their demand, UDF members raised slogans against the chief minister and the Left government saying they were scared of a CBI probe. (PTI)

BJP stages walkout from Chhattisgarh Assembly over Baghel govt's failure to implement housing scheme

RAIPUR, JULY 21 /--/ Members of the opposition BJP on Thursday accused the Congress government in Chhattisgarh of "snatching" houses of the poor to which they were entitled and staged a walkout from the state Assembly.

Even the state panchayat and rural department minister had to quit the portfolio after being disappointed with the state government's reluctance in releasing funds for the implementation of the Pradhan Mantri Awas Yojana (PMAY), they claimed (REFAY), they claimed (REFAY), they claimed (REFAY). On July 16, Singh Deo had given up charge of the panchayat department citing various reasons, saying he was unable to fulfil the department's targets as per the vision of the Jan Ghoshna Patra (poll manifesto), given the "current scenario". In his letter to chief minister Bhupesh Baghel, the minister had claimed not a single house was built for homeless people under the PMAY as funds were not allotted despite "repeated request".

Singh Deo continues to hold four other portfolios, including the state health department. Raising the issue during the Question Hour on the second day of monsoon session of the Chhattisgarh Assembly, former chief minister Raman Singh claimed the PMAY implementation was pathetic in the state where the Baghel government was not giving its part of the share and as a result, targets allotted by the Centre were withdrawn. Singh Deo in his letter (to CM while giving up the panchayat department) had said funds were not released under the

Similarily, from 2019 to 2022 (three financial years), 1,01,081 houses were sanctioned under the PMAY-Urban, 19,594 houses were completed, 43,304 were under progress/incomplete, while the work on 38,183 houses was yet to be started, Akbar said. SC to hear in Oct 1 st week pleas on Gyanvapi mosque

NEW DELHI, JULY 21 /--/ The Supreme Court on Thursday said that it will await the Varanasi district judge's decision on the Gyanvapi mosque committee's application raising objections to the maintainability of the civil suit filed by Hindu devotees.

The apex court also refused to entertain two writ petitions that sought its permission to worship the Shivling', which is claimed to be found in the Gyanvapi mosque premises during a court-ordered survey and carbon dating of the Shivling' to ascertain its age. A bench of Justices DY Chandrachud, Surya Kant, and PS Narasimha said that it is posting for October first week hearing on the appeal of Gyanvapi mosque committee's plea against the Allahabad High Court order upholding the appointment of court commissioner to survey the site. The bench said that it has been apprised of the fact that proceedings before the district judge are still underway and it would be appropriate if the appeal of the mosque committee is kept pending till the outcome of the application filed under Order 7 Rule 11 questioning the maintainability of the suit.

During the hearing, the bench told senior advocate Huzefa Ahmadi appearing for the Committee of Management of Anujman Intezamia Masajid, Varanasi, that it will keep the proceedings on the appeal filed by it pending till the district judge adjudicate upon the objections filed by the mosque committee on the

maintainability of the suit under Order 7 Rule 11 of CPC. It said: "You see everything depends on the application under Order 7 Rule 11 of CPC which has been filed before the district judge, Varanasi.

If the district judge upholds the objections then nothing remains but if it rejects the objections then parties can avail the remedies provided under the law. As regard to the commission's report, you can very well raise it before the court that it should not be read in evidence". Ahmadi accepted that there is a remedy under law but said that the High Court order upholding the appointment of a court commissioner cannot be passed. "It is like a fruit from a poisonous tree. The order of commission survey was ex-facie beyond jurisdiction", he said, adding: "If I can make out a case that the order appointing commission is illegal, then the report has to be struck off. In my case, there was no situation for ordering a commission report". The senior counsel said that the court must see what the commission report has led to and the entire area of worship has been sealed. "The high court said that the order appointing
