महाराष्ट्राच्या सगळ्याच भागात तुलनेने चांगलाच पाऊस झालेला आहे. आणि सर्व भागातल्या नद्या दुथडी भरून वाहत आहेत. महाराष्ट्राला निसर्गतः मिळालेले नद्यांचे वरदान आनंद स्वरूपाचे ठरते. परंतु पुढच्या महिन्या दोन महिन्यात जवळपास सगळ्या नद्यांची स्थिती अतिशय वाईट स्वरूपाची होईल. त्यावेळी या नद्यांकडे पाहिल्यावर पावसाळ्यात या नद्या दुथडी भरून वाहत असतील की नाही याबद्दल शंका वाटू लागते. म्हणजे काही नद्यांमध्ये तर पाणी शोधण्याची वेळ येते. तर ९० टक्के नद्या या सर्व प्रकारच्या प्रदूषणाला आंदण दिल्या जातात. पाच दहा टक्के नद्यांमध्ये बाराही महिने पाणी राहत असले तरी ते स्वच्छ आणि शुद्ध राहू शकत नाही. कारण ना सरकार ना जनता कोणालाच या नद्या शुद्ध आणि पवित्र हव्यात असे वाटत नाही. आपल्या जवळच्या नद्यां बाराही पाणी राहिले पाहिजे, अशी सगळ्यांची इच्छा मात्र असते. परंतु सध्या महाराष्ट्रातल्या नद्यांची ही परिस्थिती पाहिली तर अवकाळी पावसाप्रमाणे ९० टक्के नद्या या पावसाळी नद्या आहेत असे म्हटले पाहिजे. म्हणजे अवकाळी पावसाप्रमाणे अनेक नद्या पावसाळी नद्या आहेत असेच म्हणावे लागते. कारण पावसाळ्यापुरतेच त्यांचे अस्तित्व शिल्लक असते. नंतर याच नद्यांमध्ये जिरवले जाऊन कृष्णा, कोयना, गोदावरी, पंचगंगा, भीमा, यासारख्या कितीतरी मोठ्या आणि पुराणकाळापासून पवित्रता लाभलेल्या नद्या महाराष्ट्रात आहेत. परंतु यातली एकही नदी बाराही नाही. आणि शुद्ध पाण्याचा प्रवाह त्यातून पाहायला मिळत नाही. अशाच एका नदीप्रदूषणाबद्दल प्रकार घडला आणि कृष्णा नदीतले प्रदूषण रोखता आले नाही म्हणून सांगली महापालिकेला प्रदूषण नियंत्रण मंडळाने ९० कोटींचा दंड ठोठावला. त्यासंदर्भात काही कारणे सांगितल्यानंतर दंडाची रक्कम तीस कोटींवर आली. आता दंड भरायचा की कृष्णेचे प्रदूषण रोखायचे अशा एका समस्येत सांगली महापालिका अडकली आहे.

धोकादायक उदासीनता

एका स्वयंसेवी संस्थेने कृष्णा नदीतल्या या प्रदूषणाविरुद्ध न्यायालयात याचिका दाखल केली. न्यायालयाने प्रदूषण नियंत्रण मंडळाला कारवाई करण्याचे आदेश दिले आणि मग हा दंड ठोठावला गेला आहे. याचा अर्थ नदीतले हे प्रदूषण रोखण्याची जबाबदारी ज्या सांगली महापालिकेची होती तिने ती पार पाडली नाहीच. आणि प्रदूषण नियंत्रण मंडळ नद्यांबाबत इतके जागृत नाही की, स्वतःहून पुढाकार घेतील आणि कारवाई करेल. शेवटी न्यायालयाचे दार ठोठावल्यानंतर ही कारवाई झाली. स्वाभाविकपणे नद्यांमधील प्रदूषणाचे कारण भ्रष्टाचार हेच आहे यात काही शंका नाही. असे म्हणतात की, नदीचे मूळ आणि ऋषींचे कुळ विचारू नये. तशीच काहीशी परिस्थिती आज भ्रष्टाचाराची झालेली आहे. कारण या भ्रष्टाचाराचे मूळ कुठेही एका ठिकाणी सापडत नाही. ते एकमेकांना

इतके जोडलेले असते की, या भ्रष्टाचाराच्या प्रदूषणानेच सगळेच जनजीवनही प्रदूषित झालेले पाहायला मिळते. कोणत्याच गोष्टी पैसे खाण्यापासून सोडायच्या नाहीत. मग आपल्याला पिण्याचे पाणी पुरवणाऱ्या नद्यांची जरी वाट लागली तरी हरकत नाही. ज्यांच्याकडून नद्यांमध्ये प्रदूषित पाणी सोडले जाते, त्यांच्यावर कारवाई होणे हा तर एक भाग महत्त्वाचा ठरतोच. परंतु असे पाणी नद्यांमध्ये घेणार नाही याचा कोणताही पूर्ण बंदोबस्त कोणीही करीत नाही. आणि तसे करण्याची इच्छाशक्तीही कोणामध्ये नसते. मग अगदी याच नद्यांमधून अमर्याद रीतीचा उपसा करण्यापासून ते केमिकल युक्त सांडपाणी अत्यंत निर्लज्जपणे नदीमध्ये सोडण्यापर्यंत अनेक प्रकार घडतात. आतादेखील न्यायालयात गेल्यानंतर नगरपालिकेवर बेजबाबदारपणाचा आरोप झाला. आणि दंड भरायला सांगितले गेले. कदाचित दंड भरून महापालिका मोकळी पण होईल. परंतु कृष्णा नदीचे प्रदूषण रोखले जाणार आहे का हा मूळ प्रश्न आहे. जी कृष्णा नदी पश्चिम महाराष्ट्राच्या अनेक जिल्ह्यांना अनेक अर्थार्थी सुखसंपन्न करीत आली आहे तिचे पावित्र्य जपण्याची जबाबदारी सर्वांनीच पार पाडली पाहिजे. वाढत्या तापमानामुळे नद्या लवकर आटतात, हे जरी खरे असले तरीसुद्धा याच नद्यांचे जलप्रवाह काही विशेष प्रयत्नांमधून कायम ठेवता येऊ शकतात.

गोदा, चंद्रभागेची तीच अवस्था

हा प्रकार केवळ महाराष्ट्रात आहे असे नाही तर पूर्ण देशभर त्याचा प्रभाव पाहायला मिळतो. अगदी जगाला पवित्र वाटणारी गंगा नदी याच प्रदूषणामुळे बदनाम झाली. यमुनेची अवस्था तिच्यापेक्षा वेगळी नाही. अखेरीस ही सगळ्यांना अत्यंत पवित्र असणारी गंगा स्वच्छ व्हावी म्हणून केंद्र आणि त्या भागातल्या राज्य सरकारांना स्वतंत्र अशी नमामी गंगेची मोहीम राबवावी लागली आहे. महाराष्ट्राचे आध्यात्मिक विद्यापीठ मानल्या जाणाऱ्या पंढरपूरला चंद्रभागेची अवस्था अशीच बिबट आहे. तर दर बारा वर्षांनी महाकुंभ भरणाऱ्या गोदावरी नदीची स्वच्छता कोणतेच सरकार ठेवू शकलेले नाही. आतादेखील २०२७ च्या कुंभमेळ्यासाठी काही हजार कोटींची तरतूद केली जाते आहे. परंतु गोदावरी कायमस्वरूपी स्वच्छ राहिले जायबाबत कोणताच ठोस उपक्रम पाहायला मिळत नाही. फक्त हरिद्वार किंवा हृषिकेशच्या गंगाआरती प्रमाणे गोदावरीची आरती करण्याची नक्कल केली जाते आहे. आणि काही कोटी रुपये खर्च होत आहेत. पण ज्या ठिकाणी आरती होते त्याच ठिकाणी गोदावरीत इतके अस्वच्छ पाणी असते की, आरती करण्यामागचा भंपकपणाही त्यातून दिसून येतो. ज्या नदीला त्या त्या गावाचे सौभाग्य मानले जाते, त्या नद्यांची आजची ही दुरावस्था म्हणजे मानवनिर्मित नद्यांचे केले जाणारे क्रूर शोषण ठरते. नद्यांना वाचवता येत नसल्याने अनेक अर्थार्थी समाजाला याचक होण्याची वेळ येते आहे.
